INTRODUCTION TO BJC

 Bechtel Jacobs Company LLC (BJC) is the **Environmental Management Contractor for the** U.S. Department of Energy's (DOE's) operations in Oak Ridge, Tennessee and associated areas. Our contract with DOE is for Accelerated Cleanup of various projects/sites. Environmental Management is the largest DOE program in Oak Ridge, with cleanup projects under way to correct the legacies remaining from 60 years of energy research and weapons production.

BACKGROUND OF MISSION

 Because of past practices, portions of land and facilities on the Oak Ridge Reservation are contaminated with radioactive elements, mercury, asbestos, polychlorinated biphenyls (PCBs), and industrial wastes. The Oak Ridge Reservation is on the Environmental Protection Agency's (EPA's) National Priorities List and is being cleaned up under a Federal Facility U.S. Environmental Protection Agency and the State of Tennessee.

COMMITMENTS AND PROGRESS

- Disposition of legacy and low-level and mixed low-level waste from Oak Ridge Reservation, (completed in FY 2005).
- Cleanup of Melton Valley Project, (Targeted for completion in FY 2006).
- Cleanup of East Tennessee Technology Park (ETTP), the former K-25 Gaseous Diffusion Site.
- Completion of all remaining cleanup projects, including those off site.

COMMITMENTS AND PROGRESS CONTINUED

- BJC also supports the DOE reindustrialization program to find commercial uses for many Oak Ridge facilities.

IMPLEMENTATION/90-DAY FORECAST


- The 90-Day Forecast website changes very often!!!
- The website splits Purchases/Equipment, Materials and Rental opportunities (listed at the top of the website) out from Subcontract Services opportunities which are listed at the lower section of the website.
- Most opportunities for Subcontract Services and some opportunities for purchases require firms to submit project specific prequalifications, based on what is requested and the firms' capabilities.
- When project specific prequalifications are required, they are prerequisites for firms to be eligible to submit a proposal.

DOING BUSINESS WITH BJC

- Supplier/Contractor Information Questionnaire.
 Completion of the Questionnaire puts you into our Supplier Database.
- Registering into the database is also one of the requirements/steps in the prequalification process.



Summary FY06 - Oak Ridge


YTD 10/1/05- 6/30/06



Percent Subcontract Dollars Placed with Socioeconomic Firms








Percent Subcontract Dollars Placed with Socioeconomic Firms (continued)
