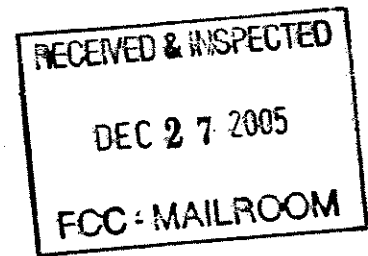

### **Petition for Exemption from Closed Captioning Requirements**

#### **Introduction**

World Changes Tabernacle is based out of Columbus, Georgia in the Muscogee County, located at 1241 Alta Vista Drive. It was established and incorporated in 1991. The mission of World Changes Tabernacle is to teach and preach a simple gospel of our Lord and Savior Jesus Christ, that all may be able to live by.

The title of our program is "The Word Is On" and "The Final Word". "The Word Is On" program consists of biblical based lessons and sermons to assist the listening audience in their faith walk with God through Jesus Christ. This program answers and addresses many questions Christians may have concerning their belief. "The Final Word" is a program that addresses community issues both spiritual and non-spiritual. This program is designed to allow the church to answer everyday issues based on biblical principles. Therefore giving people more positive solutions to their everyday dilemmas.

"The Word Is On" program airs on every Monday and Thursday at 6:30 am and "The Final Word" airs every Tuesday at 6:30 am. Both programs air on WXTX-Columbus Fox 54, channel 9. Volunteers and staff members produce the shows

of World Changes Tabernacle. Our program is designed to reach the listening audience of Christians and non-Christians.

For the reasons set forth below, World Changes Tabernacle hereby requests an undue burden exemption from the closed captioning rules for "The Word Is On" and "The Final Word", pursuant to § 79.1 (f) of the Commission's rules.

#### **Nature and Cost of Closed Captions**

World Changes Tabernacle's staff has researched through internet, local produced broadcast shows and referrals from local television station. (See attached)

#### **Impact on the Operation of the Program Provider**

The total cost to produce both the "The Word Is On" and "The Final Word" is \$16,419.00 (airtime and tapes). Each episode cost \$105.25. The closed captioning will increase the cost of production by \$150.00 per episode to out service each tape (increasing our budget almost 150%). To purchase the needed equipment, it would cost \$8,554.65. There is also the undisclosed cost of training personnel on the new equipment. The cost for out servicing the program, the new machine and training of personnel are not presently in the fiscal years budget. This additional cost would put the production of the broadcast at a great disadvantage. Our present budget is already at its maximum and limited by overhead cost of replacement and repairs of present studio/editing equipment. Considering we have just entered into our next broadcast contract we would be unable to fulfill that contract with the local television station.

#### **Financial Resources of the Program Provider**

World Changes Tabernacle is a non-profit organization without tax-exempt status. Because our main source of income comes from the current members of World Changes

Tabernacle, we can only submit our budget to their free will giving. Our monthly income differs from month to month. We are unable at this time to incorporate any additional cost to our already limited budget. Our main expenditures are the mortgage, utilities, media, and salaries. To not be allowed proper time to solicit for supporters to assist in the purchase or production of closed captioning would only cripple our programming, being there is no other resources to divert these funds from. We have asked the local station if they would be able to do closed captioning for us. Unfortunately, they were not able but referred us to Raycom. (Quote attached)

#### **Type of Operation of the Program Provider**

We are a Christian based ministry. Our main purpose is to spread the good news of Jesus Christ. We have several outreach ministries within this ministry. We have the adopt a block, Save Our Youth, Men Mentoring (M&M), Youth ministry, Adult ministry, Television Ministry and others. Our efforts are not for profit. Most of our outreach is based on the generosity of others. We are primarily a non-profit religious institution.

#### **Other factors**

Petitioner believes that the local, non-news exemption to the closed captioning rules also applies to "The Word Is On" and "The Final Word". As noted above, the program is produced and distributed locally, and the sermons of World Changes Tabernacle are of primarily local public interest. The episodes are not news, they do not have repeat value, and the electronic newsroom technique is not available.

Notwithstanding the applicability of the exemption, we have filed this petition in an abundance of caution and for the purpose of establishing certainty.

## **Conclusion**

As shown by this Petition and its attachments, the Commission should grant a waiver of the closed captioning requirements in this case, because requiring closed captioning would create an undue burden. The costs of captioning would be excessively high and would have significant impact on Petitioner's operations. The Petitioner's type of operations and financial resources are different in kind and magnitude from a mainstream programming provider. Because of the significant difficulty and expense of providing closed captioning, a waiver under § 79.1(f) is warranted. 

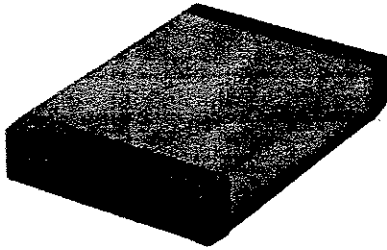

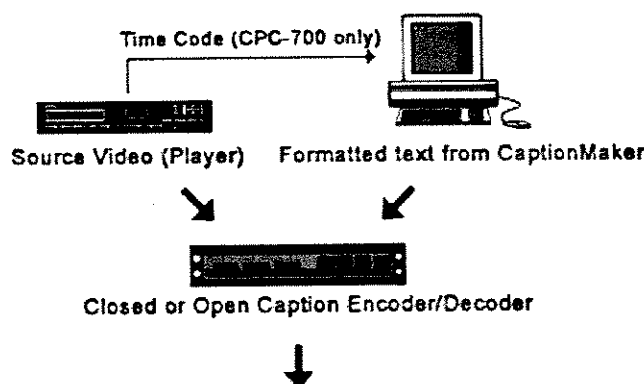
