## Many Campgrounds are now Open Due to the Hard Work of Crews. Only Fourteen Sites Remain Closed because of the Bark Beetle Epidemic.

**Denver Colo. August 29, 2008**— Forest Service officials concerned about visitor safety have identified fourteen campgrounds and picnic areas that will remain closed due to hazards caused by bark beetle- killed trees. Another six sites have partial closures. The bark beetles (also known as mountain pine beetles) are still at epidemic proportions, but the Forest Service and their partners are busy mitigating the effects. There are 209 recreation sites in Northern Colorado and Southeastern Wyoming open for Labor Day weekend. The Fourteen closures are on the Arapaho and Roosevelt, Medicine Bow and Routt, and White River National Forests.

"Thanks to the hard work of our crews and partners, we have made great progress this summer. Many of the sites that were delayed earlier this year and a couple that we thought would be closed all year are now open," said USFS Bark Beetle Incident Commander Clint Kyhl. "Bark beetle-killed trees are hazards because they can fall anytime. Public safety is our number one priority. Some sites have so many beetle-killed trees, that it may take awhile to remove them. Visitors need to be aware of their surroundings and wind conditions in areas where trees have been killed by the bark beetle," he added.

Colorado Corrections Industry Crews, USFS hotshot firefighting crews, Wyoming Conservation Corps and Rocky Mountain Youth Corps have been cutting and removing the hazard trees in many campgrounds to open them. Recreation sites that opened earlier than expected include Seedhouse Trailhead near Steamboat Springs, Green Ridge Campground near Granby, and East Fork at Camp Hale near Minturn. Big Creek Lake Campground near Walden is now only partially closed. In spite of the closures and delays, there are still many great places to camp and explore on the National Forests.
