Active ingredient: Duloxetine Hydrochloride

Form/Route: Delayed Release Pellets Capsule/ Oral

Recommended studies: 2 studies

1. Type of study: Fasting

Design: Single-dose, two-treatment, two-period crossover in-vivo

Strength: 60 mg

Subjects: Normal healthy males and females, general population.

Additional Comments: Females should not be pregnant, and if applicable, should practice abstention or contraception during the study. Due to the need to maintain the enteric coating, the subjects in a BE study should be advised not to crush or chew the enteric

coated pellets.

2. Type of study: Fed

Design: Single-dose, two-treatment, two-period crossover in-vivo

Strength: 60 mg

Subjects: Normal healthy males and females, general population.

Additional comments: Please see above

Analytes to measure (in appropriate biological fluid): Duloxetine in plasma

Bioequivalence based on (90% CI): Duloxetine

Waiver request of in-vivo testing: 20 mg, 30 mg based on (i) acceptable bioequivalence studies on the 60 mg strength, (ii) proportional similarity of the formulations across all strengths, and (iii) acceptable in vitro dissolution testing of all strengths.
