# THIRTY-THREE DEFENDANTS CONVICTED AND THIRTY DEFENDANTS HAVE FEDERAL CHARGES PENDING IN AUGUSTA INK PROSECUTION

AUGUSTA, Ga. – Edmund A. Booth, Jr., United States Attorney for the Southern District of Georgia, announced today that as a result of the undercover storefront operation entitled "Augusta Ink," 33 defendants have been prosecuted and convicted of federal crimes arising out of that investigation, while 30 defendants named in 14 indictments continue to face federal charges. The names of those defendants awaiting trial, as well those defendants convicted along with their offenses of conviction and the maximum statutory penalties faced, are set forth on the attached charts. Booth stated that the court will schedule a sentencing date for each convicted defendant following the completion of pre-sentence investigations and reports.

Booth commended the collaborative efforts of the Richmond County Sheriff's Office and the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) in the undercover operation that led to these convictions. Booth noted that these cases were federally prosecuted as part of the district's Project Ceasefire initiative, a program devoted to reducing gun violence by prosecuting individuals found in possession of firearms who cannot legally possess them, such as felons and drug dealers; and through the district's Anti-Gang initiative.
