**Active ingredient:** Repaglinide

Form/Route: Tablets/Oral

**Recommended studies:** 2 studies

1. Type of study: Fasting

Design: Single-dose, two way crossover in-vivo

Strength: 2 mg

Subjects: Normal healthy males and females, general population

Additional comments: To avoid hypoglycemic episodes in healthy volunteers, the drug products should be administered with 240 mL of 20% aqueous glucose solution, followed by 60 ml of the glucose solution administered every 15 minutes for up to 4 hours after

dosing.

2. Type of Study: Fed

Design: Single-dose, two way crossover in-vivo

Strength: 2 mg

Subjects: Normal healthy males and females, general population

Additional Comments: Please see comment above.

## Analytes to measure (in appropriate biological fluid): Repaglinide in plasma

Bioequivalence based on (90% CI): Repaglinide

Waiver request of in-vivo testing: 0.5 mg and 1 mg based on (i) acceptable bioequivalence studies on the 2 mg strength, (ii) acceptable dissolution testing across all strengths, and (iii) proportional similarity in the formulations across all strengths.
