The following information is provided to help you understand what is presented in this degree plan:

This document is an UNOFFICIAL Degree Plan to provide you with a preliminary assessment of how your prior learning experiences might fit into the specified degree program for this academic institution. - Appropriate assignment of ACE Guide-recommended credit at the lower or upper level for military service schools and occupations, CLEP, DSST, and other tests, transfer credit for courses from other colleges and universities, certification programs, etc.

IMPORTANT NOTE: When you are ready to seek admission into this degree program, please contact the USCG Institute at 1-405-954-7241. Your advisor will send the college or university an official U.S. Coast Guard Institute transcript, a copy of the degree plan, and a ready-for-signature SOC Student Agreement which, when signed by a college official, becomes a contract for degree completion committing the college or university to supporting you in your academic endeavors.

Credit for all courses you have taken must be reflected on official transcripts sent directly to this college from the administrative offices of the colleges you previously attended. This degree plan is often used for information purposes by

college counselors pending receipt of the official transcripts from the source colleges.

This degree plan is not intended to compete with your local college or university. Keep in mind, you are allowed to transfer in a significant amount of the degree requirements to this institution. As such, credit from local colleges, college level examination programs, or advanced military training may be applied to this degree. You may also complete the courses necessary from this college either in residence (on campus or possibly on a military base at a campus extension in the Education Center) or through distance delivery of the courses. - \*\* DANTES Academic Codes: The Defense Activity for Non-Traditional Education Support (DANTES) publishes the DANTES Independent Study Catalog (DISC) annually, which lists more than 6,000 courses from dozens of regionally accredited colleges and universities. Because this is a degree from a SOC affiliated college, the academic residency requirements are limited, thereby allowing students to transfer in a significant portion of the degree, as mentioned above. If the course you desire to take is not offered by this institution when you want to take it, consider the opportunities the courses in the DISC present. Thomas Edison State College (TESC) General Information

Each program of study is defined by personal academic program plan in which college credit for military service and professional training, previous college credits, college credit-by-examination, licensure and certifications may be used to satisfy Thomas Edison State College requirements.

Tuition and Fees (Subject to change)

Participants pay the application and assessment fees at the time of application. The tuition is paid at the time of course registration. Text and materials are extra and cost varies per course. Students must order textbooks and course materials directly from MBS Direct, the College's textbook supplier at: (800) 325-3252. The application fee and a completed application establish the applicants file. The application fee extends for six months from the date of application. Applicants who do not enroll in a course during this period of eligibility will have to reapply to the college before enrolling in a course.

If all credit is completed outside of TESC and transferred in, the following fees apply:

## POLICY NOTES:

The maximum amount of college level testing credit accepted by TESC is 60 semester hours for an Associates Degree - the entire degree. Transfer credit accepted by TESC may include the entire degree requirements using non-traditional credit (military credit or college level testing). If this option is chosen, no courses must be taken through TESC. However, a student may find it in his/her best interest to take 9 semester hours of an Associates Degree through TESC, thereby paying substantially less in administrative fees.
