This degree plan is often used for information purposes by college counselors pending receipt of the official transcripts from the source colleges.

This degree plan is not intended to compete with your local college or university. Keep in mind, you are allowed to transfer in a significant amount of the degree requirements to this institution. As such, credit from local colleges, college level examination programs, or advanced military training may be applied to this degree. You may also complete the courses necessary from this college either in residence (on campus or possibly on a military base at a campus extension in the Education Center) or through distance delivery of the courses. \* SOC Course Category Codes: Service members Opportunity Colleges (SOC) is a consortium of over 1,600 accredited colleges and universities seeking to provide degree opportunities to the military. Over 170 of these institutions participate in network degree programs developed for the Army, Navy, Marine Corps, and Coast Guard. A SOC course category number beside a course from one of these institutions, such as [EN024A] or [EN024B] for English Composition, indicates that courses from other degree program institutions with the same code may be taken to satisfy the degree requirement. \*\* DANTES Academic Codes: The Defense Activity for Non-Traditional Education Support (DANTES) publishes the DANTES Independent Study Catalog (DISC) annually, which lists more than 6,000 courses from dozens of regionally accredited colleges and universities. Because this is a degree from a SOC affiliated college, the academic residency requirements are limited, thereby allowing students to transfer in a significant portion of the degree, as mentioned above. #### Coastline Community College (CCC) General Information

Coastline Community College is unique in that it serves many communities rather than being affiliated in only one. Founded in 1976, the fully accredited college offers classes at more than 60 sites located in coastal Orange County. In addition to class sites located in Costa Mesa, Fountain Valley, Garden Grove, Huntington Beach, Newport Beach, Seal Beach, and Westminster, many students take classes in their homes through telecourses. As a comprehensive college, Coastline offers transfer and A.A. degree programs, occupational certificates, and also serves the needs of adults needing English language skills and remedial education.

Unlike other colleges, Coastline does not have a traditional campus. Instead, instruction is offered in nine different cities within the college service area, at approximately 60 sites close to students' homes and workplaces. These teaching sites include banks, senior centers, high schools, office buildings, shopping malls, and many other facilities. In addition to these sites, the College has main area learning centers based in Costa Mesa, Fountain Valley, and Westminster. In 1997, the College opened a new center in Garden Grove which features the latest in technology, specialized labs, and large lecture facilities.

Distance Learning courses fulfill degree requirements. Coastline offers a comprehensive selection of distance learning courses that allow you to meet nearly all the requirements for an Associate in Arts (A.A.) Degree. Students should speak with a counselor regarding degree requirements

Take courses over the Internet and work at your own time, place and speed! Use your computer with an Internet account, such as Earth Link or America Online (AOL), to access the Coastline Distance Learning Web site. Course materials (lectures, video clips, sound files, images, site links, assignments, quizzes, instructor interaction, chat rooms) are featured on the Web site. Textbooks, possible multimedia materials and videos are part of the packet purchased for the course. Exams are conducted on-site or proctored for students unable to attend locally.

Study independently using specially prepared course materials that include reading materials, textbooks, study guides, self-paced assignments and video materials. May also include CD-ROM multimedia materials, Internet access or lab kits. Interact with instructor via phone, FAX or e-mail, watch or listen to pre-recorded review sessions, mail in assignments and quizzes, and take on-site or proctored exams.

Coastline is accredited by the Accrediting Commission for Community and Junior Colleges of the Western Association of Schools and Colleges, an institutional accrediting body recognized by the Commission on Recognition of Postsecondary Accreditation and the U.S. Department of Education.

POLICY NOTES:

The maximum amount of college level testing credit accepted by CCC is 30 semester hours. (Check with CCC counselors for acceptance of CLEP, DSST, or ECE examinations prior to taking each examination.)
