#### What is BASIS?

**B**lood **A**vailability and **S**afety **I**nformation **S**ystem

A strategic nationally representative blood collection and utilization *inventory\** system

**Supply and Demand Data – nationally representative** 

- Blood Collection Centers: Supply data (approx. 80%)
- Hospital Blood Banks: Demand data (roughly 350-500)

## **BASIS Purpose (why monitor?)**

To provide national policy makers with current blood supply and demand data (the illusive national real-time denominator)

#### This need was identified in:

- the 1997 HHS Blood Action Plan
- Twice identified by the ACBSA in recommendations to the Secretary

## Who Operates BASIS?

The U.S. Department of Health and Human Services
The representative Blood Community -

Operated by staff of the Assistant Secretary for Health, the Nation's Blood Safety Officer

- Project Director
- •Contracts (Recruit/Retain Data Validating)
- •Funded by USPHS Agencies (CDC, FDA, NIH, CMS)

### **How BASIS works**

Secure Web-based Information Technology platform with easy manual entry and easier file upload

- Daily Tech time: 2 minutes
- <u>Hardware</u> HHS owned and operated with 24/7 contractor support (TAIC)
- <u>Software</u> HHS owned and operated contractor developed and supported (KBSI)

## **BASIS Open Issue Reporting**

#### Secure Web based free text with audit trail

- Anyone can report reporting person must input brief institution demographics
- New (as of last week)- undeveloped, but working
- Intended for availability issues could be used for safety issues?

## BASIS Open Issue Survey

Secure Web based with audit trail – next version (approximately 6 months)

- Can survey any single issue: leukocyte filter, white particulate matter, etc.
- Can survey BASIS participants, or whole universe
- Intended for availability issues could be used for safety issues?

## **BASIS** approach

- ACBSA recommended monitoring to the Secretary
- HHS contracted for conceptual research 3 ESI deliverables
- HHS funded the 2005 and 2007 NBCUS AABB
- HHS contracted for IT development KBSI
- HHS contracted for recruitment and retention ESI
- HHS contracted for data validation ESI
- HHS contracted for on-site hardware support TAIC
