### **TELECOMMUNICATIONS FOR THE DEAF (TDD)**

#### **MESSAGE RELAY SERVICES FOR COMMUNICATING WITH THE DEAF**

Hearing people who do not have a Telecommunication Device for the Deaf (TDD) and want to reach someone with a TDD can do so via the Federal Information Relay Service as follows:

Call a Relay Service operator on 1(800) 877-8339. You will be answered by either a voice or a "beep" from a TDD. If you hear a beep, say something to let the operator know this is a voice call.

Once the operator is on the line, provide the telephone number of the person you want to call. Once the call is answered, you can converse with the person through the operator.

Deaf people with TDDs can also use this service to speak to hearing people without TDDs.
