Dear Ms. Dortch:

On behalf of JW Broadcasting LLC ("JW"), licensee of station K02NQ, Columbia, Missouri, we respectfully request cancellation of the \$7000 forfeiture proposed against JW, by way of a Notice of Apparent Liability for Forfeiture released on October 12, 2004 (the "NALF"),<sup>1</sup> for K02NQ's alleged broadcast of the Fox Television Network program "Married by America" on April 7, 2003. Attached hereto is a copy of a notice of consummation filed with the Commission on November 13, 2003, evidencing that JW, pursuant to Commission approval,<sup>2</sup> acquired the license of K02NQ on November 12, 2003—over seven months after the cited broadcast allegedly occurred. Because JW was not the licensee of K02NQ at the time of the alleged broadcast, it respectfully requests that the forfeiture proposed against it in the NALF be cancelled.
