

Hurricanes Katrina and Rita

- Hurricane Katrina
 - Landfall on August 29th
 - Category 3
 - 125 mph Winds
- Hurricane Rita
 - Landfall on September 24th
 - Category 3 Hurricane
 - 115 mph Winds

Press coverage following both Hurricane Rita and Katrina have been far from flattering


The Hurricanes have been associated with:

- introducing a 'criminal' element into Houston


Houston Police Department

- Making it the 4th largest city in the U.S.


Population Over Time

Index Crime Rate* over Time




2005 Houston Crime

Index Crime across Houston (2005)




2005 and 2006 Crime Data

Weekly crime data was geo-coded for both 2005 and 2006.

2005 crime data was analyzed to examine the impact of the Hurricanes.

2006 crime data was analyzed as a comparison group to the 2005 data.


Nearest Neighbor Hierarchical Spatial Clustering Single Standard Deviation Ellipses

Index Crimes for 2005 and 2006 separately


- 1. Weeks 1-34 (Pre-hurricanes)

- 3. Weeks 44-52 (Post-hurricanes)




Hot Spots of Index Crime- Time 1




Hot Spots of Index Crime- Time 2

Weekly Counts by Crime Type








Houston Burglaries (2005)




Hot Spots of Burglaries- Time 1

Patterns across Houston

No evidence was found to suggest that Hurricane Rita or Katrina resulted in increased violent crime or drug crime as suggested by the media.

Evidence does show a 'limited' longitudinal impact of the Hurricanes on property crime, specifically burglary.

Burglary Patterns

The most common explanation for the change in crime patterns has been to blame the increase on displaced residents from New Orleans.

A great deal of media coverage has highlighted the poverty and criminal records of many of those displaced to Houston.

Conclusions

It seems unlikely that we can assign the blame for the burglary increase on displaced New Orleans residents.

A reason survey of law enforcement agencies (TELEMASP, 2006) suggests that only three (3) burglary arrests, in the six months following Katrina, can be attributed to displaced New Orleans residents.

Why the Impact of Katrina?

Immediately following Katrina we fail to see an increase in criminal activity. However, the media coverage demonstrated the inability of the police to focus on law enforcement efforts during the crisis.

It seems that the lessons learned from Katrina may have demonstrated to crime 'prone' individuals that immediately following a natural disaster was an ideal time to engage in property crime.
