JUDGMENT

This action came to trial before the Court. The issues have been tried or heard and a decision has been rendered.

IT IS ORDERED AND ADJUDGED that judgment is entered for the plaintiff and against the defendant. Plaintiff is granted injunctive relief and defendant Donald E. Hunt, both personally and doing business as Hunt's Income Tax and Bookkeeping Services, Inc. is permanently enjoined from engaging in any of the following actions and conduct, either by himself or through any other business association or corporation:

1. He shall not take any action in furtherance of aiding, assisting, advising, or preparing for compensation, tax returns of taxpayers.

2. He shall not aid or assist in, or procure or advise any person, with regard to the preparation or presentation of any portion of a tax return, affidavit, claim, or other document for another person on any matter arising under the Internal Revenue Code and Regulations.

3. He shall not maintain any ownership interest in any business that provides, directly or indirectly, services that would result in the aiding, assisting, advising, or preparation for compensation of tax returns for other persons.

4. He shall not maintain any ownership interest in any business that provides, directly or indirectly, any services that would result in the aiding or assisting in preparation or presentation of any portion of a return, affidavit, or other document for another person or any matter arising under the Internal Revenue Code and Regulations.

5. He shall immediately cease and desist from using the name Hunt's Income Tax and Bookkeeping Services, Inc., or any substantially similar name that refers to preparation of income tax

returns or related documents.

6. He shall disclose to the plaintiff within thirty days of entry of the decree the names, addresses, social security or tax identification numbers of all persons for whom he has prepared federal income tax returns for the tax years, 1991, 1992, and 1993. He shall also provide to the plaintiff a description of all documents he has in his possession, custody, or control that relate to persons for whom he has prepared income tax returns during those years.


7. He shall inform all of his clients about the seven-numbered paragraphs of the Decree. By January 3, 1995, he shall file in the office of the Clerk of this Court a list of the names and addresses of all persons so notified.

Judgment is entered for the plaintiff and against the defendant Donald E. Hunt for the costs of this action.
