Commerce Committee Hearings

May 6th: <u>The National Oceanic and Atmospheric Administration Oversight Hearing of 2008</u> This hearing provided an opportunity to address general NOAA oversight issues facing the agency during the remaining session of the 110th Congress, as well as the Administration's Fiscal Year 2009 budget request. During the hearing Senator Stevens urged NOAA to address the increasing problem of illegal, unreported, and unregulated (IUU) fishing.

May 7th: Reauthorizing the Vision for Space Exploration

The Subcommittee considered the issues regarding the upcoming reauthorization of the National Aeronautics and Space Administration.

May 7th: <u>The State of the Airline Industry and the Potential Impact of a Delta/Northwest</u> <u>Merger</u>

This hearing examined the current financial state and long-term economic outlook of domestic air carriers and the implications of consolidation.

May 8th: Improving the Capacity of U.S. Climate Modeling for Decision Makers and End-Users

This hearing examined the current computing capacity to process models at the regional and local scales, the need for continuous observational data to support the models, and the basic science to support the improvement of the next generation of climate models to meet the needs of decision makers.
