Pursuant to the Standing Orders, auctioneers can either post a blanket bond for several cases or individual bonds for single cases. Trustees and debtors in possession are responsible for insuring that the auctioneer is adequately bonded for the particular auction.

Any auctioneer who desires to be added to this list can do so by obtaining and posting an appropriate blanket bond with the United States Trustee. The United States Trustee does not, as a policy matter, recommend or endorse the use of any specific auctioneer. The United States Trustee retains the right to object to the employment, for cause, of any auctioneer including one on the following list in any bankruptcy case.

In addition to the Standing Orders, please also note that Illinois enacted legislation in 1999 which imposes, for the first time in our state, licensing requirements on all auctioneers. The licensing requirements are fully applicable to auctioneers who serve in bankruptcy cases. An auctioneer who is listed above, but who is not licensed with the state, can obtain a license by contacting the Illinois Office of Banks and Real Estate at 217-782-3414. We would recommend only using an auctioneer who has complied with the state licensing requirements.
