## The Oregon EMS Conference

This year marks the 15<sup>th</sup> anniversary of the Oregon EMS Conference. The Conference is organized and coordinated by a group of committed volunteers including representatives from organizations such as Oregon Research and Education Foundation, Braun Northwest, Life Flight Network, Rural Metro Ambulance, Oregon Research and Education Foundation, REACH and other independent EMT partners with an interest in EMS Training and Education.

During August, 3 new ambulances were licensed. Oregon Law Enforcement Data Systems background reviews were conducted on 119 new applicants and 54 national background reviews were completed.

Four investigations were opened. Two EMTs have surrendered their certifications pending the outcome of a criminal proceeding. Twenty-four certificate holders are completing court diversion requirements for DUII/BUII (boating under the influence). There are currently 18 certificate holders on department-stipulated probation.

#### EMS Certification and Discipline Subcommittee

Suzann Schmidt chaired the quarterly meeting of the EMS Certification and Discipline Subcommittee on September 4<sup>th</sup>. The Subcommittee reviewed the procedures for issuing and monitoring EMT-Paramedic Provisional certificates, reviewed the Agency Reportable Actions form and interviewed some applicants for EMT certifications with special circumstances.

## Oregon EMS Advisory Committee

The Oregon EMS Advisory Committee met on September 5<sup>th</sup> in the Portland State Office Building. The Committee heard the Federal EMS for Children site visit team explain their findings and reviewed the status of project. They also received reports on activities and coordination efforts with other agencies. There are 8 members of the Committee with terms expiring at the end of this year. A group was appointed to work with staff on this. The members are Dr. McCart, JD Fuiten, Will Bauscher and Suzann Schmidt. ## New AHRQ Tool Estimates Resources Needed for Emergency Response

HHS' Agency for Healthcare Research and Quality has released a new Webbased interactive tool to help hospitals and emergency planners identify resource requirements to treat an influx of patients due to major disasters such as an influenza pandemic or a terrorist attack. The Hospital Surge Model provides essential resource information for emergency planning strategies. It is able to estimate, by day, the number and flow of casualties needing medical attention for scenarios selected by users. These scenarios are consistent with the Homeland Security Council's National Planning Scenarios. For instance, planners can use the model to estimate how many patients each hospital unit will need to treat each day following an event, casualty arrival patterns and peak days of patient care, day by day use of the personnel, equipment, and supplies needed by each hospital to treat casualties, and a daily count of anticipated deaths and patient discharges. The Hospital Surge Model was developed by AHRQ in collaboration with HHS' Office of the Assistant Secretary for Preparedness and Response. ## Mass Fatalities State Plan Seminar and Tabletop Exercise

The purpose is to introduce the State Mass Fatalities Plan to a broad range of county/regional responders, to discuss the coordination of state and local response, and to ensure the state plan is realistic, clear, and adequate. The tabletop exercise will focus on the state response, but will also stimulate discussion about county/local roles and responsibilities. The scenario for the tabletop exercise will be an earthquake. James Roddey, the Oregon geologist who is the earthquake subject matter expert for the Cascadia Peril scenario, will present on what to expect from such an earthquake in each location. The training would be particularly useful for those planning to participate in the Cascadia full-scale exercise next spring.

Participants will receive an orientation to the State Mass Fatalities Plan, participate in discussions related to State and county roles and responsibilities

and lines of communications, identify gaps in the State Mass Fatalities Plan, identify local areas that need strengthening, participate in a debriefing, or "hotwash," and make recommendations for closing identified gaps.

The seminar and exercise is open to the faith community, morticians, funeral directors, medical examiners, Oregon tribes, and professionals from local health departments, hospitals, vital records, emergency management, law enforcement, fire/hazmat, EMS, Healthcare Regional Coordinators, PHEP Liaisons, and other emergency response partners.
