Agua is a brand new client, but we will try to get them to pass it orally before Friday (they only have five members of the council, three of whom are coming). I hope this is OK.

Regarding the Standard, it is the same jerk as from the Forward. he is calling everyone on the planet. I am not speaking with him, given the lies from last time. we are still putting together a legal case against them, and we are watching this one possibly to add Weekly Standard into the mix.

Do you understand that the Senate is controlled by DEMOCRATS and that letting them take credit for this program will send a VERY bad signal to the few tribes that actually like Republicans?????" Bush Sending Baker to Iraq to Deal With Its Debt Problem

President Bush named James A. Baker III, the former secretary of state, as his personal envoy to Iraq today to help the country grapple with its debt problem.

"Secretary Baker will report directly to me," Mr. Bush said in a statement, "and will lead an effort to work with the world's governments at the highest levels, with international organizations and with the Iraqis, in seeking the restructuring and reduction of Iraq's official debt."

The White House press secretary, Scott McClellan, said the president made the appointment in response to a request by the Iraqi Governing Council.

In his statement, Mr. Bush said that "the future of the Iraqi people should not be mortgaged to the enormous burden of debt incurred to enrich Saddam Hussein's regime."

"This debt endangers Iraq's long-term prospects for political health and economic prosperity," Mr. Bush said. "The issue of Iraq's debt must be resolved in a manner that is fair and does not unjustly burden a struggling nation at its moment of hope and promise."

The Bush administration has been under increasing criticism from Democrats and others, including world leaders, for its management of post-war Iraq. The financial issues include who will pay for the country's reconstruction and how Iraq will manage its foreign debt, which totals \$150 billion to \$200 billion.

Some legislators here and the leaders of other countries want to tie the discussion about how much to contribute to Iraq's reconstruction — and whether it will come in the form of loans or grants — to the question of how war-torn Iraq will pay off its crippling foreign debt, and whether some of its debtors will forgive portions of those loans.

This is not the first time Mr. Bush has turned to Mr. Baker, who in addition to serving as secretary of state during the presidency of Mr. Bush's father, was also a secretary of the Treasury under President Ronald Reagan.

Most recently, Mr. Bush dispatched Mr. Baker to the former Soviet republic of Georgia to discuss political and

Tracey Hanke was at the Sen. [REDACTED] staff retreat today. My friends over there weighed in with her pretty hard and told her that [REDACTED] was aware and supportive of the project - which wasn't true because he doesn't know what is going on; really - but he wanted to feel her out how adamant her position was with regard to increasing the \$9 million figure.

They also played the political angle up with her...she didn't seem overly impressed.

Trevor said that she is 100 percent not going to budge with what we've hit her with thus far. Her excuse was that they are already taking 1/3 the budget -which isn't totally true because of the unobligated FY01 funds -and because "they're one of the richest tribes in the country" yadda yadda yadda, which does mean anything because of the Fed's trust responsibility.

What does that mean? Well, going after her directly won't work because she's protected and was placed in that position to "be a bitch".. I want to take this opportunity to make an urgent request of Your Excellency to send your closest and most trusted advisor to a special meeting with the Honorable Karl Rove, the Senior Advisor to President Bush, which will take place at 6:30 PM (Washington, DC time) on the evening of Tuesday, July 9, 2002.

The meeting is very restricted and has been set for a long time, however, I have been able to obtain one invitation to this meeting. I am not certain I would be able to obtain a second place at this meeting, however, if convenient, perhaps you could also dispatch a second advisor as well in case I am able to do so. Mr. Nkashama, your Honorary Ambassador, during his official trip here, advises us that Mr. Diambwana, the Vice President of your National Bank, might be an appropriate second advisor for this purpose.

This meeting will take place at the home of Grover Norquist, president of Americans for Tax Reform, the most powerful private section interest group in the United States. The meeting, which will include dinner, will also be attended by some of the top political and social leaders in the United States, but will be a very small group.

I just spoke on the phone with Rove's office. They want us to give them a private memo outlining every indignity visited upon the Christians by the PAS guys. Can you get me every possible example of this for the past decade? We need as much as possible. The discussion was very positive regarding Shanghai, but they need to make the case internally that this is a US domestic political issue, and not just a foreign policy matter. They felt that Sudan would help as well. Can you also get me anything on what Malaysia has already done on this front? I know that this will play a bit to Feulner, but victory is what is important and they have asked for it.

Finally, and this is critical, they were shocked that the US Embassy appeared at the PAS event with HAMAS. They felt that this alone could help them put a domestic handle on the meeting in Shanghai, since if this is the case, this would have reverberations domestically among the Christians and Jews. We really need to get this confirmed. Please try to get me confirmation and details if possible (as in who attended) asap.

I think we have a bit of a breakthrough. The Rove guys, as you know, are our friends, so they are trying to help make this happen, but getting control of this to the White House political guys, and away from State/NSC is critical.

Ralph is also now very active. I told him we would find a way to get a contribution for one of his groups in appreciation of his work. Is there a way to get someone there to help with that? If not, I'll find the money elsewhere. Thanks.

I had lunch with Jennifer Farley today. She said they were still hoping to do some sort of ceremony or commemoration of the bill being enacted. However, she was not sure of when they would do it. You will remember that I sent you the attached briefing paper and you called Interior on the issue, which was greatly appreciated. I just wanted to let you know that, as next week's Senate hearing approaches, the agencies are acting strange.

I learned today that Interior is planning to testify that they are neutral on the Pueblo-Government settlement. Tomorrow, Dept of Ag (Forest Service) is going to be briefing Republicans on Senate Energy and Natural Resources on the problems with the settlement (and Binigaman's legislation to implement it). All of this would be fine and dandy EXCEPT THAT THE INTERIOR AND AGRICULTURE ARE PARTIES TO THE SETTLEMENT AND ARE LEGALLY BOUND TO IT (at least until November 15 when it expires).

I know [REDACTED] is leaning on the agencies to oppose it, but they cannot unilaterally back out of the settlement. OMB is going to have to clear the testimony, and I am going to call over there, but I wanted to make you aware of this as soon as possible.
