Greenberg Traurig Billing Records

This document contains the entries in the billing records provided to the Committee by Greenberg Traurig that include references to White House officials.

In some instances, a single lobbying contact with White House officials appears in the billing records on multiple occasions, such as when the lobbying contact is billed to more than one client or when there is one entry in the billing record for time and a second entry for expenses incurred. In this document, these duplicate entries are presented as they appear in the billing records. In tabulating the total number of lobbying contacts in the accompanying Committee staff report, the duplicate entries were combined and counted as a single instance of lobbying.

The billing record entries often aggregate many activities into a single listing. In these cases, it is not possible to determine how much of the time billed was expended in lobbying White House officials.
