Random thoughts:

Business Plan: One of the crucial missing pieces in previous unsuccessful roll-ups was a cohesive business plan. Roll-ups took smaller companies and combined them into one large company without taking into account how those individual companies (each with their own business philosophy, culture, accounting and HR methods) could be successfully integrated. There are some spectacular failures and as a result, I think investors are wary. A business plan will need to be developed that carefully maps out a strategy. In addition, we need to carefully map out the specs of target acquisitions and determine the overarching business philosophy.

Operations: I can look out for your business interests but lack the experience to run the day-to-day operations of a defense company. Who would do this? Who is the CEO?

Timing: The creation of the new Homeland Security agency has created a rush to get lucrative government contracts. A lot of foreign companies (such as Siemens) are already capitalizing on this opportunity. Time is of the essence but at the same time, I don't believe this can be done quickly.

Logistics: Because this will take a lot of upfront research and ground work before coming to existence, how do you propose to account and pay for my time? Do we create an entity and if so, what is the structure? Limited partners...but at what ownership distribution? Am I a consultant, and if so, who pays me?

Profits: This doesn't strike me as a short-term money making venture so you have to be committed for the long haul. Are you prepared to spend a significant amount of time in running a business like this or do you just want to be a capital contributor?

Investment Bankers: Who has relationships w/ investment bankers and which ones?

My commitment: Karl and I have discussed my role in the 2004 reelection campaign so for the time being, I'm committed to the WH. It would take a significant amount of money for me to be lured away so unless you're really serious and can make it worth my while, let's wait until 2005.

Governor goes right to source

WHEN THE governor tracks you down at home, you know there's a problem. "Mr. Beam, would you please hold for Gov. Mike Foster?" the woman asked after I picked up the telephone Thursday and identified myself.

I realized the column I had written for that day's paper about the governor signing a secret gambling compact with the Jena Choctaws would get some reaction. However, I had no idea the big man himself would call.

"JIM, I'M calling about a mistake in your column today," Foster said. "You said I hadn't talked to local officials, and that isn't true. Your legislators knew what I was doing."

The governor's comment caught me off guard because there was every indication from our legislators that they didn't know Foster had signed on the dotted line. Some of them said after the compact was signed that they knew the governor was talking with the Choctaws about opening an Indian casino in Vinton, but Foster had asked them to keep the negotiations under wraps.

State Rep. Vic Stelly, R-Moss Bluff, a spokesman for the local legislative delegation, said he learned about the Choctaws' plans after he was contacted by a political consultant. He said he then called the governor.

"His (Foster's) exact words were, 'Vic, you can tell the rest of the delegation, but please don't make a big deal out of it. We'd rather be able to do our negotiations with the Bureau of Indian Affairs without it all hitting the fan.' We honored his request," Stelly said.

"I didn't know that he had actually signed it (the compact), but I knew he was considering it," Stelly said. "I also knew that there were some ticklish negotiations going on because I knew, frankly, he had tried to get as much as he could."

State Rep. Ronnie Johns, R-Sulphur, said last week, "We didn't have any idea the governor was going to sign the

Hi Susan,

As a follow up to the email I sent you last month on this, the American Bondholders Foundation (ABF) is in the process of signing a ten year deal with representatives of the Iraqi Governing Council. It should be done in the next few days. The deal would exchange \$100 billion in Chinese Government bearer bonds for \$2 billion in Iraqi oil each year for ten years. The Iraqis would use the bonds to set-off a \$100 billion in debt that Iraq owes to the PRC.

The ABF is holding open until mid-night on December 15, 2003, the same deal to the US Government. If the White House does this ten year deal by mid night on December 15, 2003, the USG would receive approximately \$6 billion. However, if the White House fails to enter into the agreement by mid night on December 15, 2003, the US Government would lose the opportunity to secure any funds from the sale of ABF's Chinese bonds to Iraq.

Needless to say, having these extra funds available would be a huge help to the Administration, but the WH would have to make a decision on this immediately. We heard that James Baker is now in charge of Iraqi debt. Not sure if that is accurate, but if so, I hope the transition would not impede the possibility that the USG would get these funds. I have the ten year contracts and can forward them to you if needed. Please let me know if this is doable.

Attached is a short briefing paper on the OIA position to use with the White House political guys. Tony needs to get a memo to someone there today. Jack is meeting with Rove on Thursday.

I thought putting this down would be helpful for us to lay out as succinctly as possible what OIA does, why the position is important, and why Zach - and not the others - should get this job. I NEED YOU BOTH TO REVIEW THIS DRAFT ASAP, so I can make certain I get all of our arguments in. What is it missing? What should be taken out, etc?

Office of Insular Affairs: Desperately in Need of a
Compassionate Conservative

WHAT IS IT?

The Office of Insular Affairs (OIA) in the Interior Department is responsible for coordinating federal policy for the territories, e.g. Commonwealth of Northern Mariana Islands (CNMI), and the freely associated states, e.g. Republic of Marshall Islands. The stated mission of the OIA is to assist the islands in developing more efficient and effective government, and to serve as a focal point for the management of relations between the United States and the islands.

The OIA is a place that has the potential to be a beacon of compassionate conservatism - or a miserable headache for the new Administration. The simple fact is that, although many on the mainland do not spend a great deal of time thinking about OIA, island politics are very intense and fraught with danger. Every shift in federal policy (and even statements that reveal a potential shift) is scrutinized closely and debated vigorously.

WHAT HAS HAPPENED?

During the Clinton Administration, OIA was marked by anti-Republican political scandal. The Interior Department IG testified before the House Resources Committee in July 2000 that his investigation of OIA had uncovered the "most egregious example I've seen" in 30 years of law enforcement experience of official misconduct. The IG found officials had taken part in "partisan political activity", engaged "in a lobbying campaign", and "improperly" obtained and disclosed information about Members of Congress and political opponents - all on official time and through the use of U.S. government equipment.

On the policy front, the OIA has failed to initiate or advocate policies that will make the U.S. territories more self-sufficient. Instead, the territories and freely associated states have become even more dependent on Washington. This increasing dependency has created resentments in the islands, as well as on the mainland. The clamor over of Vieques (Puerto Rico) is just the latest high-profile case in which U.S. citizens in the territories are pitted against U.S. citizens in the mainland.

WHAT IS NEEDED NOW?

The OIA needs a compassionate conservative at the helm. The next OIA Director should be someone who can relate to the plight of the people living in the territories because he or she has lived there among them. The job should go to someone who understands the Bush-Cheney Administration's vision of self-sufficiency and local autonomy for the islands.

Of the candidates currently under consideration for OIA Director, only one can implement that vision: Mark Zachares. Mark is a compassionate conservative who has lived and traveled in the territories for nearly a decade. He understands

the important issues. His knowledge and empathy earned him such respect and support in his adopted home of the CNMI that he was chosen to be the first non-Indigenous Director of Labor and Immigration in the CNMI. It should be noted that Mark's interest in the islands is not strictly professional; his wife is a proud Chamorro.

None of the other candidates mentioned for the post comes close to matching Mark's credentials or philosophy. Of the two other candidates floated, one has served as a loyal Democrat staffer in the House and Senate. The other is a strong McCain supporter from Hawaii, home of the activist labor unions that have provoked much of the discord between the territories and the mainland. Either of these candidates will turn the OIA into an unnecessary and unmitigated disaster for the new Administration.

I just had a 10-minute conversation with him. It is clear that we are out in the open lobbying for Zach because Jodey asked me at one point if I knew you. I said yes, and then he asked if we worked for the garment manufacturers in CNMI. I said yes, in addition to the government.

We talked a bit about the proper philosophy for the territories. I told him our guys were good Republicans who thought the federal government should leave them alone and should only work to foster self-sufficiency, not dependency. He said that was their number one goal for the position.

He ran the Radewagen's name by me. I dumped on him for being old school and a colonialist that would preserve the status quo. He asked me about "Houston" but couldn't remember his first name. I said I was not familiar with his record. He said he was insular affairs under Reagan. I said that I was afraid someone who served previously would not bring the new perspective needed.
