Landfill Disposal of Mortality

If disposal of carcasses at a landfill must be done, the following guidelines shall be followed.

- Carcasses shall be double bagged and the bags sprayed with disinfectant before placing them in an appropriately prepared container/drop box.
- The container shall have all crevices sealed with spray foam and be lined with plastic in order to prevent any possible leakage.
- The top of the container shall be securely covered.
- The outside of the truck shall be thoroughly cleaned and disinfected before departure from the farm.
- A route shall be selected which avoids passage in close proximity to commercial poultry operations.
- Following placement of birds in the landfill, they shall be promptly covered with soil, in accordance with Oregon Department of Environmental Quality regulations.
- The truck, container, and tarp shall be thoroughly cleaned and disinfected before leaving the landfill. The plastic liner shall be disposed of.

Initial talks indicate that roughly 70 containers, each with a 30-ton capacity, could be organized for transport to a north central Oregon landfill. Roughly, this number would be needed for disposal of a 1,000,000 hen laying operation. Trucking would run probably \$400 to \$500 per truck and disposal between \$40 and \$70/ton. It would take roughly a week for the landfill to properly dispose of that type and quantity of waste. Cost per bird for disposal by landfill would be approximately 19 cents per bird and \$2,600 per truck holding roughly 14,300 birds. Total cost for 1,000,000 birds would be approximately \$190,000.

Pacific Northwest Waste Connection, with **Finley Butte Landfill near Boardman** has been most responsive to our inquiries and contingency planning. Their general number in Vancouver is 360-695-4858. Relatively small number of birds may be buried on site or there is an existing agreement with the **Brooks incinerator** to burn up to one ton of dead poultry per day. They request 24 hours notice. Their contact number is 503-393-0890 and our contact has been through Darby Randklev ext. (214)
