The Department of State Lands is proposing to update these rules to reflect current technological changes regarding recordkeeping of records available for review and to safeguard the personal and confidential information of owners of unclaimed property in the Department's custody according to current federal and state mandates. In addition, the Department is proposing changes in the criteria for business claims.
