Need for the Rule(s):

The Department of Human Services, Public Health Division is proposing to amend OARs relating to Radiation Protection Services to comply with the Nuclear Regulatory Commission (NRC) Code of Federal Regulations (CFR); Adopt two new rules to comply with implemented CFRs for compatibility with NRC regulations per state agreement; Amend OARs affecting renewal dates; and implement fee increases approved by HB 2193 in the 2007 Legislative Session.

Statement of Cost of Compliance:

- 1. Impact on state agencies, units of local government and the public (ORS 183.335(2)(b)(E)): State and local governments required to have a validated radiological license or registration could be affected by fee increases. Devices or services provided to the user could increase user fees.
- 2. Cost of compliance effect on small business (ORS 183.336):
- a. Estimate the number of small businesses and types of business and industries with small businesses subject to the rule: Approximately 3,200 facilities registered to use radiation machines, 690 tanning facilities and 50 microwave oven repair services will be affected by the implementation of these proposed rules.

- b. Projected reporting, recordkeeping and other administrative activities required for compliance, including costs of professional services: Licensees using sources of radiation will be required additional recordkeeping regarding radiological source accountability.
- c. Equipment, supplies, labor and increased administration required for compliance: Licensees using sources of radiation will be required additional recordkeeping regarding radiological source accountability.
- d. How were small businesses involved in the development of this rule? Small businesses were represented on the Radiation Advisory Committee during the crafting and draft approval of these rules. In addition, several public hearings for HB 2193 were conducted to receive testimony concerning the statutory changes authorizing fee increases related to these rules.
