You are invited to submit a proposal to the Agency for Healthcare Research and Quality (AHRQ) for Request for Proposal (RFP) No. AHRQ-00-0009, entitled "Bioterrorism Initiative." Your proposal must be developed and submitted in accordance with the requirements and instructions of this RFP.

A cost reimbursement type, multiple-award, task order-type contract is contemplated for a period of one (1) years plus a one (1) year Option Period.

NOTICE OF SMALL BUSINESS GOALS: All offerors (other than small businesses) must submit a complete subcontracting plan with their initial proposal. The requirement to submit a subcontracting plan also applies to colleges, universities, and non-profit organizations, as well as large business concerns. AHRQ recommended goal (as a percentage of total contract value for the base period) is 23% for Small Businesses, which shall include at least 5% (as a percentage of total contract value for the base period) for Small Disadvantaged Businesses, and at least 5% (as a percentage of total contract value for the base period) for Women-Owned Small Businesses, and at least 1.5% (as a percentage of total contract value) for HUBZone Small Businesses. These goals represent AHRQ's expectation of the minimum level for subcontracting with small businesses at the prime contract level. Any goal stated less that the AHRQ recommended goal shall be justified and is subject to negotiation. A copy of the AHRQ model subcontracting plan is provided as an attachment to this solicitation. If the model is not used, all elements outlined must be addressed in the offeror's format. If the offeror is not a small business and fails to submit a subcontracting plan with the initial proposal, the offeror will be considered nonresponsive and their proposal will be returned without further consideration. The approved plan will be included in any resultant contract.

Offerors shall submit the following:

This limitation is for administrative purposes only and exceeding the limitation shall not, of itself, be considered a basis for rejection of your proposal.

As part of the business proposal, offerors shall provide an original and five (5) copies of their cost/price proposal, only to the extent that it shall include:

- 1. Certified, unloaded, labor rates for individuals expected to work on a project of this size and nature (Class Levels I through VI, see Sections B.3 and L.10).
- 2. Certified documentation indicating that the offeror has a cost accounting system in place which allows for the collection, tracking and reporting of all costs under a cost reimbursement-type contract.

SECTION B-SUPPLIES OR SERVICES AND PRICES/COSTS

B.1 BRIEF DESCRIPTION OF SUPPLIES OR SERVICES

"Bioterrorism Initiative." See Section C for a complete description.

B.2 TASK ORDERS

This is a task order requirement for "Bioterrorism Initiative." Services will be acquired on an asneeded basis through issuance of task orders. For each contract awarded, the minimum total amount to be awarded over the one (1) year base period plus the one-year Option Period will be \$100,000. The maximum total amount for the base period will be \$2,000,000 and \$2,000,000 for the Option Period. Typical task orders are expected to range between \$100,000 and \$500,000.

In consideration of the satisfactory performance of the work performed in Section C, the Contractor shall be reimbursed on a cost-reimbursement basis. Each task order awarded under this contract shall include one or more of the labor categories in Section B.3, and the Contractor shall be reimbursed for costs incurred for labor based on the following hourly rates. All other costs, i.e., travel, supplies, etc., shall be reimbursed in accordance with individual cost proposals received under task orders.

B.4 PROVISIONS APPLICABLE TO DIRECT COSTS

a. Items Unallowable Unless Otherwise Provided

Notwithstanding the clauses, ALLOWABLE COST AND PAYMENT, and FIXED FEE, incorporated into this contract, unless authorized in writing by the Contracting Officer, the costs of the following items or activities shall be unallowable as direct costs:

- (1) Acquisition, by purchase or lease, of any interest in real property;
- (2) Rearrangement or alteration of facilities;
- (3) Purchase or lease of <u>any</u> item of general purpose-office furniture or office equipment regardless of dollar value. (General purpose equipment is defined as any items of personal property which are usable for purposes other than research, such as office equipment and furnishings, pocket calculators, etc.);
- (4) Accountable Government property (defined as both real and personal property with an acquisition cost of \$1,000 or more, with a life expectancy of more than two years) and "sensitive items" (defined and listed in the <u>Contractor's Guide for Control of Government Property, 1990,</u> regardless of acquisition value;
- (5) Travel to attend general scientific meetings;
- (6) Foreign Travel;
- (7) Any costs incurred prior to the contract's effective date;
- (8) Rental of meeting rooms not otherwise expressly paid for by the contract;

- (9) Any formal subcontract arrangements not otherwise expressly provided for in the contract;

- b. SECTION C

DESCRIPTION/SPECIFICATION/WORK STATEMENT

Bioterrorism Initiative

Independently and not as an agent of the Government, the Contractor shall furnish all the necessary services, qualified personnel, material, equipment, and facilities, not otherwise provided by the Government as needed to perform the Statement of Work below:

C.1 Background Information

The Healthcare Research and Quality Act of 1999, reauthorized the Agency for Healthcare Research and Quality (AHRQ). In Fiscal Year 2000, AHRQ received funds from the Public Health and Social Services Emergency Fund for research related to bioterrorism.

The threat of bioterrorist attacks has stimulated broadly-based planning by the Department of Health and Human Services (DHHS). DHHS plans involve various elements of the public health and medical care systems in preparing for and responding to weapons of mass destruction. If an episode of bioterrorism were to occur, health professionals on the front line would see patients presenting in many varied and dispersed clinical settings, including emergency rooms, community clinics, physicians' offices, and hospital walk-in clinics.

Health-care providers represent an essential component of a comprehensive response, but without proper training and tools they might become unwitting obstacles to rapid identification of, and response to the release of a bioterrorist weapon. An initially localized dispersal of a transmissible biological agent might be followed by scattering of those exposed among multiple geographical sites, so that each patient would seek care from a different provider, none of whom might appreciate the significance of the initial nonspecific clinical findings. All involved might thus fail to recognize the epidemic. For health professionals in the front lines of emergency departments and primary care settings, the difficulty of accurately diagnosing a patient's illness and the lack of a direct connection to the public health infrastructure might preclude their recognizing the implications of their clinical observations and taking appropriate action.

Information systems that enhance the clinician's ability to diagnose infectious diseases caused by biological weapons, to inform public health authorities, and to treat the individual patient are essential. Because most medical care in the United States is provided in the private sector, the nation's capacity to detect and respond to a bioterrorist attack or to any other major health crisis will depend heavily upon the service capacity, clinical preparedness, information technology (IT), and communication capabilities of emergency departments, hospital and community clinics, managed care and integrated delivery systems, and individual physicians' or group practice offices. Administrative and patient encounter data currently collected by such entities can provide a baseline for research and illuminate decision-making on appropriate policies and programs.

In FY 2000, AHRQ will develop an initiative that complements current federal efforts to respond to bioterrorism and that includes at least three components:

- (1) AHRQ will sponsor a research initiative with federal and private collaborators to develop and evaluate information systems to detect sentinel events and provide rapid information to clinicians regarding appropriate management. A specific focus of interest will be the development and evaluation (through simulations) of artificial intelligence technology for early detection of the release of a bioterrorist weapon. Research that addresses the role of human factors in early detection and that evaluates the extent to which such detection can be integrated with other sentinel-event-detection efforts (e.g., medical errors, natural epidemics, and the occurrence of rare conditions) will also be solicited. The highest priority will be given to collaborative efforts among academic health centers, emergency departments, local and federal agencies, professional associations, and systems or networks of care.
- (2) AHRQ will support developing a broad research agenda to identify important areas related to the role of clinicians, emergency departments, hospitals, and physicians' practices; to evaluate the current data capacity and needs of hospitals, clinical practices and emergency departments; to convene regional and national groups of clinicians, hospitals, and emergency departments to assess current and future research agendas, specifically focusing upon primary care practice networks; and to consult with national experts in bioterrorism and clinical practice.
- (3) AHRQ will assess and improve the capacity of integrated delivery systems and managed care organizations to detect and respond to bioterrorist attacks. Using task orders with the Agency's new Integrated Delivery System Research Network (currently being solicited) and working closely with the Centers for Disease Control and Prevention (CDC) and the Office of Emergency Preparedness (OEP), AHRQ will study the feasibility of using managed-care data to monitor sentinel events such as patients' presenting with symptoms suggestive of exposure to bioterrorist agents and to identify specific IT requirements that should be met to enhance early detection and response.

C.2 Objectives

The contract objectives are (1) to describe and evaluate approaches to preparedness for bioterrorism that are based upon information systems; (2) to determine the best ways to train clinicians to diagnose and manage rare events, specifically including infectious diseases that may have resulted from the release of a biological weapon; and (3) to develop some model hospital plans (for institutions providing different levels of care or with different numbers of beds, e.g., secondary, as compared with tertiary care facilities) for managing massive numbers of casualties, including cases that would require inpatient care, (4) to develop alternative models that would allow local health providers and institutions to use off-site, non-medical care facilities to provide care to large numbers of people; (5) to identify strategies that will help the medical care community forge links with the local health department and, through the local health department, with public health officials at the state and federal levels; (6) to identify effective means of promoting the development of links between the medical and public health communities and local emergency preparedness planning bodies; and (7) to model capacity, costs, and impact of a bioterrorist event on hospitals and integrated delivery systems, in order to fulfill the legislative mandate of AHRQ. The bioterrorism initiative at AHRQ is managed by the Center for Primary Care Research in collaboration with the Center for Outcomes and Effectiveness Research. The primary

objective of this bioterrorism task order contract is to secure targeted research of the highest quality from experienced investigators of established competence to determine reliable answers to seven research questions: (1) What is the current capacity of surveillance and detection systems to mine data for rare events? (2) What is the experience with surveillance and detection systems in other industries? (3) What is the current state of the art of on-line decision-support systems? (4) What can be learned from other industries about decision-support systems? (5) What is the best way to train clinicians to deal with rare events? (6) Are there innovative approaches to training clinicians for rare events? (7) What is the current capacity of the nation's hospitals to respond to a bioterrorist attack, and what enhancements are needed to develop sufficient capacity to respond?

C.3 Specific Requirements

Following are examples of topics that may result in a task order. These are provided as examples only and are not necessarily indicative of actual topics which may be used in the award of task orders under this proposed contract: (1) Assessing what can be learned about Internet-based decision-support systems in other fields in order to illuminate the development of decision-support systems for clinical care in general and bioterrorism response in particular. (2) Delineating a model prototype for preparing a state to respond to a bioterrorist threat or attack. (3) Developing and evaluating clinical surveillance and detection systems to detect emerging infectious diseases and other rare events, with particular emphasis on the adaptation of existing clinical systems to detect possible bioterrorism. (4) Evaluating existing systems of surveillance and decision support (e.g., poison-control centers, CDC botulism surveillance. ProMed. and military systems) to support detection and management of unusual clinical events. (5) Supporting development of decision-support systems that could be used to aid clinicians at the point of care with special emphasis on the requirements of the system for reconfiguration to deal with bioterrorism. (6) Determining the utility, effectiveness, and cost-effectiveness of training simulations, including review of the experience in other industries. (7) Reviewing and evaluating the effectiveness of current programs of training and education about bioterrorism. (8) Identifying the best approaches to reaching front-line clinicians with appropriate training about bioterrorism. (9) Modeling the capacity, costs, and impact of a bioterrorist event on hospitals and integrated delivery systems.

No individual TO will exceed \$1,000,000 and TOs may often vary in terms of content, cost and duration. It is expected that TOs will average between \$100,000 and \$500,000 and last approximately twelve (12) months.

Once the total dollar value of all TOs issued to a contractor equals the not to exceed (NTE) amount of \$2,000,000, the contractor will be ineligible to compete for additional work during that contract period. However, the Government reserves the right to adjust the NTE amount by 5% for the purpose of accepting the lowest offer which would have been rejected solely because the total dollar value of all of a contractor's TOs would exceed the NTE amount by this minimal amount.

A Task Order Officer (TOO) will be designated for each TO issued under this contract. The TOO will function as principle technical liaison between the Contracting Officer and the Contractor's Project Manager.

Procedures for Issuance of TOs

- Each awardee will be provided a fair opportunity to be considered for each TO. Factors such as past performance, quality of deliverables, cost control, price, cost, or other factors that the Contracting Officer believes are relevant to the placement of orders will be considered.
- 2. When a TO is to be awarded, the Government will solicit proposals from awardees based on those factors mentioned above. The TO Statement of Work will be sent to those selected awardees and a cost proposal and a brief discussion of technical approach shall be submitted within twenty (20) calendar days. In unusual circumstances, contractors may be requested to reply within a shorter amount of time. Oral proposals and streamlined procedures may be used in selecting the TO awardee.
- 3. The determination of award of the TO will be based on cost, technical merit, past performance, and any other relevant factors.
- 4. Awardees need not be given an opportunity to be considered for a particular TO if the Contracting Officer determines that:
 - A. The Agency need for such supplies or services is of such urgency that providing such opportunity would result in unacceptable delays;

- B. Only one such contractor is capable of providing such supplies or services required at the level of quality required because the supplies or services ordered are unique or highly specialized;
- C. The order should be issued on a sole-source in the interest of economy and efficiency as a logical follow-on to an order already issued under the contract, provided that all awardees were given a fair opportunity to be considered for the original order; or
- D. It is necessary to place an order to satisfy a minimum guarantee.
- 5. Each TO proposal will be subject to review and negotiation and will not be effective until signed by both parties.

Required content of TO proposals will usually include, but not necessarily be limited to, the following:

- --offeror's understanding of TO objectives;
- --proposed approach to solving the problem in terms of major steps or subtasks of the proposed study program;
- --types of final products anticipated;
- --proposed staff by name and percentage of time each individual will be assigned to the work; and
- --management plan for conducting the TO.
- 6. The cost-plus-fixed-fee for each TO will be negotiated based on the fixed maximum labor rates set forth in Section B Supplies or Services and on other cost/fee issues.
- 7. Upon negotiation and agreement on the proposal submitted, the Contracting Officer shall issue for the signature of the Contractor a formal TO. The Contractor shall not proceed with performance until the Contracting Officer has signed the TO, which constitutes written approval to proceed.
- 8. The Contractor's performance of the TO is subject to the terms and conditions in the contract, and the TO may be modified by the Contracting Officer and **ONLY** the Contracting Officer.
- Protests ARE NOT authorized in connection with the issuance or proposed issuance of a TO except for a protest on the ground that the order increases the scope, period, or maximum value of the contract under which the order is issued.
- 10. The Contractor is not required to compete for a particular TO if it chooses not to do so, i.e., the Contractor may elect not to submit a proposal on a particular TO. Such election will not preclude the Contractor from an opportunity to submit proposals on future TOs.

H.2 RESTRICTIONS ON PUBLICATION AND DISSEMINATION OF MATERIAL DERIVED FROM WORK PERFORMED UNDER THIS CONTRACT

Section 903(c) of the Public Health Service Act (PHS Act), 42 U.S.C. 299a-1, states in part that "No information, if the establishment or person supplying the information or described in it is identifiable, obtained in the course of activities undertaken or supported under this title, may be used for any purpose other than the purpose for which it was supplied unless such establishment or person has consented...to its use for such other purpose. Such information may not be published or released in other form if the person who supplied the information or who is described in it is identifiable unless such person has consented...to its publication or release in other form."

To ensure compliance with these requirements and to fulfill the mandate of 923(b)(1) of the PHS Act, 42 U.S.C. 299c-2(b)(1), to assure that statistics developed with AHRQ support are of high quality, comprehensive, timely, and adequately analyzed, except as otherwise provided in this contract, the Agency for Healthcare Research and Quality (AHRQ) must, prior to dissemination by the contractor, review all reports, presentations, or other disclosures that contain information, statistics, analytical material, or any other material, which is based on or derived from work performed under this contract. Accordingly:

- (a) Except as provided in H.2(c), (e), and H.3(d), the contractor will not publish, have published, or otherwise disseminate any material resulting or derived from the work performed for AHRQ-funded research, except in accordance with the terms or conditions required by the Task Order Officer or until AHRQ has published the results of the research.
- (b) AHRQ will, within three months of the receipt of any proposed publication, presentation, or any other disclosure of materials derived from information collected or produced for a particular task order, use best effort to review the proposed report, presentation, or other text to assure that (1) identifiable information is being used for the purpose for which it was supplied; (2) the privacy of individuals supplying the information or described in it is not violated; and (3) the quality of statistical work meets the statutory standards cited above.
- (c) Except as provided in H.2(e), in the event no written conditions or approval are received from the Task Order Officer by the end of the three month period following submission of a request (that is accompanied by the proposed text) to publish a report or to make a presentation or other disclosure of material derived from work performed for AHRQ-funded research, the contractor may publish, present, or otherwise disclose this material subject to the restrictions of Section 903(c). However, the contractor must print prominently on the report or any portion of it which is released, or state prior to any oral or other disclosure of material derived from work performed under this contract, the following disclaimer:

"THIS REPORT *(or other appropriate description of publication)* HAS NOT BEEN APPROVED BY THE AGENCY FOR HEALTHCARE RESEARCH AND QUALITY"

- (d) Whether or not written approval of the Task Order Officer is received, the contractor must:
 - print the following statement prominently on written reports or other forms of recorded data derived from work performed under this contract which is to be released; or
 - preceding any presentation or other oral disclosure of such material make the following statement:

"IDENTIFIABLE INFORMATION ON WHICH THIS REPORT, PRESENTATION, OR OTHER FORM OF DISCLOSURE IS BASED, IS CONFIDENTIAL AND PROTECTED BY FEDERAL LAW, SECTION 903(c) OF THE PUBLIC HEALTH SERVICE ACT, 42 U.S.C. 299a-1(c). ANY IDENTIFIABLE INFORMATION THAT IS KNOWINGLY DISCLOSED IS DISCLOSED SOLELY FOR THE PURPOSE FOR WHICH IT HAS BEEN SUPPLIED. NO IDENTIFIABLE INFORMATION ABOUT ANY INDIVIDUAL SUPPLYING THE INFORMATION OR DESCRIBED IN IT WILL BE KNOWINGLY DISCLOSED EXCEPT WITH THE PRIOR CONSENT OF THAT INDIVIDUAL."

- (e) In cases where the Contracting Officer has given written notice that the Government intends to retain all rights in any particular data produced under this contract, the contractor shall have no right without prior written permission of the Contracting Officer to publish any of those data or analyses based on those data, depending on the scope of the Contracting Officer's notice.
- (f) Whenever data or analyses are to be developed by a subcontractor under this contract, the contractor must include the terms of H.2(a), (b), (c), (d) and (e) in the subcontract, without substantive alteration, and with a prohibition on the subcontractor engaging in further assignment of its obligations to the contractor. No clause may be included to diminish the Government's restriction on publication and dissemination of work or material derived from work performed under this contract.

H.3 RIGHTS IN DATA -- SPECIAL WORKS (FAR Clause 52-227-17 June 1987) (DEVIATION)

(a) Definitions

"Computer software", as used in this clause, means computer programs, computer data bases, and documentation thereof.

"Data", as used in this clause, means recorded information, regardless of form or media on which it may be recorded (e.g., reports, tabulations, questionnaires, punch cards, data tapes, data files, tables, data processing and computer programs, graphic representations, sound recordings, form, work flow charts, equipment descriptions, and works of any similar nature). The term does not include information incidental to contract administration, such as financial, administrative, cost or pricing, or management information.

"Form, fit, and function data", as used in this clause, means data relating to items, components, or processes that are sufficient to enable physical and functional interchangeability, as well as data identifying source, size, configuration, mating, and attachment characteristics, functional characteristics, and performance requirements; except that for computer software it means data identifying source, functional characteristics, and performance requirements, but specifically excludes the source code, algorithm, process, formulae, and flow charts of the software.

"Unlimited rights", as used in this clause, means the right of the Government to use, disclose, reproduce, prepare derivative works, distribute copies to the public, and perform publicly and display publicly, in any manner and for Agency for Healthcare Research and Quality purposes, and to have or permit others to do so for Agency for Healthcare Research and Quality purposes.

(b) Allocation of Rights

- (1) The Government shall have:
 - (i) Unlimited rights in all data delivered under this contract, and in all data first produced in the performance of this contract, except as provided in paragraph (c) of this clause for copyright.
 - (ii) The right to limit exercise of claim to copyright in data first produced in the performance of this contract, and to obtain assignment of copyright in such data, in accordance with subparagraph (c)(1) of this clause.
 - (iii) The right to limit the release and use of certain data in accordance with paragraph (d) of this clause.
- (2) The contractor shall have, to the extent permission is granted in accordance with subparagraph (c)(1) of this clause, the right to establish claim to copyright subsisting in data first produced in the performance of this contact.

(c) Copyright

- (1) Data first produced in the performance of this contract
 - (i) The contractor agrees not to assert, establish, or authorize other to assert or establish, any claim to copyright subsisting in any data first produced in the performance of the contract without prior written permission of the contracting officer. When claim to copyright is made, the contractor shall affix the appropriate copyright notice of 17 U.S.C. 401 or 402 and acknowledgment of Government sponsorship (including contract number)to such data when delivered to the Government, as well as when the data are published or deposited for registration as a published work in the U.S. Copyright Office.

The contractor grants to the Government and the Government's licensees, a paid-up nonexclusive, irrevocable, worldwide license for all such data to reproduce, prepare derivative works, distribute copies to the public, and perform publicly and display publicly, for Government purposes.

- (ii) If the Government desires to obtain copyright in data first produced in the performance of this contract and permission has not been granted as set forth in subdivision (c)(1)(i) of this clause, the contracting officer may direct the contractor to establish, or authorize the establishment of, claim to copyright in such data and to assign, or obtain the assignment of, such copyright to the Government or its designated assignee.
- 2) Data not first produced in the performance of this contract.

The contractor shall not, without prior written permission of the contracting officer, incorporate in the data delivered under this contract any data not first produced in the performance of this contract and which contain the copyright notice of 17 U.S.C. 401 or 402, unless the contractor identifies such data and grants to the government, or acquires on its behalf, a license of the same scope as set forth in subparagraph (c)(1) of this clause.

(d) Release and Use Restrictions

Except as otherwise specifically provided for in this contract (e.g., H.2(e)), the contractor shall not use for purposes other than the performance of this contract, nor shall the contractor release, reproduce, distribute, or publish any data first produced in the performance of this contract, nor authorize others to do so, without prior written permission of the Task Order Officer or until AHRQ has published the research for which the data were first produced.

(e) Indemnity

The contractor shall indemnify the Government and its officers, agents, and employees acting for the Government against any liability, included costs and expenses, incurred as the result of the violation of trade secrets, copyrights, or right of privacy or publicity, arising out of the creation, delivery, publication, or use of any data furnished under this contract; or any libelous or other unlawful matter contained in such data.

The provisions of this paragraph do not apply unless the Government provides notice to the contractor as soon as practicable of any claim or suit, affords the contractor an opportunity under applicable laws, rules, or regulations to participate in the defense thereof, and obtains the contractor's consent to the settlement of any suit or claim other than as required by final decree of a court of competent jurisdiction. Further, these provisions do not apply to material furnished to the contractor by the Government and incorporated in data to which this clause applies, nor in cases where Government officers, agents, and employees are solely at fault.

(f) The contractor must release all required deliverables under this contract solely in accordance with the reporting requirements of this contract.

- (g) In accordance with the Federal Register (Vol. 57, No. 167, August 27, 1992, pp:38845-38848) the contractor is to provide for secure and confidential storage, retrieval access, maintenance, and disposition of data and other information used in the work performed under the contract.
- (h) Whenever any data is to be developed by a subcontractor under this contract, the contractor must include the terms of H.3(a), (b), (c), (d), (e), (f) and (g) in the subcontract, without substantive alteration, and with a prohibition on the subcontractor engaging in further assignment of its obligations to the contractor, and no clause may be included to diminish the Government' rights in those data.

H.4 DEBARMENT

Violation of the special provisions of this contract entitled **RESTRICTIONS ON PUBLICATION AND DISSEMINATION OF MATERIAL DERIVED FROM WORK PERFORMED UNDER THIS CONTRACT, and RIGHTS IN DATA - SPECIAL WORKS** will be viewed as a serious violation of the terms of this contract as the requirements in this provision reflect AHRQ statutory obligations and responsibilities. Such violations, as well as other violations, of the contract terms which are deemed serious, could result in the initiation of debarment proceedings in accordance with the Federal Acquisition Regulations and the Department of Health and Human Services implementing regulations.

H.5 NON-ALLOWABLE CONTRACT COST PROVISION

It is understood that work to be performed under this contract will be undertaken only after the issuance of a Task Order. Accordingly, there will be no costs billed or paid for under this contract that are not <u>directly</u> attributable to the performance of specifically assigned work under the terms of this contract.

H.6 SUBCONTRACTS

The Contractor must include in any subcontracts executed or used to provide the support specified in this contract the terms of requirements H.1, H.2, H.3 and H.4. These requirements are to be included without substantive alteration, and no clause may be included to diminish these requirements.

Award of any subcontract is subject to the written approval of the Contracting Officer upon review of the supporting documentation as required by FAR Clause 52.215-12, Subcontractor Cost or Pricing Data, of the General Clauses incorporated into this contract. A copy of the signed subcontract shall be provided to the Contracting Officer.

H.7 LATE PAYMENTS TO THE GOVERNMENT

Late payment of debts owed the Government by the Contractor, arising from whatever cause, under this contract/order shall bear interest at a rate or rates to be established in accordance with the Treasury Fiscal Requirements Manual. For purposes of this provision, late payments are defined as payments received by the Government more than 30 days after the Contractor has been notified in writing by the Contracting Officer of:

- a. The basis of indebtedness.
- b. The amount due.
- c. The fact that interest will be applied if payment is not received within 30 days from the date of mailing of the notice.
- d. The approximate interest rate that will be charged.

H.8 PRIVACY ACT

The Privacy Act clauses cited in Section I (FAR 52.224-1 and 52.224-2) are applicable to the consultant records kept by the Contractor for the Agency for Healthcare Research and Quality.

You are hereby notified that the Contractor and its employees are subject to criminal penalties for violations of the Act (5 U.S.C. 552a(i)) to the same extent as employees of the Department. The Contractor shall assure that each Contractor employee is aware that he/she can be subjected to criminal penalties for violations of the Act. Disposition instructions: Records are to be destroyed after contract closeout is completed and final payment is made and in accordance with IRS regulations.

H.9 GOVERNMENT-FURNISHED MATERIALS

Unless otherwise stated in a specific task order, the contractor will furnish all the necessary personnel, materials, data, facilities, or services or otherwise all things necessary for or incident to the performance of the tasks stated in an individual task order.

- (b) All delivery orders or task orders are subject to the terms and conditions of this contract. In the event of conflict between delivery order or task order and this contract, the contract shall control.
- (c) If mailed, a delivery order or task order is considered "issued" when the Government deposits the order in the mail. Orders may be issued orally, by facsimile, or by electronic commerce methods only if authorized in the Schedule.

(End of Clause)

I.3 ORDER LIMITATIONS (OCT 1995) (FAR 52.216-19)

- (a) *Minimum Order*. When the Government requires supplies or services covered by this contract in an amount of less than \$10,000, the Government is not obligated to purchase, nor is the Contractor obligated to furnish, those supplies or services under the contract.
- (b) Maximum Order. The Contractor is not obligated to honor--
 - (1) Any order for a single line item in excess of \$1,000,000;
 - (2) Any order for a combination of items in excess of \$2,000,000; or
 - (3) A series of orders from the same ordering office within 30 days that together call for quantities exceeding the limitation in subparagraph (1) or (2) of this section.
- (c) If this is a requirements contract (i.e., includes the Requirements Clause at Subsection 52.216-21 of the Federal Acquisition Regulation (FAR)), the Government is not required to order a part of any one requirement from the Contractor if that requirement exceeds the maximum order limitations in paragraph (b) of this section.
- (d) Notwithstanding paragraph (b) and (c) of this section, the Contractor shall honor any order exceeding the maximum order limitations in paragraph (b), unless that order (or orders) is returned to the ordering office within 10 days after issuance, with written notice stating the Contractor's intent not to ship the item (or items) called for and the reasons. Upon receiving this notice, the government may acquire the supplies or services from another source.

I.4 INDEFINITE QUANTITY (OCT 1995)(FAR 52.216-22)

- (a) This is an indefinite quantity contract for the supplies of services specified, and effective for the period stated in the Schedule. The quantities of supplies and services specified in the Schedule are estimates only and are not purchased by this contract.
- (b) Delivery or performance shall be made only as authorized by orders issued in accordance with the Ordering Clause. The Contractor shall furnish to the Government, when and if ordered, the supplies and services specified in the Schedule up to and including the quantity designated in the Schedule as the "maximum." The Government shall order at least the quantity of supplies or services designated in the Schedule as "minimum."

- (1) The Government is requesting the information called for in this RFP pursuant to the authority provided by Section 301(g) of the Public Health Service Act, as amended, and P.L. 92-218, as amended.
- (2) Provisions of the information requested are entirely voluntary.
- (3) The collection of this information is for the purpose of conducting an accurate, fair, and adequate review prior to a discussion as to whether to award a contract.
- (4) Failure to provide any or all of the requested information may result in a less than adequate review.
- (5) The information provided by you may be routinely disclosed for the following purposes:
 - -to the cognizant audit agency and the General Accounting Officer for auditing;
 - -to the Department of Justice as required for litigation:
 - -to respond to Congressional inquiries; and
 - -to qualified experts, not within the definition of Department employees for opinions as a part of the review process.

In addition, the Privacy Act of 1974 (P.L. 93-579, Section 7) requires that the following information be provided when individuals are requested to disclose their social security number.

Provision of the social security number is voluntary. Social security numbers are requested for the purpose of accurate and efficient identification, referral, review and management of AHRQ contracting programs. Authority for requesting this information is provided by Section 305 and Title IV of the Public Health Service Act, as amended.

h. The RFP does not commit the Government to pay any cost for the preparation and submission of a proposal. It is also brought to your attention that the Contracting Officer is the only individual who can legally commit the Government to the expenditure of public funds in connection with this or any acquisition action.

The Government reserves the right to award a contract without discussions if the Contracting Officer determines that the initial prices are fair and reasonable and that discussions are not necessary.

L.10 TECHNICAL PROPOSAL INSTRUCTIONS

The technical proposal shall contain an original and twelve (12) copies. The technical proposal described below shall be limited to **125 pages** not including resumes or bibliographies, with no less than a 11 point pitch, with the majority of the text double-spaced (lists of deliverables, person loading charts, and similar materials need not be double-spaced, so long as they are legible).

a. Recommended Technical Proposal Format

To assist in the expeditious and comprehensive evaluation of your proposal, the Government desires that you follow the guidelines and format listed below:

- (1) Cover Page: The name of the proposing organization, author(s) of the technical proposal, the RFP number and the title of the RFP should appear on the cover. One (1) manually signed original copy of the proposal and the number of copies specified in the RFP cover letter are required.
- (2) <u>Table of Contents</u>: Provide sufficient detail so that all important elements of the proposal can be located readily.
- (3) <u>Introduction</u>: This should be a one or two page summary outlining the proposed work, your interest in submitting a proposal, and the importance of this effort in relation to your overall operation.
- (4) <u>Technical Discussion</u>: The offeror shall prepare a technical discussion which addresses evaluation criteria 1, 2, 3, 4, and 5 below. Evaluation criteria 6 and 7 are to be prepared in accordance with Sections L.11 and L.12. The offeror shall further state that no deviations or exceptions to the SOW are taken. The evaluation criteria are as follows:
 - 1. Understanding the Problem
 - 2. Technical Approach
 - 3. Management Plan
 - 4. Kev Personnel
 - Facilities
 - 6. Past Performance (See Section L.11)
 - 7. Small Disadvantaged Business Participation Plan (See Section L.12)

Technical proposals submitted in response to this RFP shall address each of the items described below, and shall be organized in the same manner and within the page limitations specified. Proposals shall be prepared in double-spaced format, with numbered pages.

1. Understanding the Problem

The offeror shall discuss the implications for innovation and sophistication in the design, documentation, and execution of the task orders to approach a threat in which the risk of catastrophic morbidity and mortality is very high; the ability to predict the etiology, timing, and location of the event is by no means assured; and the fund of accumulated practical experience available is minimal. This discussion shall make specific reference to the very broad range of sources of information needed to make inferences about what practices can be recommended for transfer to the clinical setting. The discussion should devote particular attention to the advantages of collaboration with academic medical or public health institutions.

2. Technical Approach

The offeror shall prepare a proposal for applying technical expertise in clinical medicine, public health, medical microbiology, educational psychology, and the fundamental techniques of health services research (including cost-effectiveness analysis, information technology and sciences, meta-analysis, outcomes research, quality measurement and improvement, operations research, management sciences, and technology assessment) to answer the seven research questions: (1) What is the current capacity of surveillance and detection systems to mine data for rare events? (2) What is the experience with surveillance and detection systems in other industries? (3) What is the current state of the art of on-line decision-support systems? (4) What can be learned from other industries about decision-support systems? (5) What is the best way to train clinicians to deal with rare events? (6) Are there innovative approaches to training clinicians for rare events like bioterrorist attacks? (7) What is the current capacity of the nation's hospitals to respond to a bioterrorist attack, and what enhancements are needed to develop sufficient capacity to respond?

3. Management Plan

The qualified offeror should demonstrate an appropriate organizational structure and management system, including the management of the personnel assigned to each task and the labor hours proposed, the plan for ensuring the availability of adequate staff, the plan for reporting the required technical and cost information to the Government, the system for maintaining efficient use of resources, the plan for responding to special requests on short notice, and planned methods for assuring the successful completion of all tasks within the time and budget allocated. Potential offerors must also show sufficient staff with the skills and experience to be fully operational within 30 days of the start of a contract.

Several tasks may require significant collaboration between researchers and academic medical or public health institutions. Offerors shall demonstrate that they have structures and processes in place for facilitating successful collaboration with and between these groups. Offerors should describe the structures and processes that they intend to use to facilitate successful collaboration with these groups while maintaining the scientific integrity of the research.

The majority of task orders issued under this contract are to be completed in twelve (12) months.

Offerors should describe the overall plan for organizing, staffing, and managing the tasks required under this task order contract. The offeror shall explain how this management and staffing plan will enable the offeror to start projects quickly, ensure that qualified personnel will be available for individual task orders, potentially conduct more than one task order concurrently, complete complex tasks within narrow time frames, and assure quality of products.

Offerors should also specify how the contractor, consultants and/or subcontractors will work together to assure timely, quality research products.

4. Key Personnel

The offeror must have permanent staff with demonstrated experience in the areas set out above. That is, qualified offerors will have a project director and subordinate personnel who among them have at least 5 years of experience in each of the following disciplines: (1) primary care and/or emergency medicine, (2) public health, (3) medical education, (4) information technology, and (5) cost-effectiveness analysis.

The offeror shall provide the resumes of all key personnel (those included in Class Levels I, II and III below) describing their qualifications as they relate to the requirements of this solicitation. This includes research or managerial leaders from the academic medical or public health institutions with which it is collaborating who may be involved in completing the tasks and activities described. Resumes of consultants or subcontractors in these classes (I, II, and III) should also be included and be clearly identified as such.

The offeror is expected to be specific in describing the proposed personnel and their relevant qualifications and experience, including their background and experience in working in health services research. Senior and associate management and professional research personnel (those in Class I and II) are considered critical to the successful completion of short-term (12 months), high-priority projects required under this task order contract. The offeror shall clearly describe the roles of such staff, including how responsibilities will be divided, decisions made, work monitored, and quality assured.

Additionally, offerors shall clearly describe the roles of research and managerial leaders from the academic medical or public health institutions, their ability to facilitate successful collaborative research, and <u>major</u> health services research initiatives they may currently oversee or manage related to the research required under this contract. Major health services research initiatives shall be defined on the basis of magnitude of study population, extent of interdisciplinary and multi-institutional collaboration, duration of data acquisition, sophistication of protocol design and data analysis, and size of study budget.

Offerors are not required to have all types of expertise available on a full-time basis. To ensure adequate management of tasks under typical task orders, however, offerors shall demonstrate that there will be highly qualified senior and associate personnel (those included in Class I and II) available on a day-to-day basis with the general qualifications and experience required to oversee the task order contract and specific task orders. These individuals should be regular employees and be readily available to conduct or manage specific task orders that may be issued.

Apart from meeting the specific qualifications stipulated above, offerors are not necessarily expected to have highly specialized research and clinical personnel in all potential research areas. However, offerors must demonstrate that they have access to a range of specialized research and clinical expertise within their own institution or affiliated organizations, through consulting and subcontracting arrangements, or significant experience in identifying, accessing, and working with such personnel to successfully conduct and complete timely research.

Planned subcontracting and consulting relationships, and other special organizational relationships, shall be described in detail. The offeror shall provide letters of intent from proposed consultants and subcontractors to carry out work under this task order contract.

Offerors shall provide appropriate staff for work on task orders, including personnel in the following labor categories:

Class I:

Senior management personnel, normally holding a relevant doctoral degree, with a minimum of five years experience in conducting health services research. Knowledge and experience with many the tasks described in Section C.2 is most desirable. This class of personnel should also have management experience that reflects an ability to command organizational resources and direct staff within the broader organization.

Class II:

Associate management or professional personnel, normally holding an advanced degree, with a minimum of five years experience in conducting health services research. Knowledge and experience with the tasks described in C.2 is desirable.

Class III:

Intermediate technical personnel, normally holding a BS or BA degree and at least three years experience in technical activities of which at least two are relevant to areas required to complete the types of research noted above. The person is capable of carrying out independent assignments with minimal supervision or acting as a leader of small projects. This includes specialists in computer programming, survey design, qualitative research methods, such as interviewing, etc.

Class IV:

Junior analysts, normally holding a BS or BA degree, with three years or less experience in technical areas. Includes research assistants and junior personnel who regularly assist analysts and specialists on routine technical work, such as data cleaning and editing, scheduling interviews, collecting background materials, etc.

Class V:

Other technical staff such as editors.

Class VI:

Support staff as needed.

Offerors should describe the nature, duration, and extent of their previous collaboration with academic medical or public health institutions and indicate the extent to which such collaboration is assured for the scope of the offering.

The Project director must also have experience that demonstrates (1) excellent overall skills in project management that include substantive and technical areas, teamwork, budget management, cost control, flexibility, and the ability to produce deliverables on time, within budget, and with exceptionally high technical quality; (2) excellent verbal communication skills with the project officer and in meetings and presentations; and (3) excellent written English. There will be periodic interaction between agency research staff and the offeror's staff, so suitable logistical plans to facilitate communications and meetings must be addressed. Concerns that respond to this notice must furnish concise responses directed specifically to the requirements mentioned above. Sources possessing experience and demonstrated capability to accomplish the above are to supply pertinent information in sufficient detail to demonstrate the ability to perform the required services. In particular, information about the number of staff currently employed by the firm who are available and are qualified to meet AHRQ's requirements should be provided on all personnel. Information furnished must include background information, resumes, and proof of employment of qualified staff.

5. FACILITIES

Potential offerors must demonstrate that they have suitable, high-quality and costefficient computers and other facilities and equipment available for the performance of all requirements of this acquisition. Information furnished must include a description of general and specific facilities sufficient for AHRQ staff to perform a proper evaluation.

L.11 Past Performance Information

Offerors shall submit the following information in an original and ten (10) copies as part of their proposal for both the offeror and proposed major subcontractors:

(1) Provide a listing of the offeror's recently completed (within the last 3 years - since January 1, 1997) and ongoing work (contracts and grants) directly related to the requirements of this acquisition. This listing shall include a brief description of each relevant project. Contracts or grants may include those entered into by the Federal Government, agencies of State and local governments and commercial customers. Offerors that are newly formed entities without prior contracts/grants should provide evaluations forms for contracts/grants and subcontracts as required above for all key personnel.

Include the following information for each contract, subcontract or grant:

- A. Name of contracting/grant activity
- B. Contract/Grant number
- C. Contract/Grant type
- D. Total contract/grant value
- E. Brief description of Contract/Grant
- F. List of publications and reports from those projects
- G. Contracting Officer and telephone number
- H. Program Manager and telephone number
- I. Administrative Contracting Officer, if different from F., and telephone number
- J. List of major subcontractors
- (2) The offeror may provide information on problems encountered on the contracts, grants and subcontracts identified in (1) above and corrective actions taken to resolve those problems. Offerors should not provide general information on their performance on the identified contracts/grants. General performance information will be obtained from the evaluation forms.
- (3) The offeror may describe any quality awards or certifications that indicate the offeror possesses a high-quality process for developing and producing the product or service required. Identify what segment of the company (one division or the entire company) that received the award or certification. Describe when the award or certification was bestowed. If the award or certification is over three years old, present evidence that the qualifications still apply.
- (4) Each offeror will be evaluated on his/her performance under existing and prior contracts for similar products or services. Performance information will be used for both responsibility determinations and as an evaluation factor against which offerors' relative rankings will be compared to assure best value to the Government. The Government will focus on information that demonstrates quality of performance relative to the size and complexity of the procurement under consideration.

The attached Past Performance Questionnaire and Contractor Performance Form shall be completed by those contracting organizations listed in (1) above. The evaluation forms shall be completed and forwarded directly to the following:

Evaluation forms must be received by <u>July 31, 2000</u> in order to be included in the review process. It is the responsibility of the offeror to ensure that these documents are forwarded to the Contracting Officer.

L.12 Small Disadvantaged Business Participation Plan

In accordance with FAR Part 15.304(c)4, the extent of participation of Small Disadvantaged Business (SDB) concerns in performance of the contract shall be evaluated in unrestricted acquisitions expected to exceed a total estimated cost of \$500,000 (\$1,000,000 for construction) subject to certain limitations (see FAR 19.201 and 19.1202).

A. All offerors, regardless of size, shall submit the following information **in one clearly marked section** of their business proposal.

A plan on the extent of participation of Small Disadvantaged Business concerns in performance of the contract. Participation in performance of the contract includes the work expected to be performed by SDB concern(s). This can include SDB (as prime contractor), joint ventures, teaming arrangements, and subcontracts. Include the following information in SDB participation plans:

- 1. The extent of an offeror's commitment to use SDB concerns. Commitment should be as specific as possible, i.e., are subcontract arrangements already in place, letters of commitment, etc. Enforceable commitments will be weighted more heavily than non-enforceable ones.
- 2. Specifically identify the SDB concerns with point of contact and phone number.
- 3. The complexity and variety of the work SDB concerns are to perform.
- 4. Realism for the use of SDB in the proposal.
- 5. Past performance of the Offeror in complying with subcontracting plans for SDB concerns.
- 6. Targets expressed as dollars and percentage of total contract value for each participating SDB; which will be incorporated into and become part of any resulting contract.
- 7. The extent of participation of SDB concerns in terms of the total acquisition.

B. SDB participation information will be used for both responsibility determinations and as an evaluation factor against which offeror's relative rankings will be compared to assure the best value to the Government. The Government will focus on information that demonstrates realistic commitments to use SDB concerns relative to the size and complexity of the acquisition under consideration. The Government is not required to contact all references provided by the offeror. Also, references other than those identified by the offeror may be contacted by the Government to obtain additional information that will be used in the evaluation of the offeror's commitment to SDB participation.

L.13 BUSINESS PROPOSAL

The offeror shall submit as part of the proposal a <u>separate</u> enclosure titled "Business Proposal." The Business Proposal shall include the Cost/Price Proposal, the Small Business Subcontracting Plan and Other Administrative Data in accordance with the following:

A. Cost/Price Proposal

A cost proposal, in the amount of an original and ten (10) copies, shall be provided only to the extent that it shall include:

- 1. Certified, unloaded, labor rates for individuals expected to work on a project of this size and nature (Class Levels I through VI, see Sections B.3 and L.10).
- 2. Certified documentation indicating that the offeror has a cost accounting system in place which allows for the collection, tracking and reporting of all costs under a cost reimbursement-type contract.
- Certified documentation that the offeror has a current indirect cost rate
 agreement in place with a federal agency or that is in the process of obtaining or
 revising such an agreement. A copy of the indirect cost rate agreement or the
 proposed rate agreement shall be provided.
- B. <u>Small Business Subcontracting Plan:</u> All offerors except for small businesses are required to submit a subcontracting plan in accordance with the Small, Small Disadvantaged and Women-Owned Small Business Subcontracting Plan, FAR 52.219-9, incorporated in this solicitation. A copy of the AHRQ model subcontracting plan is provided as an attachment to this solicitation. If the model plan is not used, all elements outlined must be addressed in the offeror's format. If the offeror is a not a small business and fails to submit a subcontracting plan with the initial proposal, the offeror will be considered nonresponsive and their proposal will be returned without further consideration. The subcontracting plan should be submitted with the business proposal.

This provision does not apply to small business concerns. This provision does apply to all other offerors, including large business concerns, colleges, universities, and non-profit organizations.

The term "subcontract" means any agreement (other than one involving an employeremployee relationship) entered into by a Federal Government prime contractor or subcontractor calling for supplies or services required for the performance of the original contract or subcontract. This includes, but is not limited to, agreements/purchase orders for supplies and services such as equipment purchase, copying services, and travel services.

The offeror understands that:

- a. No contract will be awarded unless and until an acceptable plan is negotiated with the Contracting Officer. The plan will be incorporated into the contract.
- b. An acceptable plan must, in the determination of the Contracting Officer, provide the maximum practicable opportunity for small business concerns and small business concerns owned and controlled by socially and economically disadvantaged persons to participate in the performance of the contract.
- c. If a subcontracting plan acceptable to the Contracting Officer is not negotiated within the time limits prescribed by the contracting activity and such failure arises out of causes within the control and with the fault or negligence of the offeror, the offeror shall be ineligible for award. The Contracting Officer shall notify the Contractor in writing of the reasons for determining a subcontracting plan unacceptable early enough in the negotiation process to allow the Contractor to modify the plan within the time limits prescribed.
- d. Prior compliance of the offeror with other such subcontracting plans under previous contracts will be considered by the Contracting Officer in determining the responsibility of the offeror for award of the contract.
- e. It is the offeror's responsibility to develop a satisfactory subcontracting plan with respect to small business concerns and small business concerns owned and controlled by socially and economically disadvantaged individuals, and womenowned small business concerns, and that each such aspect of the offeror's plan will be judged independent of the other.
- f. The offeror will submit, as required by the Contracting Officer, subcontracting reports in accordance with the instructions thereon, and as further directed by the Contracting Officer. Subcontractors will also submit these reports to the Government's Contracting Officer or as otherwise directed, with a copy to the prime Contractor's designated small and disadvantaged business liaison.
- g. For this particular acquisition, the AHRQ recommended goal (as a percentage of total contract value for the base period) is 23% for Small Businesses, which shall include at least 5% (as a percentage of total contract value for the base period) for Small Disadvantaged Businesses, at least 5% (as a percentage of total contract value for the base period) for Women-Owned Small Businesses, and at least 1.5% (as a percentage of total contract value for the base period) for HUBZone Small Businesses. These goals represent AHRQ's expectation of the minimum level for subcontracting with small business at the prime contract level. Any goal stated less than the AHRQ recommended goal shall be justified and is subject to negotiation.

C. Other Administrative Data

(1) <u>Terms and Conditions</u>: The proposal shall stipulate that it is predicated upon the terms and conditions of the RFP. In addition, it shall contain a statement to the effect that it is firm for a period of at least 120 days from the date of receipt thereof by the Government.

Minimum Bid Acceptance Period (April 1984)

- (a) "Acceptance period," as used in this provision, means the number of calendar days available to the Government for awarding a contract from the date specified in this solicitation for receipt of bids.
- (b) This provision supersedes any language pertaining to the acceptance period that may appear elsewhere in this solicitation.
- (c) The Government requires a minimum acceptance period of 120 days.
- (d) A bid allowing less than the Government's minimum acceptance period may be rejected.
- (e) The bidder agrees to execute all that it has undertaken to do, in compliance with its bid, if that bid is accepted in writing within (i) the acceptance period stated in paragraph (c) above, or (ii) any longer acceptance period stated in paragraph (d) above.
- (2) <u>Authority to Conduct Negotiations</u>: The proposal shall list the names and telephone numbers of persons authorized to conduct negotiations and to execute contracts.

(3) Property:

- (a) It is HHS policy that contractors will provide all equipment and facilities necessary for performance of contracts. Exception may be granted to furnish Government-owned property, or to authorize purchase with contract funds, only when approved by the contracting officer. If additional equipment must be acquired, you shall include the description, estimated cost of each item and whether you will furnish such items with your own funds.
- (b) You shall identify Government-owned property in your possession and/or property acquired from Federal funds to which you have title, that is proposed to be used in the performance of the prospective contract.
- (c) The management and control of any Government property shall be in accordance with HHS Publication (OS) 74-115 entitled, <u>Contractor's Guide for Control of Government Property" 1990</u>, a copy of which will be provided upon request.

- (4) Royalties: You shall furnish information concerning royalties which are anticipated to be paid in connection with the performance of work under the proposed contract.
- (5) <u>Commitments</u>: You shall list other commitments with the Government relating to the specified work or services and indicate whether these commitments will or will not interfere with the completion of work and/or services contemplated under this proposal.
- (6) <u>Financial Capacity</u>: You shall provide sufficient data to indicate that you have the necessary financial capacity, working capital, and other resources to perform the contract without assistance from any outside source. If not, indicate the amount required and the anticipated source. (Financial data such as balance sheets, profit and loss statements, cash forecasts, and financial histories of your organization's affiliated concerns should be utilized.)
- (7) Performance Capability: You shall provide acceptable evidence of your "ability to obtain" equipment, facilities, and personnel necessary to perform the requirements of this project. If these are not represented in your current operations, they should normally be supported by commitment or explicit arrangement, which is in existence at the time the contract is to be awarded, for the rental, purchase, or other acquisition of such resources, equipment, facilities, or personnel. In addition, you shall indicate your ability to comply with the required or proposed delivery or performance schedule taking into consideration all existing business commitments, commercial as well as Government.
- (8) Representations and Certifications: Section K, "Representations and Certifications and Other Statements of Offerors" shall be completed and signed by an official authorized to bind your organization. This section shall be made a part of the original business proposal

L.14 SELECTION OF OFFERORS

- a. The acceptability of the technical portion of each contract proposal will be evaluated by the technical review committee. The committee will evaluate each proposal in strict conformity with the evaluation criteria of the RFP, utilizing point scores and written critiques. The committee may suggest that the Contracting Officer request clarifying information from an offeror.
- b. The business portion of each contract proposal will be subjected to a limited cost review, management analysis, small business plan analysis, etc.
- c. The Contracting Officer will, in concert with program staff, evaluate past performance and the Small Disadvantaged Business Participation Plan of the technically acceptable offerors and decide which proposals are in the competitive range. Oral or written discussions will be conducted with all offerors in the competitive range, if necessary. All aspects of the proposals are subject to discussions, including cost, technical approach, past performance, Small Disadvantaged Business Participation Plan and contractual terms and conditions. Final Proposal Revisions will be requested with the reservation of the right to conduct limited negotiations after submission of the Final Proposal Revisions.

- d. A final best-buy analysis will be performed taking into consideration the results of the technical evaluation, cost analysis, past performance, small disadvantaged business utilization plan, and ability to complete the work within the Government's required schedule. The Government reserves the right to make an award to the best advantage of the Government, technical merit, cost, past performance, and other factors considered.
- e. The Government reserves the right to make a single award, multiple awards, or no award at all to the RFP.

SECTION M - EVALUATION FACTORS FOR AWARD

- M.1 Selection of an offeror for contract award will be based on an evaluation of proposals against four factors and award will be made to that responsible offeror whose proposal is most advantageous to the Government. The four factors are: technical, cost, past performance, and the small disadvantaged business (SDB) subcontracting plan. The technical proposal will receive paramount consideration in the selection of the Contractor(s) for this acquisition. Offerors that submit technically acceptable proposals will then be evaluated for past performance and for their Small Disadvantaged Business Subcontracting Plan. Following the evaluation of the offeror's past performance and Small Disadvantaged Business Participation Plan, a competitive range will be determined.
- M.2 All evaluation factors, other than cost or price, when combined are significantly more important than cost or price. However, cost/price may become a critical factor in source selection in the event that two or more offerors are determined to be essentially equal following the evaluation of all factors other than cost or price. In any event, the Government reserves the right to make an award to that offeror whose proposal provides the best overall value to the Government. The Government reserves the right to make a single award, multiple awards, or no award at all.

THE GOVERNMENT RESERVES THE RIGHT TO MAKE AN AWARD WITHOUT DISCUSSION

M.3 All proposals will be reviewed in accordance with the governing regulations and AHRQ policies and procedures. The technical proposal, past performance information and Small Disadvantaged Business Participation Plan will be evaluated in terms of the offeror's responses to each of the evaluation factors. Each proposal will be evaluated on the likelihood of meeting the Government's requirements. The evaluation factors and assigned weights which will be used in the overall review of the offeror's proposal are outlined below. The technical proposal shall consist of the responses to evaluation criteria 1 through 5. The offeror should show that the objectives stated in the proposal are understood and offer a logical program for their achievement. The following criteria will be used to evaluate proposals and will be weighted as indicated in establishing a numerical rating for all proposals submitted. The offerors' past performance will be evaluated on the basis of the following factors:

- (a) Quality: How well the contractor conformed to the performance standard in providing the research services or achieved the stated objective of the contract or grant. Quality will be evaluated by the personnel provided, the level of effort agreed to in the contract statement of work or grant, and quality of final products (e.g., written reports).
- (b) Timeliness: How well the contractor adheres to time-tables and delivery schedules in providing the research services or products. Consideration is given to contractor's effort to recommend and/or take corrective actions to keep the contract or grant on schedule.
- (c) Customer-satisfaction: Rates the professional and cooperative behavior of the contractor or grantee with the client.

The Government is seeking to determine whether the offeror has consistently demonstrated a commitment to customer satisfaction and timely delivery of services at fair and reasonable prices.

The assessment of the offeror's past performance will be used as a means of evaluating the relative capability of the offeror and the other competitors. Thus, an offeror with an exceptional record of past performance may receive a more favorable evaluation than another whose record is acceptable, even though both may have acceptable technical proposals.

By past performance, the Government means the offeror's record of conforming to specifications and to standards of good workmanship; the contractor's record of forecasting and controlling costs; the offeror's adherence to contract schedules, including the administrative aspects of performance; the offeror's reputation for reasonable and cooperative behavior and commitment to customer satisfaction; and generally, the offeror's business-like concern for the interest of the customer.

The Government will consider the number or severity of an offeror's problems, the effectiveness of corrective actions taken, the offeror's overall work record, and the age and relevance of past performance information.

The lack of a performance record may result in an unknown performance risk assessment, which will neither be used to the advantage nor disadvantage of the offeror.

The Government reserves the right to evaluate relevant past performance information not specifically provided by the offeror.

7. Small Disadvantaged Business Participation Plan (5 points)

The evaluation will be based on information obtained from the plan provided by the offeror, the realism of the proposal, other relevant information obtained from named SDB concerns, and any information supplied by the offeror concerning problems encountered in SDB participation.

Evaluation of the SDB Participation Plan will be a subjective assessment based on a consideration of all relevant facts and circumstances. It will not be based on absolute standards of acceptable performance. The Government is seeking to determine whether the offeror has demonstrated a commitment to use SDB concerns for the work that it intends to perform as the prime contractor.

The assessment of the offeror's SDB Participation Plan will be used as a means of evaluating the relative capability and commitment of the offeror and the other competitors. Thus, an offeror with an exceptional record of participation with SDB concerns may receive more points and a more favorable evaluation than another whose record is acceptable, even though both may have acceptable technical proposals.

SDB participation will be scored with offerors receiving points from 0 to 5, with 5 being the most favorable.

A. Welcome and Opening Remarks

Helen Burstin, M.D., M.P.H., Director of the Center for Primary Care Research division of the Agency for Healthcare Research and Quality (AHRQ), opened the meeting and welcomed the participants. The purpose of the discussion is to understand how AHRQ can contribute to the current state of bioterrorism research. Five million dollars of the agency's \$205 million FY 2000 budget is allocated to addressing current issues relating to bioterrorism research, prevention, and preparedness.

John Eisenberg, M.D., Director of AHRQ, gave a brief overview of AHRQ's history and future goals. He stressed that AHRQ's focus is on health care within the context of the general population, whereas agencies such as the CDC are much more focused on public health. However, there is significant overlap among government agencies and research institutions with respect to bioterrorism initiatives. AHRQ's overall research goals are as follows:

- # To support improvement in health outcomes;
- # To strengthen quality measurement and improvement; and
- # To identify strategies to improve health care access, foster appropriate use of the health care system and reduce unnecessary expenditures.

Dr. Eisenberg encouraged meeting participants to identify priorities of bioterrorism research within the abovementioned goals.

B. Presentation of the Center for Disease Control and Prevention

Richard Spiegel, D.V.M., M.P.H., a medical epidemiologist within the Bioterrorism Preparedness Response Program of the CDC, gave an overview of the CDC's role in responding to biological and chemical terrorism nationwide. The CDC has been designated by DHHS to coordinate and lead the overall planning effort to upgrade public health capabilities in response to bioterrorism. A few of the CDC's priority responsibilities and activities for the bioterrorism initiative include:

- # Conducting studies on health and bioterrorism events;
- # Facilitating and supporting State and local bioterrorism preparedness and response planning;

- # Enhancing Federal, State and local laboratory diagnostic capabilities;
- # Strengthening State and local epidemiological and surveillance capacity; and
- # Establishing a national health alert network.

In order to successfully accomplish the above goals, the following components of a comprehensive public health program for bioterrorism preparedness and response must be in place:

- # Program planning and development;
- # Detection of unusual events--surveillance;
- # Rapid investigation and containment of real or potential threats--epidemiology;
- # Education and training;
- # Coordination and communication; and
- # Practice, exercises and program evaluation.

One hundred twenty-one million dollars of the CDC's FY 1999 budget was allotted to bioterrorism research. Of that amount \$28 million was spent on health alert (communications) initiatives, \$17 million was spent on surveillance and epidemiology (response) systems and research, and \$3 million was spent on planning. Dr. Spiegel predicts FY 2000 expenditures will be roughly similar in proportion. Priority initiatives for this fiscal year include enhancing outbreak response, coordination and support, enhancing local-level epidemiology and surveillance, and improving the use of information technology in the preparedness process. Data flow is one area in which the CDC would like to improve. News of a recognized, unusual event spreads quickly to the right people using various means of direct communication. An unrecognized, unusual event, however, is much harder to detect. Efforts to develop surveillance systems which can monitor unique circumstances and notify key personnel when a rare situation arises would be highly beneficial.

C. Presentation of the Office of Emergency Preparedness

Robert Knouss, M.D. and Commander Kevin Tonat, Dr.P.H., M.P.H. presented an overview of the Office of Emergency Preparedness (OEP) of DHHS. The National Disaster Medical System, within the OEP, focuses on emergency and disaster assistance through planning, training, development and response activities. A

systems development approach, concentrating on four key elements, strengthens and enhances DHHS's ability to prepare and respond to terrorist events. The four elements are as follows:

- 1. Enhancing the public health infrastructure;
- 2. Strengthening medical response capabilities on national and local levels;
- 3. Creating and maintaining a stockpile of pharmaceuticals and other materials; and
- 4. Enhancing research, design, development and approval of diagnostic antibiotics/antivirals and vaccines.

In reviewing the response characteristics, Commander Tonat stressed the bottom-up nature of a bioterrorism event. Therefore it is essential to implement rapid and appropriate response systems, beginning with the first responder in the community and working up through appropriate channels and ultimately reaching the Federal level. The main components of the response pathway are:

- # Public health monitoring and surveillance;
- # National/local data collection and analysis;
- # Federal/local response operations; and
- # Federal recovery assistance.

One area of study the OEP would like to focus on is strengthening the links along the response pathway. Law enforcement, emergency management, public health, and medical personnel can all be involved in a single bioterrorism event. Appropriate surveillance and communication measures which connect these and other personnel are key components of effective public health decisionmaking and response.

D. Group Discussion

The group identified research activities in which AHRQ can utilize its bioterrorism funding, with suggestions falling into the following categories:

- # Surveillance Systems;
- # Education and Training;

- # Decision Support;
- # Models/Simulations;
- # Outcomes; and
- # Other Ideas for Evidence Report.

1. Surveillance Systems

Some participants suggested that AHRQ focus its efforts on making a difference in outbreak detection or response in a concrete way in order to increase bioterrorism funding in future years and give AHRQ more leverage in health communities. To do so, AHRQ needs to articulate steps in detection and response and offer solutions. Many felt that determining the specific functions a surveillance system should perform and the necessary sensitivity needed by such a system is a high research priority. An effective surveillance system should link the public health community, the health care provider, and Government agencies. If the surveillance system serves as a routine organizational system that can be altered to a different purpose during a bioterrorism event, clinicians will be invested in using it every day. An appropriate system will build on current electronic medical records and include multiple-source detection data and a follow-up/feedback function. Suggestions for specific research activities include:

- # Develop an algorithm which can be used to identify an emerging event.
- # Monitor awareness and access of users and potential users.
- # Determine what systems are already being used and how effective they are in order to minimize development and use efforts.
- # Implement a surveillance system which consists of a human interface with a model framework. The ideal person/people will have public health training. Computers are too slow and antiquated and there is little incentive for hospitals to use them.
- # Develop a way to link surveillance systems to poison control centers or use them as models.
- # Focus a study on the interface between bottom and top levels along the response pathway.
- # Research the different models and approaches to how an affordable linkage system can visibly and quickly improve the interface communication.

2. Education and Training

Participants had opposing views on the effectiveness of bioterrorism education programs targeting health care workers. Some believed that programs designed to increase the awareness among those along the bioterrorism response pathway would lead to a positive change in behavior. Others were unsure of whose behavior is being targeted and what information they need to know. The main objective of education initiatives was determined to be the identification of the most effective educational interventions and dissemination of that information. Research suggestions are as follows:

- # Evaluate what is currently being done to educate health care providers and determine if it is effective. Is it something the medical care community feels a need for?
- # Survey school training programs to determine the average baseline training level.
- # Ask who is being trained. How are they being trained? Is "just-in-time" training effective?
- # Study how awareness among health care workers is created and maintained. How can accurate information be supplied to clinicians in a timely manner?
- # Raise the index of suspicion by teaching professionals how to recognize an outbreak rather than how to identify a particular agent.
- # Find out how public health officials recognize and deal with false positives.
- # Document the current state of experience and knowledge about bioterrorism events.

3. Decision Support

Development of systems of decision support for physicians was another suggested research topic. Studies should be designed to answer the following questions: If clinicians are alerted to an unusual event, what do they do next? Who do they alert? How do they respond? Can a system be built to give physicians "just-in-time" information? AHRQ should look at the feasibility of effectively answering these questions.

4. Models/Simulations

Because simulations are effective in raising awareness and allow movement into complex modes of interaction, participants suggested AHRQ focus its efforts on assessing the objectivity and effectiveness of models and simulations. However, it can be difficult to match an appropriate simulation to the level of capacity of the clinician. Key questions to consider and suggested research efforts on this topic are:

- # With minimal data how does one detect and define the affected population and assess models for predictive ability?
- # How can one design simulations that will raise awareness and teach skills to health care professionals?
- # How can models remain current?
- # How can simulations appropriately change to meet the needs of unique health events?

Outcomes

Issues such as short- and long-term outcomes, costs, and quality indicators were the subject of much discussion among participants. Various suggestions for research topics are listed below.

- # Determine the impact of false alarms and hoaxes.
- # Evaluate the psychiatric and physical burden among health care providers and workers during a bioterrorism incident.
- # Develop programs to treat community stress in order to keep the health care community psychologically healthy.
- # Determine where people get information during a health emergency. What information do they trust?
- # Form a joint information center to function as a readily available source of authoritative information on bioterrorism events nationwide.
- # Study how the public can be reassured during conditions of high uncertainty.
- # Determine what risk communication tools are useful in bioterrorism events.

6. Other Ideas for Evidence Reports

- # Study sensitivity/specificity of detection systems.
- # Determine how prepared the health care community is to deal with an outbreak and determine the economic impacts of such an event.
- # Perform an evidence-based evaluation of protective gear (i.e., firemen's masks, hospital masks).
- # Conduct an evidence-based study of current response systems. How well integrated are EMS command systems and hospitals?

E. Next Steps

Helen Burstin and Carolyn Clancy were pleased with the level of interest expressed by the meeting participants and the amount of input given to this research question. While keeping in mind the mission and goals of the agency, they will determine which research questions will benefit those groups handling bioterrorist issues, and which will make the most impact with the level of funding provided. A program announcement will be written to solicit additional funding to supplement the funds currently allocated to bioterrorism research.
