Oregon Celebrates 60 Years of Desegregation of the Military



New GI Bill Expands Benefits

WASHINGTON DC – The Congress has passed and President George W. Bush has signed legislation enacting the Post 9/11 GI Bill, also known as the GI Bill for the 21st Century. The most comprehensive education benefits package since the original GI Bill of 1944, the new GI Bill significantly expands a veteran's education benefits.

"One of the reasons the World War II generation is the greatest generation is because

they came home from war, went back to school, and then began leading our nation," said Oregon Department of Veterans' Affairs Director Jim Willis. "With this new GI Bill, we can make another great generation of future leaders."

Benefits Start Date

This new GI Bill is set to go into effect on August 1, 2009. However, as with any new

homas Jefferson wrote in the Declaration of Independence that: "We hold these truths to be self-evident, that all men are created equal." Abraham Lincoln said in his Gettysburg Address that we live in "a new nation, conceived in liberty and dedicated to the proposition that all men are created equal."

However, for veterans attending the celebration of the 60th Anniversary of the Desegregation of the Armed Services, July 18 in Salem, their liberties were hard won during a different time in our nation's history.

Hosted by the Oregon Department of Veterans' Affairs (ODVA) and the Oregon Military Department, the celebration drew more than 100 family, friends and interested visitors to honor the American veterans of African, Japanese, Hispanic, Indian and other descent.

Oregon's first African-American general officer, Brig. Gen. Garry C. Dean, was the keynote speaker. He would address a unique group of veterans: Tuskegee Airmen, Japanese-Americans from the famed 442nd Regimental Combat Team, as well as Native American and Hispanic veterans.

ODVA Director Jim Willis welcomed guests to the ceremony and praised the military's changes to establish equality for all service members.

"It is important that we hold events commemorating the successes we have

Scholarship Named for Late Advisory Chair, Dick Lucht

In memory of Richard P. "Dick" Lucht, the Yamhill County Disabled American Veterans (DAV) will soon be establishing a Scholarship Program.

The new scholarship will be open to graduating sons and daughters of service-connected disabled veterans attending McMinnville High School.

As reported in the July/August edition of VETS NEWS, Lucht passed away on June 5. He was honorably discharged from the Navy, and would later work tirelessly with the Oregon

Department of Veterans' Affairs and Oregon Legislature to create the Oregon Veterans' Home, which opened in 1997.

It is the goal of DAV and the Auxiliary chapter to fund the scholarship at \$2,000 annually. The chapter members have approved the first \$1,000 and are challenging the DAV and other organizations to meet the goal in the first year. Scholarships should be available for the graduating class of 2009.

Vets' Home Resident Gets Jet Flight

When Donald "Don" R. McIntee grew up on a North Dakota farm near the Canadian border, he didn't imagine that at age 19 he would enlist into the U.S. Army Air Corps and be a crewmember aboard a B-17 bomber.

The former Flying Fortress aerial engineer has had one wish – to again ride in a military aircraft. As part of the "New Chapters" program of Marquis/Consonus Healthcare Facilities, he was granted his wish. On June 18, the 85-year-old veteran and resident of the Oregon Veterans' Home, returned to the skies, but not in a vintage American plane.

With help from the Dallesport, WA. volunteer fire department, McIntee, an amputee, was placed in the backseat of a Czechoslovakian-built L-39 Albatross military jet that is owned and piloted by Phil Fogg, Sr. A former Vietnam Cobra helicopter pilot, Fogg is also the director of Business Development for Marquis.

The pair lifted off from the Dallesport airport and flew over the Veterans' Home to an awaiting crowd. Fogg then rolled the aircraft and the men headed down the Columbia River Gorge to Hood River, his home for 40 years.

During World War II, McIntee spent three years instructing other men in aerial gunnery in Kingman, Ariz. As a skilled B-17 flight engineer, McIntee maintained the aircraft's electrical system and other in-flight mechanical operations.

"While on our daily four-hour training missions, I stood between the pilot and co-pilot

and read airspeed for them for take off and landing and sometimes flew the B-17's once they were in the air," McIntee said. "I was a B-17 man."

McIntee didn't experience aerial combat. He was not assigned to serve in Europe until July 28, 1945, nearly three months after Germany surrendered. His B-17 crew was ordered to fly to the Mediterranean Sea, the Suez Canal and the Indian Ocean and up to Calcutta India.

"When the first atomic bomb was dropped on Hiroshima, Japan on Aug. 6, I was in the Suez Canal. Then the war was pretty much over," he said.

McIntee was thankful for the ride and excited to be airborne again. "I only have one leg, but I was able to get on board with some help. The jet was faster than the B-17, but the feeling was again as much fun as flying over 65 years ago. I just love flying."

Veterans' Home Wins Quality Award

Enrolled Veterans Gain Access to AAFES

SAINT LOUIS – Veterans enrolled in the VA health system now can sign up to access the Army Air Force Exchange System (AAFES) online.

AAFES has established a partnership with the Veterans' Canteen Service (VCS), the store routinely found in VA Medical Facilities throughout the country. Through this partnership, any veteran with a VA medical card (Veterans Identification Card – VIC) may register.

Registering does not allow veterans access to AAFES on military bases, only access to shopping online and via catalog. To enroll, go online to www.vacanteen. va.gov or send an email to vcs.canteen@med.va.gov and use the subject line VAVCS Catalog. You will need your VIC when you register.

If you have misplaced or lost your VIC, contact the VA where your picture was taken and request a new card, or call 1-877-222-VETS (8387) to check the status of your card.

achieved as a result of President Truman's Executive Order desegregating our armed forces," he said. "Our military led the way in establishing civil rights for all persons who wear our nation's uniform and our country is better for having done so."

Among the honored guests who served in World War II were two members of the famed Tuskegee Airmen—the first "black flyers" in the Army Air Corps during World War II—and six Japanese-American veterans who were assigned to the 442nd Regimental Combat Team.

Retired Lt. Col. Bill Holloman, of Kent, Wash., began his military career in 1942 as a cadet in the famed, yet scrutinized 332nd Fighter Group that trained in Tuskegee, Ala. A combat veteran of World War II, the Korean War and Vietnam, Holloman, 84, said at the time people thought black Americans lacked the intelligence and skill to fly airplanes or do anything but menial tasks.

Nearly 1,000 airmen had been trained as pilots, bombardiers, navigators and ground crews. "It was the only flying school of its kind in the world," he said. "We proved all doubters wrong. The Tuskegee Experiment, as President Roosevelt called it, left little doubt that black men could fly, repair aircraft and do anything non-black airmen could do."

Holloman flew the P-40, P-47, and P-51 before climbing into fighter jets in Korea. He would later became the Air Force's first black helicopter pilot. "I love flying, but that doesn't mean that I wasn't looking toward the day when the war was over."

Ed Drummond recalled his time as a Tuskegee pilot. A retired lieutenant colonel from Lakewood, Wash., Drummond, 82, was in the final graduating class at Tuskegee in 1946. He was assigned initially to the 477th Composite Group and flew B-25 bombers at Lockbourne Air Base, Ohio.

Assigned to serve in Japan as a P-47 fighter pilot in June 1949, Drummond was one of the first two African American pilots to be both stationed at Misawa Air Base and fly jet combat missions in Korea in the 49th Fighter Group.

"This was all still new to the Air Force. We had a wealth of camaraderie with our fellow pilots and most everyone overseas treated us fine," he said. Holloman added that racial tensions weren't as intense in Europe. "In Italy, the (white pilots) were very friendly and wouldn't let us buy our own drinks. Back then we were all brothers in arms in a combat zone."

After the attack on Pearl Harbor, Japanese Americans stateside were deemed enemy aliens and reportedly not suited for military service. Those in the service at that time were discharged and then joined their families in relocation camps. Later when allowed to join the military and serve, many of the more than 5,000 Japanese American soldiers were assigned to pick up trash and pull weeds.

By February 1943, the War Department approved and created segregated combat

units, including the 442nd Regimental Combat Team. After once ordering Japanese Americans and their families into the camps in 1942, President Franklin D. Roosevelt called upon Japanese American men in 1943 to volunteer and serve in the 442nd.

For Kennie Namba and other young Japanese American men, the option to being held in a relocation camp was to volunteer and join the Army. "At the time we weren't considered American enough to carry a rifle. We wanted to show that we were proud Americans to fight and willing to die for our country," Namba told the crowd.

Like many Japanese American veterans, when

Namba returned home after the war, it was another world for him and his wife, Ruth. A Purple Heart recipient, he was in uniform when Namba and Ruth went to purchase groceries in her hometown of Hood River. The signs in many store windows read "No Japs." Japanese returning to their homes in Hood River County were strongly encouraged to "dispose of their holdings" while buyers would offer them " a square deal."

"We couldn't buy much of anything for almost a year and we depended upon our non-Japanese neighbors to make purchases for us," Namba recalled. "But, that was a long time ago and our lives have changed since then. Soon we earned college degrees and made positive contributions to our country while trying to blend in."

The 442nd, or the "Purple Heart Battalion," earned its nickname the hard way by suffering the highest casualty rate per capita of any U.S. military unit in the war. The men prefer to be recalled as the "Go for Broke" regiment, a

reference to their motto in battle.

Reyn Leno, a Grand Ronde tribal member and Vietnam veteran, told the audience that while serving, he and fellow Native Americans couldn't congregate due to racial tensions. Yet, at that time, Leno didn't have time to struggle with race concerns.

"When you're out there in the dark near the enemy, race doesn't matter," he said. "You want to make sure your buddy has your back and that you have his. My dad served nearly five years in World War II, but he didn't talk about racial issues."

Delivering his remarks in uniform, Oregon Army National Guard Lt. Col. Ricardo Gloria, proudly noted that his daughter is a sailor serving aboard the *USS Abraham Lincoln* near Afghanistan. He said that bravery isn't limited to a person's skin color. He noted that Hispanics have been awarded the Medals of Honor during the Civil War (2), World War II (12), Korean War (9), and in Vietnam (8).

"All races make the military the strong and cohesive force it is today. I am so very proud to serve and had so many great opportunities serving in the Guard."

Now serving at the Pentagon as the U.S. Air Force's Deputy Inspector General, Dean personally thanked the special guests in attendance for their service. Dean saluted all veterans of color for paving the way for him to reach his potential by opening doors of opportunity that he could walk through.

"I value your courage and determination to serve our nation," Dean said. "You did so with dignity and honor. I truly salute your service. You were discriminated against, yet you chose to defend freedom. Your response to segregation was to serve with honor."

While then-Army General Omar Bradley warned that it was not the business of the armed services to conduct "social experiments," Truman's decision to call for change in military policy would become a model of institutional racial integration where truly all men are created equal.

legislation, it could take some time for the Department of Veterans Affairs (VA) to begin paying benefits. Benefits will not be paid for any training or education programs completed before July 31, 2009. Applications are not being taken at this time. Please visit the VA GI Bill website at www.va.gibill.gov for more information.

Eligibility for the New GI Bill

If you have served a total of at least 90 days on active duty in the Armed Forces, you are eligible. However, the amount of benefits you receive under this program are determined by the actual amount of accumulated post-9/11 service you have.

To be eligible for the full benefit, you must have three years of active duty service after 9/11 or have been discharged due to a service-connected disability. If you are an officer who graduated from a service academy or received ROTC scholarships, you also qualify for the new GI Bill benefits. However, your ROTC/Service Academy associated obligated active-duty service time does not count toward the three years necessary to qualify for the full benefits.

Note: You didn't have to opt-in for the Montgomery GI Bill to be eligible for this program.

New GI Bill Payment Rates

The post- 9/11 GI Bill will provide up to 100 percent of your tuition. In addition, the program provides a monthly housing stipend, a stipend of up to \$1,000 a year for books and supplies. If you attend less than full-time, you will receive a portion of the payment based on the number of units of study.

The amount of tuition and stipends paid under the post-9/11 GI Bill will vary depending on your state of residence, number of units taken, and amount of post-September 11, 2001 active-duty service. Here is a quick reference showing the percentage of total combined benefit eligibility based on the following periods of post-9/11 service:

100% - 36 or more total months

100% - 30 or more consecutive days with disability related discharge.

90% - 30 total months

80% - 24 total months

70% - 18 total months

60% - 12 total months

50% - six total months

40% - 90 or more consecutive days

Monthly Housing Stipend

If you are enrolled in a traditional college program as a full time or three-quarter time student, you will be paid a monthly housing stipend equal to the monthly amount of the Basic Allowance for Housing (BAH) for an E-5 with dependents. The average housing stipend will be approximately \$1,000 a month. However, if you attend distance learning programs such as correspondence courses and online you will not qualify for this stipend.

Book and Supply Stipend

You will receive a lump sum payment the first month of each quarter, semester, or term. The payment will help cover the cost of books, supplies, equipment, and other educational fees for that academic term. The payment amount will be equal to either a quarter or half of the annual \$1,000 cap for that academic year, depending on how the academic year is divided – quarter or semester terms.

Benefits Expiration Date

The new GI Bill will allow you to use this benefit for up to 15 years after your last discharge or separation from active duty.

Benefit Transferability

Servicemembers who have served at least 10 years on active duty will be able to transfer their benefit to a spouse or dependent child. Servicemembers who have served at least six years and agree to another four-year contract may be able to transfer their benefit sooner.

The transferred benefit will cover the cost of tuition only.

Benefits may be divided as long as they don't exceed 36 months of college classes. For example, a retired soldier can use half of the benefits to pay for a two-year degree program, then transfer the remaining half to a spouse or child. College-age children of long-serving servicemembers could get a free college education starting fall 2009, provided they attend a state-backed school.

If you are eligible for both the Post-9/11 GI Bill and Vocational Rehabilitation and Employment (CH31), you should speak with your Vocational Rehabilitation Counselor to determine which benefit is most beneficial to your situation.

No. The Post-9/11 GI Bill only covers classes taken or training pursued on or after August 1, 2009.

Individuals who do not use all their entitlement under the Post-9/11 GI Bill will not receive a refund of contributions paid under the Montgomery GI Bill.



More Veterans May Be Eligible for Special Compensation

WASHINGTON - About 20,000 veterans forced out of the military early by a combatrelated injury could be eligible for hundreds of dollars in special compensation pay under new rules outlined by the services this month.

Prior to the change in law, only those veterans with 20 years of service could apply for Combat Related Special Compensation. However, under the new rules, any veteran with a combat-related disability may be eligible for the compensation.

Department of Defense guidance defines a combat-related disability in one of the three following ways:

A Purple Heart disability, which is a disability with an assigned medical diagnosis code from the Veterans Affairs Schedule for Rating Disabilities, or VASRD, that was attributed to injuries for which the member was awarded a Purple Heart.

One with an assigned medical diagnosis code from the VASRD that was:

■ Incurred as a direct result of armed conflict;

- As a result of hazardous service;
- In the performance of duty under conditions simulating war; or
 - Through an instrumentality of war.

One with an assigned medical diagnosis code from the VASRD that was deemed presumptive or "presumed" by the VA to be incurred as a result of combat operations.

To receive the special compensation, veterans must be currently receiving military retired pay and veterans' disability payments, and must have a 10 percent or greater rated disability recognized by the military as combat related.

The amount of the monthly CRSC pay will be based on troops' rank, years of service and severity of their injury. In some cases the formula for Combat-Related Special Compensation could actually reduce a veteran's total monthly payments; however, the Defense Finance and Accounting Service (DFAS) will calculate all of the disability pay impact to make sure veterans are receiving the highest payouts possible and begin CRSC payments within 60 to 90 working

days of receiving the approval letter.

All veterans, including recently separated servicemembers, will have to apply to receive the new compensation by completing a DD Form 2860 with the required documentation attached. Required documentation includes a signed claim form and:

Copy of Chapter 61 Board results (Chapter 61 claimants only).

Copies of ALL VA rating decisions which include the letter and the narrative summaries

Copies of ALL DD214's

Medical records that support "HOW" the injury occurred for each claimed disability that meets the criteria for combat-related. Refer to CRSC website to learn what combat-related is.

Veterans interested in applying for Combat Related Special Compensation should contact their local Veterans' Service Officer (page 12) or the organization who last helped them with their VA claim.

"As you may know, this 'ringing' seems never to go away, but there are ways you are able to get some relief, and these are the reasons for the meetings," according to H.L. Sponsored by the National Center for Rehabilitative Auditory Research, the Group meets eight times a year to discuss issues related to tinnitus and the latest treatment options. Willamette National Cemetery Opens Columbarium Niches

Willamette National Cemetery announces the opening of the first terrace of cremation niches in the new Columbaria built as a part of the final development of its existing acreage. Cemetery Director George A. Allen secured the immediate availability of the intial 2,104 niches because of exceptional public interest and demand.

Another 7,700 niches will be released for use in the coming months. Normal procedures would have delayed their availability until the entire construction project was completed in the late summer or early fall. That project also includes almost 10,000 new full size gravesites as well as rest rooms, a touch-screen gravesite locator and new cemetery signage.

Cemetery officials indicate that hundreds of cremations are being held by families and local funeral homes in anticipation of this aboveground placement option. Niche space in the facility's existing Columbaria was exhausted in early 2004. Work on the new walls began in September of 2006. Well over 50% of the cemetery's 3,400 annual interments are of cremated remains.

Outward Bound Program Offered for OEF/OIF Veterans


