Oregon Legislative Assembly Adjourns

The 73rd Oregon Legislative Assembly, which convened in January 2005, adjourned on August 5. During the session, approximately 150 Bills relating to veterans and/or the Oregon National Guard and Reserve were introduced. A number of bills passed providing additional or increased benefits to veterans.

As with previous legislative sessions, veterans' organizations and others concerned with and interested in veterans' issues demonstrated great support of legislation affecting veterans and their families. Additionally, these same supporters respectfully spoke up when they deemed pieces of legislation to be less than helpful. The United Veterans' Groups of Oregon held a Veterans Muster on the steps of the Capitol in early February.

The Veterans Muster was later followed by a Veterans Rally, also held on the steps of the Capitol. The subject of the rally was House Joint Resolution (HJR) 34, which would have referred a proposed constitutional amendment to the people. The proposed amendment would have dedicated 1% of net proceeds of State Lottery dollars for services to Oregon veterans. HJR 34 was passed by the House, but was not heard by the Senate.

Legislation affecting veterans that had been signed into law at the time this publication went to print included, but was not limited to:

 Department of Veterans' Affairs budget approved. (HB 5109)

- Maximum veterans home loan amount increased to 100 % (previously 97 %) reducing upfront costs for eligible borrowers. Effective 1/1/06 (SB 223)
- Property tax exemption for qualified disabled veterans modified. The exemption amount increased to \$15,000 of assessed value for a disabled veterans and \$18,000 for a veterans with 40% or more serviceconnected disabilities. (HB 2945)
- High school diplomas to be issued (upon request) to veterans of WWI, WWII, Korea, and Vietnam who attended high school but did not graduate from a high school because they were serving in the Armed Forces of the United States. Veterans or representative of deceased veterans can make requests of school districts. (HB 2681)
- Definition of veteran modified for employment preference purposes.
 Length of service requirement reduced from 180 to 178 days. One day in combat zone included as a qualifying criterion. Effective 1/1/06 (HB 2687)
- State funding assistance made available from State Parks and Recreation to nonprofit veterans' organizations for constructing and restoring veterans and war memorials located on public property. (HB 2739)
- July 16 of every year designated as Atomic Veterans Day. (HCR 9)
- Several House Joint Memorials urging Congress to take positive actions affecting veterans' benefits such as

- changing spending on veterans' health care from discretionary spending to direct spending funded by mandatory appropriations.
- Several Bills specifically affecting benefits for National Guard and Reservists and their families including extending tuition waiver program of Oregon Military Department to surviving family members of members of National Guard killed while on active duty.

At the time publication went to print, the following Measures were awaiting signature:

- Oregon Veterans' Emergency Financial Assistance Fund created in the Department of Veterans Affairs to provide emergency funds to assist Veterans and their immediate families. State educational benefits increased to \$150 per month (from \$50) to eligible Veterans. (HB 3504)
- Funds provided for enhanced and expanded services provided to veterans' by county veterans' service officers. (SB 1100)
- Funds provided for building a memorial to Oregon military personnel killed in Afghanistan and Iraq. (HB 2795)

2005 National POW/MIA Recognition Day – September 16, 2005 –

National POW/MIA Recognition Day

September 16, 2005 (observed each year on the third Friday of September) is National POW/MIA Recognition Day. Over the past several years, all or most of the 50 states have proclaimed POW/MIA Recognition Day in conjunction with the national effort.

The sacrifices of Americans still missing and unaccounted for from all our Nation's wars and their families are deserving of national recognition and support for continued priority efforts to determine the fate of those missing Americans.

This commemoration is set aside to honor the commitment and sacrifice made by this nation's Prisoners of War and those who are still Missing in Action, as well as their families.

More than 88,000 Americans remain missing from World War II, the Korean War, the Cold War, and the Vietnam War. The United States leads the world in the humanitarian effort to account for it's missing.



The 2005 POW/MIA Recognition Day poster was unveiled in Washington, D.C. on June 15, 2005, by the Department of Defense (DoD). At the unveiling, Larry Greer, Defense POW/Missing Personnel Office spokesman, stated "Though art is always in the eye of the beholder, it is pretty clear that what this poster is saying is, 'We Remember' and we as a nation are committed to bringing these guys home."

Flying the POW/MIA Flag

The Oregon Department of Veterans' Affairs flies the POW/MIA flag every business day. Since the Department has a single flag pole, federal flag protocol dictates that the United States flag be flown at the top of the pole with the POW/MIA flag immediately beneath it, and the state flag below the POW/MIA flag

The POW/MIA flag has been officially designated by the Congress of the United States as "the symbol of our Nation's concern and commitment to resolving as fully as possible the fates of Americans still prisoner, missing and unaccounted for in Southeast Asia, thus ending the uncertainty for their families and the Nation."

By federal law the flag is required to be flown six days each year: Armed Forces Day, Memorial Day, Flag Day, Independence Day, National POW/MIA Recognition Day and Veterans Day, at major federal installations.

Troop & Veteran Appreciation Day

The third annual Troop & Veteran Appreciation Day celebration will be held on Saturday, September 24, at the McMinnville Armory. The Coalition of Troop Support and the Afghan-Iraqi Freedom War Memorial Fund are sponsoring the event. The event is intended to pay tribute to all veterans who have served this country with a special focus on troops that are currently deployed to Iraq and Afghanistan.

The Master of Ceremonies for the event will be Jim Willis, Director of the Oregon Department of Veterans' Affairs.

"I'm pleased to be a part of the Troop & Veteran Appreciation Day again this year. I know what events like these mean to veterans," said Director Willis. "As a veteran myself, and a native Oregonian, it is encouraging to see communities and individuals working together to show their support for those who have served and are currently serving this country."

The Coalition of Troop Support is a group that has collected, packaged and sent

numerous shipments of requested or needed itmes to deployed servicemembers.

The Coalition provides an opportunity for individuals to get involved in supporting the men and women who are currently serving and their families. They have assisted in the planning and organizing of many events aimed at honoring and supporting veterans of all eras

This year's event will be held at the McMinnville Armory located at 333 Armory Way, McMinnville, Oregon, just off Highway 18, across from the Evergreen Aviation Museum from noon until 3 p.m. The event will include servicemembers who have returned from active duty in Iraq sharing about their experiences, live musical performances, food and various military displays.

The Afghan-Iraqi Freedom War Memorial Fund will also host a booth with information about the proposed Memorial that will be built on the Capitol Mall in Salem. The event is free and open to the public.

Senator Smith Steps Up for Veterans' Home Loans Again

On July 21, U.S. Senator Gordon Smith introduced the American Veterans Homeownership Act of 2005 (S. 1449), which would amend existing federal law to allow the use of low interest rate mortgage bonds for making home loans to veterans.

While Qualified Veterans Mortgage Bonds (QVMBs) are currently used by the Oregon Department of Veterans' Affairs (ODVA) to make home loans to veterans, certain restrictions apply. Successful passage of S. 1449 and the subsequent removal of those restrictions would mean a reliable source of funding for home loans for veterans.

Introduction of S. 1449 follows the introduction of H.R. 2952 in June by Representative Paul Ryan of Wisconsin (for himself and Representative Wally Herger of California). Both Wisconsin and California are among the five states that have home loans for veterans; Alaska, California, Oregon, Texas, and Wisconsin. Additional co-sponsors are needed for both S. 1449 and H.R. 2952. It is hoped that all of Oregon's congressional delegation will sign on as co-sponsors. (Additional congressional delegates may have signed on as co-sponsors after this publication went to print).

While the (QVMB) issue has been brought before Congress several times over the last few years, efforts have not met with success. A continued failure to remove the restriction would result in a current funding source for veterans' home loans ceasing to exist. Ultimately, that means fewer home loans for veterans and then, eventually none from that particular funding source - a big concern for veterans and ODVA since other available funding sources for state veterans' home loans are very limited.

Jim Willis, ODVA Director, commends Senator Smith's commitment to veterans, "Oregon veterans are fortunate to have a strong advocate in Senator Smith. The Senator introduced similar legislation during the 108th Congress. His willingness to step up and continue the battle in the 109th Congress is greatly appreciated."

- In Memoriam - Earl MacPherson

On July 10th, 2005, Earl MacPherson passed away in Medford. Earl served in the U.S. Marine Corps during World War II from 1942 until 1946. Earl reenlisted in the Marines, served in Korea and went on to retire from the Corps as a Master Gunnery Sergeant. He then joined the Oregon National Guard where he achieved the rank of Sergeant Major and retired in 1984. From there Earl joined the State Defense Force retiring in 2002 at the rank of Major. Earl MacPherson wore the uniform of his nation's armed forces for nearly 60 years.

As a Veterans Advocate over the past 35 years, he served as a legislative liaison for veterans, helped organize the Veteran Stand Downs at White City, was a key force behind the annual Veterans Day Parade in Medford, was the Chairman of the Jackson County Veterans Allied Council and was Chair of the Family Support Services of Medford American Legion Post 15. He also served as VFW State Chairman for Homeless Veterans. Earl was a member of the Board of Directors of the Veterans Memorial Park in Medford as well as serving as Veterans Affairs Volunteer Service (VAVS) Chairman of the Marine Corps League at the VA Domiciliary in White City.

Earl is survived by his wife Lyn, son Ronald, daughters Laura Kathleen and Adrienne, and his stepson Robert.

At his memorial service on July 29th, Earl's family was presented with the National Colors, the Oregon State Flag, the Governor's Commendation Award, the ODVA Director's Distinguished Service Award and the Oregon National Guard's Commendation Medal.

Earl's service and contributions to his community, state and nation are an example for all. He will be missed.



VA Celebrates 75th Anniversary



The U.S. Department of Veterans Affairs (VA) celebrated its 75th anniversary in 2005, and on July 21, the Southern Oregon Rehabilitation Center and Clinics (SORCC) held a kick-off event to honor the agency's mission nationally and in Oregon.

During its Diamond Jubilee, the White City facility commemorated the 60th anniversary of World War II on Aug. 24. Emphasizing their Camp White roots, the VA's SORCC dedicated its World War II Garden and the Blue Star Memorial Marker.

Guest appearances by Oregon Medal of Honor recipient Bob Maxwell and former Tuskegee Airman, Bill Holloman were punctuated with a flyover by F-15s from the Oregon Air National Guard's 173rd Fighter Wing in Klamath Falls, and a 21-gun salute by the Army Guard's 1/186 Infantry Battalion in Medford. After the ceremonies, a Freedom Lawn concert served as a tribute to all American soldiers.

Oregon Department of Veterans' Affairs Director Jim Willis attended the 75th anniversary event. He said both celebrations should remind all Americans about the important service and dedication the VA's medical staffs have been providing America's veterans for 75 years.

"We're also reminded of the debt we owe to these caring medical professionals," Willis said. "In recalling the 60 years since the end of World War II, we remember the many sacrifices made by those in the profession of arms—the men and women who served and died in that war."

President Herbert Hoover created the single federal agency in 1932 to provide benefits for America's veterans. The formation is rooted in President Abraham Lincoln's 1865 promise to "care for him who shall have borne the battle, and for his widow and his orphan."

Today, the VA is the federal government's second largest Cabinet department, responsible for a nationwide system of health care services, benefit programs, and national cemeteries for America's veterans and dependants.

Governor Kulongoski Swears in New Adjutant General

In an outdoor ceremony near his capitol office, July 1, Governor Ted Kulongoski officially swore in Major General Raymond Rees as Oregon's new Adjutant General. This marked the first time an Adjutant General for Oregon has been appointed to the position for a third term. Rees' earlier tenures in the

position were May 1987 to June 1991 and August 1994 to March 1999.

To a crowd of several dozen supporters, that included members of Oregon's congressional and legislative bodies, Rees said, "The Guard is meeting the test in Kabul, Kirkuk as citizen soldiers and airmen while responding to the war on terror and the needs of Oregon."

Kulongoski praised the outgoing acting Adjutant General, Brigadier General Ray Byrne, "We all owe a great debt of gratitude to General Byrne. Thank you very much for your dedicated service as adjutant general."

Following the ceremony, more than 200 well-wishers gathered at a reception at the Anderson Readiness Center in Salem.

Oregon Veterans Medal at 25th National Wheelchair Games

Four disabled Oregon veterans competed in the 25th National Veterans Wheelchair Games, June 27- July 1 in Minneapolis, Minnesota, and all four earned medals. With nearly 500 athletes from 45 states, Puerto Rico, and Great Britain, these games are the largest annual wheelchair sports event in the world. All athletes are military veterans who use wheelchairs due to spinal cord injuries, certain neurological conditions, orthopedic amputations or other disabilities.

Portland's Don Lambert, a Marine Corps Vietnam veteran who was wounded in combat, earned four Open Division medals including a Gold in the Chair 220 (Hand Controls). Lambert, a quadriplegic, also garnered three Silver medals in Motorized Slalom (Hand Controls), Motorized Rally, and Bowling-Ramp (Hand Controls).

The staff of the *VETS NEWS* would like to offer this clarification and also sends our sincere apologies to all our readers, especially those who have received either the Distinguished Service Cross (DSC) or the DFC as a result of their military service. Also we apologize to Mike Scorcio, noting the error occurred as a result of our misinterpretation of information and was not due to any fault of his own.

To clarify:

The Distinguished Flying Cross (DFC) is the eighth highest military award presented by the following branches of the Armed Forces: Army, Navy, Marine Corps, and the Air Force. It is the tenth highest award presented by the U.S. Coast Guard.

In the article, the DFC was confused with the DSC, which is the second highest award presented by the Army, second only to the Medal of Honor.

Camp Adair Restoration Project Update

In the March/April 2005 issue of the *VETS NEWS*, we published an article regarding restoration of the Historical Markers at Camp Adair, located some 13 miles north of

the city of Corvallis on Highway 99W.


Previously, the cost for restoration of the Camp Adair Historical Markers was estimated between \$20,000 and \$30,000. The Council now finds the cost to be more in the

DoD Proposes to Remove F-15s from Portland ANG Base

Oregon's top elected officials, on June 17, urged members of the Defense Base Realignment and Closure Commission (BRAC) to abandon plans to shift most of Oregon's F-15 fighter jets from Portland Air National Guard Base to other states. Governor Ted Kulongoski and members of Oregon's Congressional delegation joined leaders from the Air Guard's 142nd Fighter Wing (FW) in testifying at the regional BRAC hearing in Portland.

On May 13, Defense Secretary Donald H. Rumsfeld submitted his BRAC recommendations that 33 military installations be closed and 29 realigned out of a total of 318 bases, including the air defense mission assigned to Portland's 142nd Fighter Wing. Eleven additional bases were identified in July by the commission for closure or realignment and have been added to the secretary's list.

During the Portland hearing Governor Kulongoski indicated to the two visiting commission members and BRAC Chair Anthony Principi, "Our enemies will look for the weakest link and the weakest link will be in the Northwest."

Oregon Senator Gordon Smith said the plan to move Oregon's fighters jets assigned to the 142nd FW would leave just a handful of planes to defend "a target-rich environment," citing the dams along the Columbia River, the

Umatilla Army depot and the Hanford Nuclear site in Washington.

In a letter dated Aug. 2, Kulongoski told Rumsfeld that he will file a lawsuit, joining Illinois, Pennsylvania and other states, if plans move forward to transfer Oregon's aircraft and personnel from the Portland Air Base. The governor said he questioned federal authority to move National Guard members while they are under the authority of the state. The National Guard is under federal control only if activated by the president.

Principi has said that he is working to save as many of the Air Guard units as possible.

All bases identified for possible realignment or closure will be reviewed before a final commission vote on all BRAC-identified installations in late August. The nine-member BRAC commission panel is obligated to send its recommendations to the President by Sept. 8. The President will have until Sept. 23 to accept or reject the recommendations. Congress will then have 45 days to accept or reject the President's recommendations.

The Defense Department will be obligated to act on all congressionally-approved recommendations.

Oregon Air Show to Admit Veterans Free on Sept. 11

The Oregon International Air Show will honor all veterans and active duty military personnel by providing free admission to the show's final performance on Sunday, September 11, at the Hillsboro Airport, 3355 NE Cornell Road, Hillsboro, Oregon.

Additionally, all police, fire and emergency medical (EMS) personnel will be allowed free admission. Except for veterans, all others must be in uniform to be admitted free of charge.

This year, the annual air show is featuring the U.S. Air Force Thunderbirds and U.S. Army Golden Knights, vintage aircraft, and other aerial demonstration teams. For the Sunday final performance show, gates open at 9 a.m. with the show beginning at 10:30 a.m. For additional information including other show times and tickets, contact the Airshow's Main Office at 503-629-0706.

Living History Days Planned at Oregon High Schools

This year is the 60th anniversary of the end of World War II and Milwaukie will be honoring veterans who served in that war.

"We especially want to invite Oregon National Guard members, reservists, and other military personnel who have recently returned from serving in Iraq," said Ken Buckles, the executive director of Remembering America's Heroes.

At most schools veterans volunteer to share their stories with students and answer questions. New Medicare Prescription Drug Coverage

Beginning January 1, 2006, new Medicare prescription drug plans will be available to all people with Medicare. Here are the basic facts about the program:

- Medicare prescription drug plans will provide insurance coverage for prescription drugs (brand name and generic). Like other insurance, people will pay a monthly premium (generally about \$37/month in 2006) and a yearly deductible (up to the first \$250 in 2006). You will also pay a share of the cost of your prescriptions. Costs will vary depending on the drug plan chosen.
- In order to get the coverage, people must enroll in a Medicare prescription drug plan between
 November 15, 2005 May 15, 2006.
 If you join by December 31, 2005, coverage will begin January 1, 2006.
- If an eligible person doesn't join a plan by May 15, 2006, and you don't have a drug plan that covers as much or more than a Medicare prescription drug plan, your premium will increase 1% per month for each month you enroll after May 15, 2006.

So, even if you don't use a lot of prescription drugs now, you should consider joining a plan.

- Financial assistance is available to help pay for the coverage for people with limited income: individuals or married couples with income less than 150% of poverty.
- Drug coverage from TRICARE, the U.S. Department of Veterans Affairs (VA), or the Federal Employee Health Benefits Program (FEHB):
 As long as you still qualify, your TRICARE, VA, or FEHB prescription drug coverage is not changing. You should contact your benefits administrator or FEHB insurer for information about your TRICARE, VA, or FEHB coverage before making any changes. It will almost always be to your advantage to keep your current coverage without any changes.

If you lose your TRICARE, VA, or FEHB coverage and you join a Medicare drug plan after May 15, 2006, in most cases you won't have to pay a penalty, as long as you join

within 63 days of losing TRICARE, VA, or FEHB coverage.

What should individuals receiving Medicare do?

- Apply for financial assistance if you think you might qualify. Contact the Social Security Administration: www.ssa.gov or 1-800-772-1213.
- Read the *Medicare & You 2006* handbook that will be sent this fall. It will list the Medicare prescription drug plans available in your area. Information is also available at www.medicare.gov or by calling 1-800-MEDICARE (1-800-633-4227).
- Contact the Senior Health Insurance Benefit Assistance (SHIBA) Program to get local information: 1-800-722-4134.
- Look for notices about presentations in your local communities over the next few months.

USS Ranger May Move to Portland

The USS Ranger Museum Foundation is making efforts to bring the World's only Super Carrier to the Port of Portland. The non-profit Foundation was established in

March 2001 for the specific purpose of acquiring, preserving, and placing into operation the retired aircraft carrier USS Ranger (CV-61) as a floating centerpiece of an Aircraft Carrier Museum. The Carrier, which currently resides at the Puget Sounds Naval Shipyard in Bremerton, WA, became available for donation in March 2004.

Federal Legislation Would Protect Purple Heart

Federal legislation (H.R. 3352) introduced July 22 in the U.S. House of Representatives would expand a federal law to allow prosecution of anyone who falsely claims to have earned a military medal or a Purple Heart. The Stolen Valor Act of 2005 passed in the Senate on July 28.

Congress found that changes to current federal law are necessary to allow law enforcement personnel to protect the reputation and meaning of these medals. Congress further found that fraudulent claims surrounding receipt of the Medal of Honor, the Distinguished-Service Cross, the Air Force Cross, the Navy Cross, the Purple Heart, or any other medal or decoration awarded by Congress or the armed forces damages the reputation and meaning of

these medals. Introduction of The Stolen Valor Act of 2005 comes on the heels of a new summer movie release in which actors pretend to be Purple Heart recipients to win the affections of attractive bridesmaids. An Internet website promoting the movie includes a fake Purple Heart cut-out.

Special Agent Thomas Cottone Jr., of the FBI enforces a current federal law that prohibits wearing, manufacturing, buying, selling or trading a Medal of Honor. He challenged the movie's producer to go to Walter Reed Hospital, walk through the ward, and see if he still wants to print out fake Purple Hearts.

"Talk to some of the people who don't have legs anymore and see how funny they think that movie is," said Cottone."

Brain Cancer May Be Linked to Gulf War Service

In March 1991, Army soldiers destroyed two large Iraqi weapons caches at Khamisiyah, Iraq. In October 1991, March 1992, May 1992, and May 1998, representatives from the United Nations Special Commission inspected Khamisiyah and detected the existence of sarin and cyclosarin in both intact and damaged rockets in the bunker and pit.

The military commissioned the Institute of Medicine to conduct a study for the purpose of investigating whether U.S. Army Gulf War veterans, who were potentially exposed to nerve agents during the March 1991 weapons demolitions at Khamisiyah, are at increased risk of cause specific mortality.

The results of the study indicate the risks of most disease-related mortality were similar for exposed and unexposed veterans. However, exposed veterans had an increased risk of brain cancer deaths. The risk of brain

cancer death was larger among those exposed two or more days than those exposed one day when both were compared separately to all unexposed veterans.

The study concludes that exposure to chemical munitions at Khamisiyah may be associated with an increased risk of brain cancer death. Researchers note that additional research will be required to confirm that finding.



- In Memoriam -General Westmoreland

Retired General William C. Westmoreland, a hard charging soldier who commanded U.S. ground forces in Vietnam, died on July 18 at the age of 91. Westmoreland died at the Bishop Gadsden retirement home in Charleston, South Carolina, where he had lived with his wife for several years.

His military career began at The Citadel where he attended for one year before transferring to the U.S. Military Academy at West Point. In 1936, he graduated from West Point, where he later became the Academy's superintendent in 1960.

Westmoreland served in North Africa, Sicily and Europe during World War II. He fought with the 9th Infantry Division at Normandy. By July 1944, he had attained the rank of colonel at age 30. As commander of the 34th Field Artillery Battalion, he earned the loyalty and respect of his troops for joining them in battle rather than remaining behind the lines at a command post.

He was promoted to brigadier general during service in the Korean War and later served in the Pentagon. By 1958, he was a major general and commanded the 101st Airborne Division.

Westmoreland was selected by President Lyndon B. Johnson in 1964 to head U.S. Military Assistance Command and by 1968 he was commanding a force of more than 500,000. In June 1968 he left Vietnam to serve as the Army's Chief of Staff, a position he held until retiring in 1972.

"Few people have had a field command as long as I did," Westmoreland told the Associate Press in 1985. "I was there seven days a week working 14 to 16 hours a day. I was a soldier and carried out the mission given to me by the commander in chief, the president of the United States. I have no apologies, no regrets. I gave my very best efforts."
