## OSFM changes continue to produce results

n our continuous efforts to improve our service to Oregonians, members of the Oregon fire service, and other stakeholders, OSFM staff find opportunities to consolidate program efforts for increased efficiency and mission alignment.

In the last few years, we've consolidated management and training of the incident management and hazardous materials teams and urban search and rescue task force. We've restructured the statewide process to help community leaders develop local emergency planning committees. We've initiated competency standards and training to improve code enforcement consistency. We've worked with staff from the Bureau of Alcohol, Tobacco, Firearms and Explosives to remove duplicate regulatory burdens on OSFM and members of Oregon's explosives industry.

The time is right for another move. We are shifting our Juvenile Firesetter Intervention program from Community Education Services to Fire and Life Safety Services. This change will improve coordination of similar functions with our fire service partners, deputy state fire marshals and State Police Arson unit.



### Oregon gets new Fire Protection District

he Three Rivers Rural Fire Protection District located west of Madras between the Metolius and Deschutes arms of Lake Billy Chinook became Oregon's newest fire district on June 30, 2008.

Seventy percent of voters approved the new district during a May special election. The Board of Directors are: President Gary Sweet, Vice President Larry Penrod, Secretary Glennys Lindsay, Treasurer Lorraine Abney, and Director Brian Brophy. The Three Rivers RFPD fire chief is Art Klingsporn.

Three Rivers Landowners Association President Don Colfels, and local property owner Joe Parrott worked with Chief Art Klingsporn to form the district.

Three Rivers RFPD had existed as a private fire department for the past 25 years. The district operates a single station with a 30-member volunteer force.

## Juvenile Firesetter Intervention Specialist 1 Training

This no-cost, 16-hour course includes an overview of Oregon's juvenile firesetter intervention program, including: policies, procedures and laws, child development and communication, practice using the *Juvenile with Fire* screening tool, intervention options including educational strategies and referral procedures, as well as networking steps and data collection.

The class also provides students with the training to complete the task book required by the Department of Public Safety Standards and Training for National Fire Protection Association 1035 certification as Juvenile Firesetter Intervention Specialist I in Oregon.

### Fire service reminded about mandatory hazardous materials incident reporting

The Office of State Fire Marshal (OSFM) reminds members of the Oregon fire service that emergency service personnel responding to a hazardous materials incident are required to file a report with OSFM within ten working days of the incident. Reporting is required per Oregon's Community Right-to-Know and Protection Act, ORS 453.342 and OAR 837-085-0380.

Information from hazardous materials incident reports provides important data to emergency responders, planners, and the general public. Incident reports also demonstrate the need for hazardous materials response capabilities. Submitting a timely report is essential for public safety, responder safety, and cost recovery.

The fire department or state regional hazmat team having jurisdiction over the incident is responsible for completing and submitting the report. For reporting purposes, a hazardous materials incident is defined as 'the threatened or actual injury to a human, wildlife, domestic animal or the environment, or any property loss resulting from a hazardous substance release.'

There are three exceptions that do not require a written incident report.

- Motor fuels spilled from a vehicle in quantities less than 42 gallons (unless fuel enters a waterway, endangers public safety or immediate or surrounding environment including ground water);
- 2. sewage overflows; or
- 3. structure fires or other emergencies where hazardous substances are involved as exposures only and did not contribute to the cause of the emergency or to injury or death (as with any fire, a Form 10 is required).

## Sprinkler saves residents in apartment complex - twice

R esidents of the Harvard Meadows apartment complex in Woodburn were saved from potential disaster in two separate incidents by fire sprinklers that activated when cooking oil ignited on kitchen stovetops.

In each incident, a single sprinkler head activated, extinguishing the fires with only minor damage to cabinets and minimal water damage to the carpeting.

"Both of these situations could have had tragic outcomes," said Woodburn Fire Marshal Paul Iverson. "This is continued proof of the effectiveness and life saving capacity of residential fire sprinklers. A little water damage is a small price to pay compared to what could have happened."

### OSFM seeks examples of fireworks prevention and enforcement efforts

# Interest sought for fireworks training in Oregon

A lbany Fire and the Office of State Fire Marshal are looking for members of the Oregon fire service interested in attending a proposed three-day workshop in May 2009 for code officials who enforce fireworks laws.

Training is delivered by Fireworks Education & Safety Training, Inc. (F.E.S.T.), a non-profit corporation. F.E.S.T. provides education and instruction to fire and law enforcement personnel on the safe use of pyrotechnics, inspection practices, and application of codes and regulations.

The training covers the basics of pyrotechnic safety and uses the same criteria used to teach and certify pyrotechnic operators.

Subjects covered in the three-day class include:

- Outdoor public displays distance requirements, types of devices, applications, Oregon State Fire Marshal (OSFM) permit requirements, site plans, inspection practices and more per NFPA 1123 guidelines.
- Proximate indoor pyrotechnics distance requirements, applications, OSFM permit requirements, site plans, inspection practices and more per NFPA 160 guidelines.
- Demonstrations of outdoor fireworks, indoor pyrotechnic devices, and flame effects devices are planned. Permit requirements will follow NFPA 1123, 1126 and 160 guidelines.

Cost for the course is \$320 for all three days. Food and lodging is not included.

The level of interest from Oregon fire service members will determine if this course will take place in the Albany area in 2009. If you or your department are interested in attending, contact Bob Brooks of Albany Fire at 541-917-7726.

## Update on firefighter grants

wo Oregon fire departments received funding awards during rounds seven and eight from the 2008 Assistance to Firefighters Grant (AFG) program. Award announcements are released every Friday through the program period.

This year 10 Oregon fire departments have received \$1,352,551 in AFG funding, including funding of three vehicles.

In previous years, Oregon fire department project requests from the AFG program resulted in the following success rates based on the number of applications submitted:

2007 - 202 Oregon departments filed applications, 25% of applicants were funded

2006 - 193 Oregon departments filed applications, 36% of applicants were funded

2005 - 204 Oregon departments filed applications, 39% of applicants were funded

2004 - 206 Oregon departments filed applications, 47% of applicants were funded

Reasons for the downward trend in successful awards are unclear.

From 2004-2008, Oregon departments ranked 34th nationally in applications submitted. During this period, requests totaled more than \$152 million. The average amount requested for application projects was \$147,162.

### **Description:**

- Synonyms: Hexahydrobenzene; hexamethylene; hexanaphthene
- Clear colorless liquid with faint ether-like odor
- Acute Health Hazard; flammable
- CAS No.: 110-82-7
- Flash point: 0° F
- LEL: 1.3%; UEL: 8.0%
- DOT: Class 3 Flammable Liquid
- UN/NA: 1145

### **NFPA Information:**

- Health: 1
- Flammability: 3
- Reactivity: 0

### **Uses and Occurrences:**

- Produced by reacting benzene with hydrogen
- Used in laboratory analysis
- Used as a laboratory standard
- Raw material for production of adipic acid and caprolactam used in nylon manufacturing

### **Reactivity and Fire Risk:**

- May form explosive vapor-air mixture above flash point
- Stable at room temperature in sealed container
- Vapors may travel considerable distance to source of ignition and flash back
- Contact with strong oxidizers may cause fire
- Sensitive to static discharge
- Incompatibles include: strong oxidizers

### **Health Hazards:**

- OSHA PEL: 300 ppm TWA
- Irritating to the eyes and skin with redness and pain
- Irritating to the respiratory tract with coughing and shortness of breath
- May cause chest pain and edema
- Ingestion may result in abdominal pain and nausea
- May be toxic to kidneys and liver

### **Personal Protective Equipment:**

- Emergency responders should use Self-Contained Breathing Apparatus and full protective clothing
- Use local exhaust ventilation or other engineering controls to stay within PELs
- Wear impervious protective clothing, splash goggles and face shield
- Use an approved respirator if appropriate

### Inspection and Storage Tips:

- Keep container tightly closed
- Keep container in a cool, dry, ventilated area
- Store away from all sources of ignition
- Protect against physical damage
- Store away from incompatibles
- Containers should be bonded and grounded for transfers to avoid static sparks
- Use non-sparking tools and equipment
- Use explosion proof ventilation

### 2007 Oregon Fire Code:

- Flammable liquid Class 1B
- Maximum Allowable Quantities (MAQ) per S occupancy control area:
  - Unprotected by sprinklers or approved storage cabinets: 120 gallons
  - In sprinklered building, not within approved storage cabinets: 240 gallons
  - In unsprinklered building, within approved storage cabinets: 240 gallons
  - In sprinklered building, within approved storage cabinets: 480 gallons
  - For storage of quantities exceeding the MAQ for S occupancy, facility must conform to H-2 or H-3 occupancy requirements

### **Incident Reporting and Information:**

- There are three facilities in Oregon currently reporting cyclohexane on the Hazardous Substance Information Survey
- There has been one hazardous materials incident reported in Oregon since 1986 involving cyclohexane
