## Arizona Cattle on Feed Inventory Down 3 Percent From Last Year

On February 1, 2007, Arizona had 334,000 head of cattle on feed for the slaughter market, down 12,000 head from a year ago, but unchanged from last month. Placements totaled 33,000 head during January, 6,000 head less than a year ago. During January, 32,000 head were marketed, up 6,000 head from last year.

On February 1, 2007, California had 540,000 head of cattle on feed for the slaughter market, down 10,000 head from last year, and down 10,000 head from last month. Placements totaled 64,000 head during January, down 7,000 head from last year. During January, 72,000 head were marketed, up 10,000 head from last year.

Cattle and calves on feed for slaughter market in the United States for feedlots with capacity of 1,000 or more head totaled 11.7 million head on February 1, 2007. The inventory was 3 percent below February 1, 2006 but 3 percent above February 1, 2005.

Placements in feedlots during January totaled 1.69 million, 23 percent below 2006 and 10 percent below 2005. Net placements were 1.59 million. This is the second lowest placements for the month of January since the series began in 1996. During January, placements of cattle and calves weighing less than 600 pounds were 320,000, 600-699 pounds were 390,000, 700-799 pounds were 545,000, and 800 pounds and greater were 435,000.

Marketings of fed cattle during January totaled 1.84 million, up 2 percent from 2006 and up 4 percent from 2005.

Other disappearance totaled 97,000 during January, 17 percent above 2006 and 33 percent above 2005.

### January Milk Production Up 1.4 Percent

**Milk production** in the 23 major States during January totaled 14.2 billion pounds, up 1.4 percent from January 2006. December production, at 14.0 billion pounds, was up 2.8 percent from December 2005.

**Production** per cow in the 23 major States averaged 1,719 pounds for January, 8 pounds above January 2006.

**The number of cows** on farms in the 23 major States was 8.28 million head, 81,000 head more than January 2006, and 3,000 head more than December 2006.

## **United States Honey Production Down 11 Percent**

Honey production in 2006 from producers with five or more colonies totaled 155 million pounds, down 11 percent from 2005. There were 2.39 million colonies producing honey in 2006, down 1 percent from 2005. Yield per colony averaged 64.7 pounds, down 11 percent from the 72.4 pounds in 2005. Colonies which produced honey in more than one State were counted in each State where the honey was produced, therefore yields per colony may be understated. Colonies were not included if honey was not harvested. Producer honey stocks were 60.5 million pounds on December 15, 2006, down 3 percent from a year earlier. Stocks held by producers exclude stocks held under the commodity loan program.

**Arizona** honey production totaled 1.95 million pounds, 8 percent more than in 2005. Honey producing colonies, at 30,000, are down 6,000 from a year ago. Yield per colony was 65 pounds, compared to 50 pounds in 2005.

## **Honey Prices Up 14 Percent**

Honey 2006 prices increased to 104.2 cents, up 14 percent from 91.8 cents in 2005. Prices are based on retail sales by producers and sales to private processors and cooperatives. State level honey prices reflect the portions of honey sold through retail, co-op, and private channels. Honey prices for each color class are derived by weighting quantities sold for each marketing channel. Honey prices for 2006 were up from the previous year for all color class totals.

**Arizona's** average price per pound was 139 cents, up 34 cents from 2005. Value of production, at 2.71 million dollars, was up 43 percent from a year earlier.

### **Red Meat Production Sets Record High for January**

Commercial red meat production for the United States totaled 4.09 billion pounds in January, up 5 percent from the 3.90 billion pounds produced in January 2006.

Beef production, at 2.16 billion pounds, was 6 percent above the previous year. Cattle slaughter totaled 2.80 million head, up 6 percent from January 2006. The average live weight was up 5 pounds from the previous year, at 1,290 pounds.

Veal production totaled 14.3 million pounds, 21 percent above January a year ago. Calf slaughter totaled 74,300 head, 34 percent above January 2006. The average live weight was down 31 pounds from last year, at 324 pounds.

Pork production totaled 1.90 billion pounds, 4 percent above from the previous year. Hog kill totaled 9.37 million head, 5 percent above January 2006. The average live weight was down 2 pounds from the previous year, at 271 pounds.

Lamb and mutton production, at 15.1 million pounds, was 7 percent below January 2006. Sheep slaughter totaled 216,700 head, 3 percent below last year. The average live weight was 139 pounds, down 5 pounds from January a year ago.

## February Farm Prices Received Index Increased 3 Points From Last Month

The preliminary All Farm Products Index of Prices Received by Farmers in February, at 127 percent, based on 1990-92=100, increased 3 points (2.4 percent) from January. The Crop Index is up 6 points (4.6 percent) and the Livestock Index increased 3 points (2.6 percent). Producers received higher commodity prices for corn, broilers, soybeans, and hogs. Lower prices were received for broccoli, lettuce, eggs, and oranges. The overall index is also affected by the seasonal change based on a 3-year average mix of commodities producers sell. Increased average marketings of dairy, cattle, broilers, and strawberries offset decreased marketings of corn, soybeans, wheat, and cotton.

The preliminary All Farm Products Index is up 14 points (12 percent) from February 2006. The Food Commodities Index, at 127, increased 3 points (2.4 percent) from last month and increased 11 points (9.5 percent) from February 2006.

#### **Prices Paid Index Increased 1 Point**

The February Index of Prices Paid for Commodities and Services, Interest, Taxes, and Farm Wage Rates (PPITW) is 153 percent of the 1990-92 average. The index is up 1 point (0.7 percent) from January and 6 points (4.1 percent) above February 2006. Higher prices in

February for complete feeds, feed grains, mixed fertilizers, and LP gas more than offset lower prices for feed concentrates, diesel fuel, herbicides, and tractors.
