Changes in Calculations for the BLS Employer Costs for Employee Compensation Data, March 2007

The BLS Employer Costs for Employee Compensation (ECEC) series produces quarterly estimates of employer costs for wage, salaries, and benefits. Data for the ECEC are collected from employers as part of the BLS National Compensation Survey (NCS). Other NCS products include the Employment Cost Index (ECI), local and national wage estimates by occupation, and data on the incidence and provisions of employee benefits. Changes to the estimation procedure for the December 2006 ECEC, released in March 2007, were introduced to standardize the estimation calculations among all NCS products.

The specific ECEC calculation change being introduced with the December 2006 data is known as the *benchmark* calculation. Benchmarking is the process of adjusting the weight of each establishment in the survey to match the distribution of employment by industry at the reference period. Because the sample of establishments used to collect ECEC data was chosen over the past several years, establishment weights reflect their employment when selected. The benchmark process updates that weight based on current employment.

The new benchmark factor being introduced into the ECEC uses data from two BLS programs: the Quarterly Census of Employment and Wages (QCEW) and the Current Employment Statistics (CES) program. Combined, these programs provide the appropriate industry coverage and currency of data needed to match the ECEC. The NCS sample is drawn from the QCEW.

The ECEC benchmark process was also refined to account for establishments that do not include any occupations. Typically, such establishments only include an owner or family members. With this enhancement, these establishments are now treated consistently with other NCS programs.

The benchmark factor for a given ECEC industry and ownership group is calculated as follows:

$$Benchmark\ factor_i = \frac{Populationemployment_i}{\sum ECEC\ weight_i}$$

Where:

Population employment_i is the current employment for the industry and ownership group from the QCEW and CES

ECEC weight_i is the original weight of an occupation within the industry and ownership group from the ECEC adjusted for nonresponse and other sub-sampling situations that occurred during data collection. The summation is over all ECEC sample occupations within the industry and ownership group.

i = the industry and ownership group

Benchmark factors are produced for groupings of industry and ownership, as described on the following table. The change in the ECEC benchmark procedure had a negligible effect on estimates and estimated variances.
