**Michael W. Schragg Post Office Building:** Senate passed H.R. 3446, to designate the facility of the United States Postal Service located at 202 East Michigan Avenue in Marshall, Michigan, as the “Michael W. Schragg Post Office Building”, clearing the measure for the President. **Pages S14656–57**

**Wallace S. Hartsfield Post Office Building:** Senate passed H.R. 3572, to designate the facility of the United States Postal Service located at 4320 Blue Parkway in Kansas City, Missouri, as the “Wallace S. Hartsfield Post Office Building”, clearing the measure for the President. **Pages S14656–57**

**John “Marty” Thiels Southpark Station:** Senate passed S. 2272, to designate the facility of the United States Postal Service known as the Southpark Station in Alexandria, Louisiana, as the John “Marty” Thiels Southpark Station, in honor and memory of Thiels, a Louisiana postal worker who was killed in the line of duty on October 4, 2007. **Pages S14656–57**

**National Methamphetamine Awareness Month:** Senate agreed to S. Res. 366, designating November 2007 as “National Methamphetamine Awareness Month”, to increase awareness of methamphetamine abuse. **Page S14657**

**Soviet Jewish Freedom and Freedom Sunday Rally for Soviet Jewry:** Senate agreed to S. Res. 367, commemorating the 40th anniversary of the mass movement for Soviet Jewish freedom and the 20th anniversary of the Freedom Sunday rally for Soviet Jewry on the National Mall. **Pages S14657–58**

**San Francisco Bay Oil Spill Volunteers:** Senate agreed to S. Res. 385, honoring those who have volunteered to assist in the cleanup of the November 7, 2007, oil spill in San Francisco Bay. **Page S14658**

**Senate Legal Counsel:** Senate agreed to S. Res. 386, to authorize testimony and legal representation in State of Nebraska v. Pamir J. Safi. **Page S14658**

**Jordan River and the Dead Sea:** Senate agreed to S. Res. 387, expressing the sense of the Senate regarding the degradation of the Jordan River and the Dead Sea and welcoming cooperation between the peoples of Israel, Jordan, and the Palestinian Authority. **Pages S14658–59**

**Great White Fleet Anniversary:** Senate agreed to S. Con. Res. 55, commemorating the centennial anniversary of the sailing of the Navy’s “Great White Fleet”, launched by President Theodore Roosevelt on December 16, 1907, from Hampton Roads, Virginia, and returning there on February 22, 1909. **Pages S14659–60**

**Burma and Democracy:** Senate agreed to S. Con. Res. 56, encouraging the Association of Southeast Asian Nations to take action to ensure a peaceful transition to democracy in Burma. **Page S14660**

ments to commissions, committees, boards, conferences, or interparliamentary conferences authorized by law, by concurrent action of the two Houses, or by order of the Senate. **Page S14655**
