

SUBJECT: Conflict of Interest Waiver for Howard McLeod,  
Pharm.D.

I am writing to request a waiver for Howard McLeod, Pharm.D., a consultant to the Center for Drug Evaluation and Research, from the conflict of interest prohibitions of 18 U.S.C. §208(a). The appointing official may grant waivers under 18 U.S.C. §208(b)(3) where "the need for the individual's services outweighs the potential for a conflict of interest created by the financial interest involved" and where the individual has made a disclosure of the financial interests at issue. We have determined that you are the appointing official for purposes of section 208. Therefore, you have the authority to grant Dr. McLeod a waiver under section 208(b)(3).

Section 208(a) prohibits Federal executive branch employees, including special Government employees, from participating personally and substantially in matters in which the employee or his employer has a financial interest. Since Dr. McLeod is a special Government employee, he is under a statutory obligation to refrain from participating in any deliberations that involve a particular matter having a direct and predictable effect on a financial interest attributable to him or his employer.

The functions of the Pharmaceutical Science Advisory Committee, as stated in its Charter, are to provide advice on scientific and technical issues concerning the safety, and effectiveness of human generic drug products for use in

the treatment of a broad spectrum of human diseases, and as required, any other product for which the Food and Drug Administration has regulatory responsibility, and make appropriate recommendations to the Commissioner of Food and Drugs. The Committee may also review Agency sponsored intramural and extramural biomedical research programs in support of FDA's generic drug regulatory responsibilities.

Dr. McLeod has been asked to give a presentation on pharmacogenetics as it relates to warfarin and answer questions related to his presentation at the Clinical Pharmacology Subcommittee of the Advisory Committee for Pharmaceutical Science. The Subcommittee will discuss current evidence related to the pharmacogenetics of warfarin as a potential basis for label updates.

Dr. McLeod has advised the Food and Drug Administration (FDA) that he has a financial interest that could potentially be affected by his participation in the matter described above. Dr. McLeod is a co-investigator with a team from the Washington University School of Medicine, currently involved in a grant from the National Heart, Lung and Blood Institute (NHLBI), to determine how clinical and genetic factors predict a patient's response to therapy. Based on a 400 patient, pilot study, they will use the data to refine and validate an algorithm developed for determining the right dose of blood thinner warfarin.

Potential label updates with regards to the pharmacogenetics of warfarin is the issue before the Clinical Pharmacology Subcommittee.

As a consultant presenting to the Clinical Pharmacology Subcommittee, Dr. McLeod could potentially become involved in matters that could affect his employer's financial interest. Under section 208, he is prohibited from participating in such matters. However, as noted above, you have the authority under 18 U.S.C. §208(b)(3) to grant a limited waiver permitting Dr. McLeod to participate in such matters, as you deem appropriate.

For the following reasons, I believe that it would be appropriate for you to grant a limited waiver to Dr. McLeod that would allow him to make a presentation to the committee regarding pharmacogenetics as it relates to warfarin and answer questions related to his presentation. Under the terms of this limited waiver, Dr. McLeod will not participate in the committee's discussions, deliberations, or voting.

First, it is important to consider that Dr. McLeod's conflict is mitigated by the fact that FDA has decided to limit his participation. Given the need for his expertise, Dr. McLeod will give a presentation to the subcommittee and answer questions directly related to his presentation. He will not be allowed to participate in any of the committee's discussions, deliberations, or voting with respect to the current evidence related to the pharmacogenetics of warfarin as a potential basis for label updates.

Although the study that Dr. McLeod is involved in is related to the issue before the committee, it is important to note that the study is not funded by the manufacturers or any other commercial entity, but rather it is funded by an institute of the National Institutes of Health. The fact that the source of funding is a federal agency, rather than a commercial entity, minimizes the likelihood or appearance that Dr. McLeod is subject to influence by the manufacturers of warfarin or their competitor's. Thus, the potential for an actual or apparent conflict of interest is minimal.

Further, the Federal Advisory Committee Act requires that committee memberships be fairly balanced in terms of the points of view represented and the functions to be performed by the various advisory committee members and Dr. McLeod's participation will contribute to the balance of views represented and the diversity of opinions and expertise. The Committee's intended purpose would be significantly impaired if the agency could not call upon experts who have become eminent in their fields, notwithstanding the financial interests and affiliations

they may have acquired as a result of their demonstrated abilities. Dr. McLeod is Associate Professor, Department of Medicine, Division of Oncology, Section of Molecular Oncology, Department of Molecular Biology & Pharmacology, and Department of Genetics, Washington University School of Medicine. Dr. McLeod's clinical research interests focus on molecular markers of therapy and he focuses his research on cancer pharmacogenomics and translational pharmacology. He has written extensively in these areas. In addition, he is a member of several professional societies and organizations including, the American Association for Cancer Research, American College of Clinical Pharmacology, and the American Society for Clinical Pharmacology and Therapeutics. I believe Dr. McLeod's presentation will provide the committee with much needed information on the pharmacogenetics of warfarin and is essential for an appropriate discussion of the topic to be considered at this meeting.

Accordingly, I recommend that you grant Howard McLeod, Pharm.D., a limited waiver that would allow him to give a presentation on pharmacogenetics as it relates to warfarin, and answer questions related to his presentation. Under the terms of this limited waiver, Dr. McLeod will not be permitted to participate in the committee's discussions, deliberations, or voting with respect to the subcommittees discussions of the current evidence related to the pharmacogenetics of warfarin as a potential basis for label updates. I believe that such a limited waiver is appropriate because in this case, the need for the services


