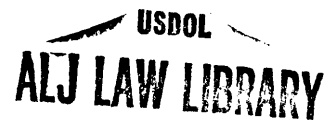

ORDER OF DISMISSAL

This is a proceeding under the Job Training Partnership Act, 29 U.S.C. § 1501 et seq., and the Rules and Regulations issued pursuant **thereto found** in Title 20 of the Code of Federal Regulations. A hearing was scheduled in this case for May 17, 1984.

On May 16, 1984, the Kickapoo Tribe notified this office by mailgram that it requested a postponement of the hearing. By telephone conversation on May 15, 1984, when I was informed orally of this request, I denied it.

On May 18, 1984, the Kickapoo Tribe followed up its earlier request by filing a letter in which it waived its right to a hearing. As reason therefor, the Tribe acknowledged that the suspension, which is at issue in this case, was proper.

The only issue in this case is whether the suspension of the Kickapoo Tribe was proper. Since the Tribe agrees that the suspension was proper, there is no issue to be decided by this tribunal, and this case should be dismissed.

Accordingly, I hereby ORDER that the above-captioned case is DISMISSED.
