

ORDER OF DISMISSAL

This matter arises under the Job Training Partnership Act (JTPA), 29 U.S.C. §1501 et seq., and the regulations issued thereunder at 20 C.F.R. Part 629.

On May 1, 1990, the Grant Officer of the U.S. Department of Labor (DOL) issued the Final Determination on an audit of Complainant's programs under JTPA and three other acts. The Final Determination established a debt of \$6,719 owed to DOL by Complainant for certain alleged violations. Complainant timely appealed the findings and requested a hearing, after which this matter was docketed.

Complainant filed a letter on March 18, 1991 stating that it wishes to withdraw its appeal because the parties have settled. Following this office's request for clarification of Complainant's letter, DOL filed a letter on behalf of both parties on April 19, 1991. DOL states that the parties resolved the disputed issues. As there are no remaining issues before this office and since Complainant has withdrawn its appeal, IT IS ORDERED that this matter is DISMISSED.
