n March 16, 2001, Special Trustee for American Indians. Tom Slonaker, and **Principal Deputy** Special Trustee, Tom Thompson, met with staff from the Office of Trust Records, the Office of Trust Funds Management, and the Office of Trust Risk Management who assisted with the Cobell v. Norton litigation Paragraph 19 document production effort.

This production effort concluded in December 2000 and resulted in the retrieval and imaging of 46,482 responsive documents.

The Special Trustee thanked the assembled group for their tremendous efforts

on a difficult job well done, and distributed a letter of appreciation from former Secretary of the Interior, Bruce Babbitt.

#### OST Budget Request will Sustain Trust Reform Progress

total of \$110.2 million is requested by the Bush Administration in its FY 2002 budget to sustain and support continued trust management reforms under the coordination and administration of the Office of the Spe-

cial Trustee for American Indians (OST). The 2002 request for OST of \$110.2 million is \$8.8 million less than was provided in FY 2001. However, including the \$18.8 million of funding retained in 2002 to meet

continuing needs, the 2002 request will be adequate to provide the necessary funding to continue to make significant progress on trust reform efforts.

### Legislative Update:

Special Trustee Testifies before House and Senate on Trust Reform Progress



n March 21 and again on March 27, 2001, Special Trustee Tom Slonaker appeared before the U.S. House of Representatives and U.S. Senate Subcommittees on Interior Appropriations to testify on the status and progress of the Department's trust reform efforts.

Mr. Slonaker began his testimony by providing Committee members with some background information to illustrate the scope and complexity of the Department's trust asset management activities. Mr. Slonaker also provided his views on the progress of trust reform since he was sworn-in to office last June. Among the accomplishments mentioned were:

- the conversion of all Tribal and IIM accounts to the Trust Funds Accounting System,
- The consolidation of the majority of IIM records to a central location in Albuquerque, New Mexico,
- The successful use of a national database to try to locate account holders whose whereabouts are unknown,
- The designation of the land title portion

of TAAMS as the system of record in four regions,

- Hiring additional staff in BIA and OHA to begin addressing the existing probate backlog,
- The publication of a Risk Management Handbook, and
- The issuance of new regulations for leasing and grazing, probates and Indian trust funds.

Mr. Slonaker also identified the next steps necessary to achieve sustainable trust reform. He stated that this path requires ensuring that strong management teams and resources are in place to bring trust reform projects to successful conclusions, developing additional regulations so that the Department has uniform trust policies and procedures in place, completing a BIA/ OTFM procedural handbook outlining uniform business rules and practices, and determining the long-term workforce planning requirements necessary so that trust asset management posi-

> tions are filled with qualified personnel.

Mr. Slonaker concluded by thanking the committee members for their past and future commitments to support these reforms.

The 2002 request provides funding for the trust management reform activities in OST, the BIA, and the Office of Hearing and Appeals, and reflects a continued emphasis on the implementation of several trust reform initiatives and

the funding necessary to sustain the operational and organizational improvements initiated in previous years.

The funds in the FY 2002 budget will support ongoing trust reform efforts including the BIA=s testing of the TAAMS system and full implementation of both the title and leasing modules in the Rocky Mountain Region.

### OTFM Develops IIM Historical Transactions Database

he Division of Trust Funds Systems within the Office of Trust **Funds Management (OTFM)** recently completed the development of a historical IIM account transactions database.

This database is composed of all IIM transaction information dating back to 1985 that was previously stored on the Legacy system. Providing this information on a centralized, electronic database means that it can be queried by OTFM and BIA personnel located in regional and field offices.

The Trust Funds Accounting System

(TFAS) is capable of storing information about account transactions for up to 17 months. Once information on the TFAS system reaches an age in which it can no longer be stored, this information will now automatically be moved to the new database.

When OTFM staff need access to information that is older than 17 months, they can simply log onto the new historical transaction database. For staff who do not have access yet to the database, but would like to, please call 1-888-OST-OTFM and enter tribal code 399.

### OST/BIA Handbook Nearing Completion

oming soon to your desk is the eagerly anticipated Interagency Procedures Handbook between the BIA and OST on the Management of Trust Accounts, Assets and Resources on Indian Lands.

When completed, this Handbook will provide employees with the procedures for cooperation and coordination between the two bureaus for various aspects of the management of Indian trust assets. The Handbook will detail

the appropriate procedures to follow for the trust functions for which the BIA and OST share responsibility. It can be used as a reference for the procedures by which the management, regulation and accounting functions will be carried out within and between bureaus.

The functions discussed in the Handbook are limited to those areas where coordination and consultation are necessary-the Handbook does not discuss every function for which either BIA or

OST is responsible.

The development of the Handbook is in its final stages and currently is circulating among a cadre of reviewing officials for comments. When comments are received and edits determined, the Handbook will be approved for use, ,and disseminated among OST and BIA staff.

Training on the specific components of the Handbook will be offered to ensure that employees reap all of its benefits.
