**COMPLAINT FOR PERMANENT INJUNCTIVE AND OTHER EQUITABLE RELIEF**

Plaintiff, the Federal Trade Commission ("FTC" or "Commission"), through its undersigned attorneys, alleges as follows:

1. Plaintiff brings this action under Section 13(b) of the Federal Trade Commission Act ("FTC Act"), 15 U.S.C. § 53(b), to secure a permanent injunction, rescission of contracts, restitution, disgorgement of ill-gotten gains, and other equitable relief against defendants for engaging in deceptive acts or practices and disseminating false advertisements in connection with the advertising and sale of a purported weight loss and cellulite reduction product, in or affecting commerce, in violation of Sections 5(a) and 12 of the FTC Act, 15 U.S.C. §§ 45(a) and 52.

**JURISDICTION AND VENUE**

2. This Court has subject matter jurisdiction over this matter pursuant to 15 U.S.C. §§ 45(a), 52, and 53(b), and 28 U.S.C. §§ 1331, 1337(a), and 1345.

3. Venue in the United States District Court for the Southern District of Florida is proper under 15 U.S.C. §§ 45(a), 52, and 53(b) and 28 U.S.C. §§ 1391(b) and (c).

#### **THE PARTIES**

4. Plaintiff, the Federal Trade Commission, is an independent agency of the United States Government created by statute. 15 U.S.C. §§ 41-58. The Commission enforces Section 5(a) of the FTC Act, 15 U.S.C. § 45(a), which prohibits unfair or deceptive acts or practices in or affecting commerce. The Commission also enforces Section 12 of the FTC Act, 15 U.S.C. § 52, which prohibits false advertisements for food, drugs, devices, services, or cosmetics in or affecting commerce. The Commission may initiate federal district court proceedings, through its attorneys, to enjoin violations of the FTC Act and to secure such other equitable relief, including rescission of contracts and restitution, and disgorgement of ill-gotten gains, as may be appropriate in each case. 15 U.S.C. § 53(b).
5. Defendant SG Institute of Health & Education, Inc. ("SGI") is a Florida corporation with its principal office or place of business at 7051 West Commercial Blvd., Suite 3A, Tamarac, Florida, 33319. At all times relevant to this complaint, acting individually or in concert with others, SGI has marketed and sold Revopatch Plus, a purported skin patch for weight loss and cellulite reduction. SGI transacts or has transacted business in this district.
6. Defendant Pedro Salas is a 50% shareholder and President of SGI. At all times relevant to this complaint, acting individually or in concert with others, Pedro Salas has formulated, directed, controlled, had the authority to control, or participated in the acts and practices of SGI, including the acts or practices set forth in this complaint. His

principal office or place of business is the same as that of defendant SGI. Pedro Salas resides in and transacts or has transacted business in this district.

7. Defendant Vanessa Salas is a 50% shareholder of SGI. At all times relevant to this complaint, acting individually or in concert with others, Vanessa Salas has formulated, directed, controlled, had the authority to control, or participated in the acts and practices of SGI, including the acts or practices set forth in this complaint. Her principal office or place of business is the same as that of defendant SGI. Vanessa Salas resides in and transacts or has transacted business in this district.

### **COMMERCE**

8. The acts and practices of defendants alleged in this complaint have been in or affecting commerce, as "commerce" is defined in Section 4 of the FTC Act, 15 U.S.C. § 44.

### **DEFENDANTS' COURSE OF CONDUCT**

9. Since approximately September 2001, defendants have advertised, offered for sale, sold, and distributed skin patches, dietary supplements and other products to consumers nationwide. Defendants' products have included, but are not limited to, Revopatch Plus, a purported skin patch for weight loss and cellulite reduction. According to its label, Revopatch Plus contains 10 mg of fucus vesiculosus (sea kelp), 2mg of guarana extract, 2 mg of chromium picolinate, 2 mg of garcinia extract and 2 mg of menthol. Defendants have offered and sold this product directly to consumers in units of 30, 60 or 90 patches for prices varying from \$60 to \$200, plus shipping and handling. The patches were manufactured by Transdermal Products International Manufacturing Corp. It is estimated that the product generated over \$1 million dollars in sales since September 2001.

10. To induce consumers to purchase Revopatch Plus, defendants have advertised in Spanish throughout the United States through various means including Spanish-language print advertisements in national Hispanic magazines, such as *Conexiones* and *La Guia*, live radio spots on *Recuerdo* radio station in California (KTNQ) and on 93.1 in New York City, and television commercials aired in Florida on *Telemundo*. Consumers have been able to purchase Revopatch Plus by calling a toll-free telephone number that appears in the advertisements.

### **Revopatch Plus**

11. Defendants have disseminated, or caused to be disseminated, advertisements for Revopatch Plus, including, but not necessarily limited to, the print ads, television commercials, and radio spots attached as Exhibits A-F. These advertisements, translated from Spanish, contain the following statements, among others:
- a. “[Revopatch Plus] reduces your appetite, eliminates fat, regulates your metabolism, dissipates cellulite and returns your body to its most slender shape.”  
-Exhibit A, Revopatch Plus Advertisement in *Conexiones* magazine
  - b. VM [unidentified male voice]: Revopatch has arrived from Europe. The revolutionary patch that will help you lose weight and reduce the appearance of cellulite at the same time.  
DI [image description]: *Interview of a young woman on the street.*  
M3 [interview woman 3]: With Revopatch my cellulite has been noticeably reduced. Try it and see the proof.  
DI: *Footage of young women in bikinis playing volleyball on the beach, followed by a woman in an orange bikini coming out of the water.*  
VM: Revopatch is a new product that is one hundred per cent natural and that alters your metabolism by adhering to your skin and contributing to diminish excess body fat and to noticeably reduce your appetite.  
DI: *Interview of a blonde woman.*

M4 [interview woman 4]: I began using it when I saw the results it had on my best friend and I have lost twenty pounds in six weeks.

DI: *Interview of a young man at the beach.*

H1 [interview man 1]: I lost fifteen pounds in only four weeks with Revopatch. It is sensational.

c. "Revopatch Plus has been approved by the FDA . . . ."

-Exhibit C, Revopatch Plus Radio Advertisement

d. "Revopatch Plus is a modern transdermic treatment . . . that contains 5 natural ingredients that has no side effects and that begins to work in your body from the very first week, regulating your metabolism and helping you lose unnecessary fat at an average of 1½ to 4 lbs. per week....You do not need to follow a rigorous diet..."

-Exhibit D, Revopatch Plus Radio Advertisement

e. "The natural components of Revopatch Plus, when they come into contact with your body, activate the body's capacity to more rapidly burn calories. All you have to do is peel off the patch, stick it to your skin, and its highly diluted components begin to send signals to the body . . . ."

-Exhibit E, Revopatch Plus Radio Advertisement

f. "[Revopatch Plus] it takes away the urge to eat and the accumulated fat in the body: and best of all, it is 2 products in 1, because it helps you to lose weight and it helps you dissolve cellulite."

-Exhibit F, Revopatch Plus Radio Advertisement

### **DEFENDANTS' VIOLATIONS OF THE FTC ACT**

12. Section 5(a) of the FTC Act, 15 U.S.C. § 45(a), prohibits unfair or deceptive acts or practices in or affecting commerce. Section 12(a) of the FTC Act, 15 U.S.C. § 52(a), prohibits the dissemination of any false advertisement in or affecting commerce for the purpose of inducing, or which is likely to induce, the purchase of food, drugs, devices, services, or cosmetics. For purposes of Section 12 of the FTC Act, Revopatch Plus is a "drug" or "device" as defined in Section 15 of the FTC Act, 15 U.S.C. §§ 55. As set

forth below, defendants have engaged in such unlawful practices in connection with the marketing and sale of the Revopatch Plus.

**COUNT I:**

**REVOPATCH PLUS: FALSE CLAIMS**

13. Through the means described in Paragraph 11 above, defendants have represented, expressly or by implication, that:

- a. Revopatch Plus causes substantial weight loss in a short period of time, for example, 15 pounds in 4 weeks and 20 pounds in 6 weeks; and
- b. Revopatch Plus has been approved by the FDA.

14. In truth and in fact:

- a. Revopatch Plus does not cause substantial weight loss in a short period of time, for example, 15 pounds in 4 weeks and 20 pounds in 6 weeks; and
- c. Revopatch Plus has not been approved by the FDA.

Therefore, defendants' representations set forth in Paragraph 13 above are false and misleading and constitute deceptive acts and practices, and the making of false advertisements, in or affecting commerce, in violation of Sections 5(a) and 12 of the FTC Act, 15 U.S.C. §§ 45(a) and 52.

**COUNT II**

**REVOPATCH PLUS: UNSUBSTANTIATED CLAIMS**

15. Through the means described in Paragraph 11 above, defendants have represented, expressly or by implication, that:

- a. Revopatch Plus causes weight loss;

- b. Revopatch Plus eliminates fat;
  - c. Revopatch Plus reduces appetite;
  - d. Revopatch Plus regulates metabolism; and
  - e. Revopatch Plus reduces or dissolves cellulite.
16. Defendants did not possess and rely upon a reasonable basis that substantiated the representations set forth in Paragraph 15 above at the time the representations were made. Therefore, the making of the representations set forth in Paragraph 15 constitutes deceptive acts or practices, and the making of false advertisements, in or affecting commerce, in violation of Sections 5(a) and 12 of the FTC Act, 15 U.S.C. §§ 45(a) and 52.

#### **CONSUMER INJURY**

17. Consumers throughout the United States have suffered and continue to suffer substantial injury as a result of defendants' unlawful acts or practices. In addition, defendants have been unjustly enriched as a result of their unlawful acts or practices. Absent injunctive relief by this Court, defendants are likely to continue to injure consumers, reap unjust enrichment, and harm the public interest.

#### **THIS COURT'S POWER TO GRANT RELIEF**

18. Section 13(b) of the FTC Act, 15 U.S.C. § 53(b), empowers this Court to grant injunctive and such other relief as the Court may deem appropriate to halt and redress violations of the FTC Act. The Court, in the exercise of its equitable jurisdiction, may award other ancillary relief, including, but not limited to, rescission of contracts and restitution, and

the disgorgement of ill-gotten gains, to prevent and remedy injury caused by defendants' law violations.

**PRAYER FOR RELIEF**

WHEREFORE, Plaintiff Federal Trade Commission, pursuant to Section 13(b) of the FTC Act, 15 U.S.C. § 53(b), and the Court's own equitable powers, requests that this Court:

(1) Permanently enjoin defendants from violating Sections 5(a) and 12 of the FTC Act, as alleged herein, including committing such violations in connection with the advertising, offering for sale, sale, or distribution of food, drugs, dietary supplements, devices, cosmetics, or other products, services, or programs;


(2) Award such equitable relief as the Court finds necessary to redress injury to consumers resulting from defendants' violations of the FTC Act, including, but not limited to, rescission of contracts and restitution, and the disgorgement of ill-gotten gains; and

(3) Award Plaintiff such other equitable relief as the Court may determine to be just and proper.
