STIPULATION OF DISMISSAL CONCERNING DEFENDANT PAUL TESKEY

Plaintiff, the Federal Trade Commission ("FTC"), filed a Complaint for Injunctive and Other Equitable Relief ("Complaint") pursuant to Sections 13(b) and 19 of the Federal Trade Commission Act ("FTC Act"), 15 U.S.C. §§ 53(b) and 57b, and the Telemarketing and Consumer Fraud and Abuse Prevention Act ("Telemarketing Act"), 15 U.S.C. §§ 6101 *et seq.*, charging defendants with deceptive acts and practices in connection with the sale, offering for sale, or distribution of foreign lottery tickets. The plaintiff's Complaint alleges that these acts and practices violate Section 5(a) of the FTC Act, 15 U.S.C. § 45(a), and Sections 310.3(a)(1)(ii) and 310.3(a)(4) of the Telemarketing Sales Rule ("Telemarketing Rule"), 16 C.F.R. §§ 310.3(a)(1)(ii) and 310.3(a)(4).

The plaintiff and defendant Paul Teskey have consented to a voluntary dismissal of this action against defendant Paul Teskey, upon the following terms and conditions:

1. The plaintiff's agreement to this Stipulation is expressly premised upon the representations of Paul Teskey contained in an affidavit dated October 29, 2002, which contains material information upon which the plaintiff relied in negotiating and agreeing upon this Stipulated Order. If, upon motion of the plaintiff, the Court finds that said affidavit of Paul

Teskey contains any material misrepresentation of fact, plaintiff may request that the judgment of dismissal provided for herein shall be set aside as void and that the plaintiff may be permitted to proceed as if no such judgment had been entered.

2. The parties shall each bear their own costs and attorneys' fees incurred in this action and waive all claims under the Equal Access to Justice Act, 28 U.S.C. § 2412.
