### Sea Service Requirements

**REGENCY** (10.202(e)) 90 days in the last 3 years on vessels of appropriate tonnage.

**MASTER 200** – (10.426)

- A. 720 days of service on Ocean or N/C waters, **OF WHICH**
  - 1. 360 days of service must be in Ocean or N/C waters, **AND**
  - 2. 360 days of service must have been as a licensed Master, Mate, or OUPV, **OR**
- B. 360 days as a licensed master or mate of Ocean or N/C towing vessels and completion of a limited examination.

**MASTER 100** – (10.428)

- A. 720 days of service on Ocean or N/C waters, **OF WHICH**
  - 1. 360 days of service must be in Ocean or N/C waters.

**TONNAGE LIMITATION** – (10.422)

- A. **200 Tons** – 180 days of service on vessels of 151 GRT or above, **OR**
  - 1. 360 days of service on vessels over 101 GRT.
- B. **150 Tons** – 180 days of service on vessels at 101 to 150 GRT, **OR**
  - 1. 360 days of service on vessels at 67 to 101 GRT.
- C. **100 Tons** – 180 days of service on vessels of 51 GRT or above, **OR**
  - 1. 360 days of service on vessels over 33.4 GRT.
- D. **50 Tons** – 1 day of service on vessels over 5.01 GRT.
- E. **25 Tons** – All service is on vessels of 5 GRT or less.

**SAIL OR AUXILIARY SAIL** – (10.426(b) & .428(b)) – 360 days of service on sail vessels.

**ASSISTANCE TOWING** – (10.482) – Must pass endorsement exam or approved course.

**NOTES:** (Consider OUPV N/C which only requires 360 days of service with 90 days being on N/C waters **IF** mariner doesn't qualify for Master N/C.)
