Sea Service Requirements

RECENCY (10.202(e)) 90 days in the last 3 years on vessels of appropriate tonnage.

FCP – (10.703)

- A. 1080 days of service in the deck department of vessels, **OF WHICH**
1. 540 days of service as quartermaster, wheelsman, AB, apprentice pilot, or equivalent capacity, standing regular watches at the wheel or in the pilot house, **AND**
 2. 360 days of service must be on vessels operating on the class of waters for which pilotage is desired, **OR**
- B. Masters or Mates with licenses over 1600 GRT meet the service requirements.

ROUTE REQUIREMENTS – (10.705)

- A. Original Endorsement
1. ___ Minimum number of round trips required over the route sought, **OF WHICH**
 2. ___ 25% of the round trips must be during the hours of darkness, **AND**
 3. 1 of the required round trips must be within 6 months.
- B. Subsequent Endorsement
1. ___ Minimum number of round trips required over the route sought, **OF WHICH**
 2. ___ 25% of the round trips must be during the hours of darkness, **AND**
 3. 1 of the required round trips must be within 6 months.

TONNAGE REQUIREMENTS – (10.711)

- A. Unlimited Tonnage
1. 540 days of service as master, mate, quartermaster, wheelsman, AB, apprentice pilot, or equivalent capacity, standing regular watches at the wheel or in the pilot house on vessels over 1600 GRT and 2/3 of the minimum number of round trips over the route sought have been on vessels over 1600 GRT.
- B. Limited Tonnage
1. As determined by the OCMI; applicant may complete additional round trips, in accord with 10.705 (b)/ (c), on vessels of over 1600 GRT to have the limitation removed.
