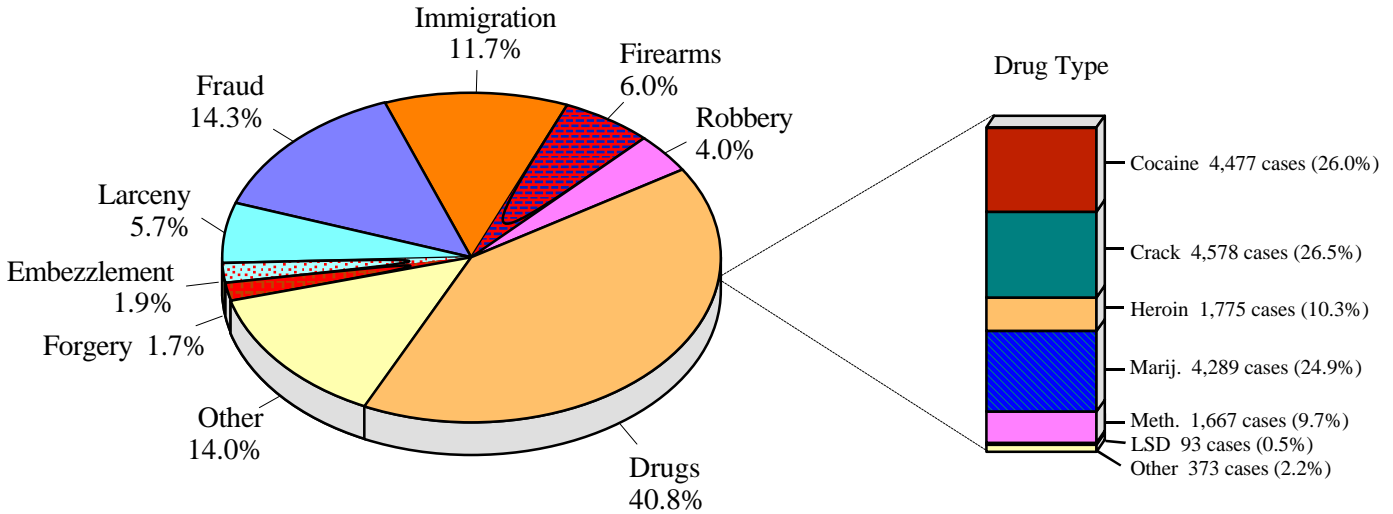


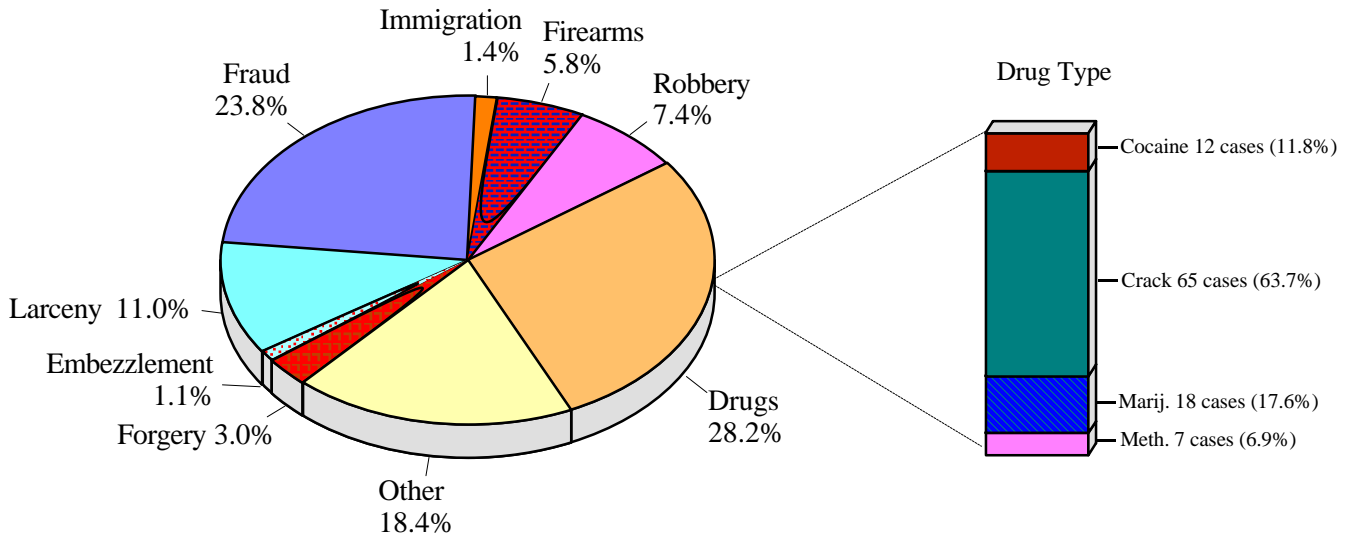

Of the 42,436 guideline cases, 8,615 cases with zero months prison ordered were excluded. In addition, 370 cases were excluded due to one or both of the following reasons: missing primary offense category (74) or missing or indeterminable sentencing information (330).

Of the 366 guideline cases from the District of Alabama, Northern, 117 cases with zero months prison ordered were excluded. In addition, one case was excluded due to both of the following reasons: missing primary offense category, and missing or indeterminable sentencing information.
