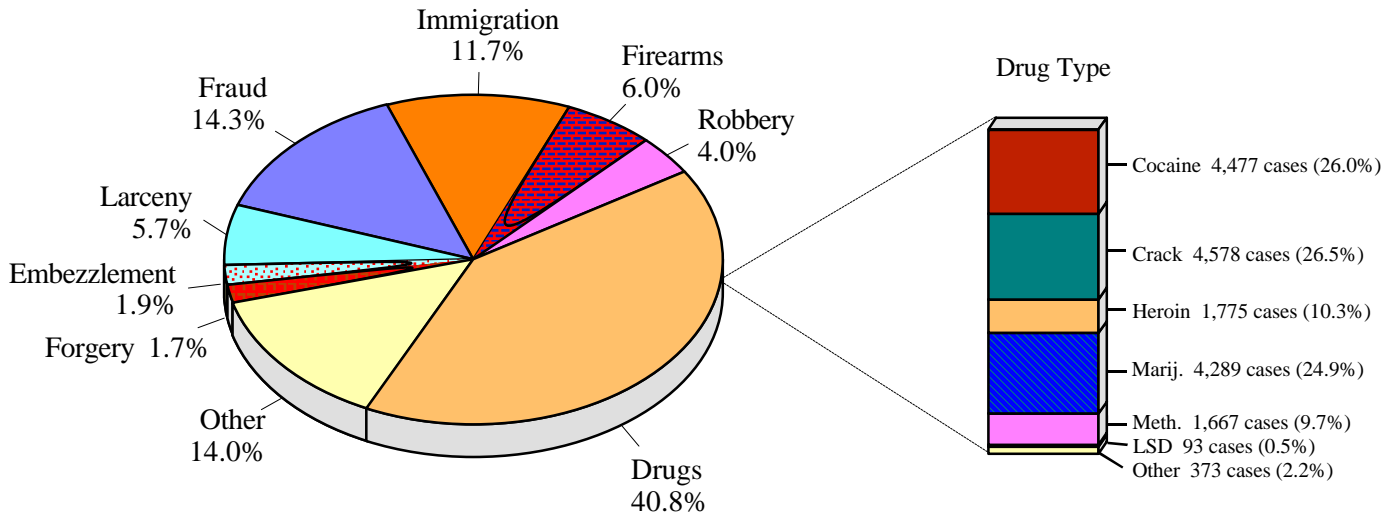


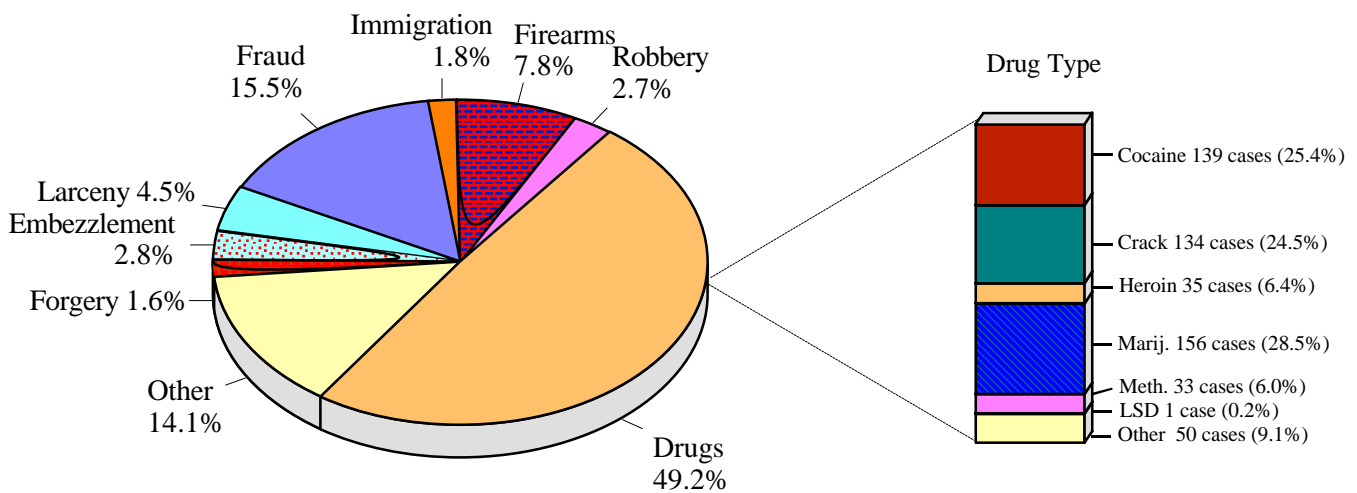

Of the 42,436 guideline cases, 8,615 cases with zero months prison ordered were excluded. In addition, 370 cases were excluded due to one or both of the following reasons: missing primary offense category (74) or missing or indeterminable sentencing information (330).

Of the 1,113 guideline cases from the State of Michigan, 222 cases with zero months prison ordered were excluded. In addition, four cases were excluded due to missing or indeterminable sentencing information.
