Brief comments about the presenters:

Graciela Ben Dror, now teaching at the University of Haifa, has published on Catholic teachings about Jews both in Spain and in Argentina. She completed her Ph.D. in Jerusalem.

Susannah Heschel, Eli Black Associate Professor of Jewish Studies at Dartmouth College, is one of the most important scholars on Jewish-Christian relations and the author of *Abraham Geiger and the Jewish Jesus* (1998).

David Kertzer of Brown University is the author of *The Popes against the Jews* (2001).

Gerhard Lindemann published his doctoral dissertation regarding Christian pastors of Jewish descent and their treatment in the Hanoverian Church, up to 1945. He continues to work on topics of Jewish-Christian relations as he completes his Habilitation.

Mikko Ketola, of Helsinki, published in 2000 his Ph.D. dissertation on the Estonian Evangelical Lutheran Church, 1918-1939, with a focus on the relationship between Estonians and Baltic Germans. He is now working on a book on the Estonian Lutheran Church during World War II, with a major section on the Holocaust.

Anna Lysiak has worked on the published antisemitic writings of Josef Kruszynski, a priest as well as rector of the only Catholic University in Poland. She also has access to his unpublished memoirs. She is presently completing a Ph.D. at Krakow University on Jewish responses to Polish Catholic antisemitism in the interwar period.

Thorsten Wagner is a Danish German now finishing his Ph.D. at the Institut für Antisemitismus Forschung in Berlin. He has studied in Israel as well. His dissertation deals with Danish-Jewish relations in the nineteenth century, but he has written about Danish attitudes under German occupation and is well prepared to develop this topic for our conference.
