	<p>The Maggie fire was a lightning initiated fire located 8 miles north of Camp Nelson in Tulare County on July 9th. The fire was initially battled and then allowed to burn as a resource burn through August. There were no structures lost nor did any casualties occur. The total cost associated with this fire was \$454,000 as of August 26th.</p>

	<p>The Tamarack Fire was lightning initiated on July 9th and located 14 miles north of Camp Nelson in the Sequoia National Park. The fire was initially battled but became a resource burn in early August. There were no structures lost nor were there casualties to fight the fire. The total cost to battle the fire reached \$879,000 by the end of August and 4,654 acres had been burned.</p>

	<p>The Frog Complex Fire was a lightning initiated fire on July 21st but became a resource management fire. The fire was located 1 mile West of Laurel Lake or 19 miles northwest of Yosemite Village. The fire continued through August and September and burned 5,578 acres by October 2nd and at a cost of \$850,033.</p>

	<p>The King Fire located 2 miles northeast of Mr. Starr King in Yosemite National Park was lightning initiated on July 19th and was maintained as a resource burn through August. The fire burned 157 acres through September as a resource burn with a cost to manage assessed at \$23,000 by the end of August.</p>

	<p>The Middle-T Fire was a lightning initiated fire on July 20th located 10 miles northwest of Yosemite Village. The fire was initially battled but became a resource management burn over 451 acres that had cost \$1.1 million to battle through August 27th. There were no structures lost nor were there any injuries.</p>

	<p>The Roaring Fire was lightning initiated on July 22nd and located one mile south of Cedar Grove in Kings Canyon National Park. The fire became a resource management burn through August and burned 1525 acres by the end of September. No structures were lost nor were there any injuries. The cost to battle the fire was not known.</p>

	<p>The Broder-Beck Fire was lightning initiated July 25th and became a resource management burn through the month of August. The cost to battle the fire to August 25th was assessed at \$560,276. No structures were lost nor were there any casualties</p>

The Cottonwood Fire burned approximately 2,346 acres around Sorrell Peak in the Piute Mountains of Kern County about 15 miles south of Weldon. The cause of the fire was unknown but 2 vehicles, a few outbuildings, and some trailers were destroyed in the first day of the blaze. One injury occurred in fighting the fire. The cost to fight the fire was estimated at \$1.03 million
