Child Support Obligations and Referrals to the Division of Child Support (DCS)

- Oregon law (ORS 419C.590, 419C.595 and 419C.597) allows the Oregon Youth Authority (OYA) to be the recipient of any financial support available to a child placed in its custody.
- The OYA has an agreement with the Division of Child Support to collect this support.
- The Division of Child Support State Recovery Central Unit establishes support orders for the OYA.
- Parents can, at their own expense, speak with an attorney regarding child support obligations.
- Money collected for child support is used to reimburse the State for a portion of the costs associated with your child's out-of-home placement.
- The Division of Child Support cannot give legal advice to parents but can answer general questions.

Whom Should I Contact?

Contact the Division of Child Support **State Recovery Central Unit** for questions about establishing new orders and wage withholding.

Also, contact SRCU for questions about existing orders that were established when a child was in the custody of the OYA or Child Welfare.

wage withholding where a parent or guardian was
the payee when the order was established.

This brochure provides basic information about the State's child support program and how it may affect you and your child if your child is placed in the custody of the Oregon Youth Authority (OYA).

Why does the Division of Child Support get involved in my case?

The Department of Justice, Division of Child Support (DCS) is the agency designated by Oregon law to establish paternity, enact obligations for support and medical coverage, and to collect child support payments. Under Oregon law, both parents have the responsibility for providing support for their child(ren). The OYA must refer your family to DCS when your child is placed with the OYA.

By Oregon law, if an order for child support already exists (e.g., divorce decree, paternity award, etc.), the OYA will be the "payee" while your child is placed with OYA. This is called an "assignment of support rights". ORS 419C.597 also allows the state to collect past-due child support owed under the existing order. If you continue to receive child support after your child is placed with the OYA, you need to contact DCS.

If no child support order exists, DCS will establish an order to collect child support from each parent, and the OYA will be the payee.



Why do I need to pay child support when my child is in an OYA placement?

State and federal law require the

State of Oregon to collect child support from you when your child is placed in state custody. The money is used to reimburse the state for part of the cost of providing for your child's placement.



How does DCS establish a support order?

Parents are served with a "Notice and Finding of Financial Responsibility." The notice shows

the proposed amount of support to be paid on a monthly basis, and the amount of past support owed based on the date of the child's placement with OYA. Parents may request a hearing through State Recovery Central Unit if they do not agree with the proposed order.



How will the dollar amount of support be established?

The amount of support you are ordered to pay depends on your

individual income. DCS has established guidelines to calculate child support amounts. DCS calculates the support order amount using information about a parent's income and the child support guidelines. If you have questions, please contact the State Recovery Central Unit.



What is the hearings process?

Support order hearings are called "administrative" hearings. They are conducted by a hearings officer via telephone. An

Administrative Support Order has the same legal standing as a court order. Parents have 60 calendar days to appeal a decision by a hearings officer to the circuit court.



How do I make support payments?

Oregon law requires all child support orders to be paid through

automatic wage withholding (payroll deduction). There are some exceptions, however, which are explained in the "Notice and Finding of Financial Responsibility."



What if my child is under the age of 18, but was convicted in adult court and placed in a youth correctional facility?

Even if your child is sentenced in an adult court, the state will collect child support from you while your child is in an OYA facility. Sentencing in an adult court does not emancipate a youth, nor does it relieve the parents of their financial obligation to the youth.



When does my child support obligation stop?

Under Oregon law, youth in the custody of OYA may be eligible to receive support up to the age of

21, if they qualify as a "child attending school" (ORS 107.108, effective October 6, 2001). DCS will continue to collect the monthly child support amount if the youth meets the criteria. All youth committed to the Oregon Youth Authority are enrolled in some type of mandatory education program.
