This two-day training is designed for both treatment providers, including outpatient, residential, and correctional facilities, and parole and probation officers from OYA and county juvenile departments.

The first day of the training, offered by Dr. Greg Czar, will present information about conducting assessments and using the ERASOR, covering each one of the questions listed in the ERASOR. Dr. Czar is an experienced psychologist who has used the ERASOR for a number of years. Dr. Czar is very knowledgeable about the research on the ERASOR as well as juvenile sexually abusive behavior in general.

The second day of the training, offered by John Lynch, probation officer from Yamhill County Juvenile Department and Gary Davis, PhD, Director of Clinical Services and Sex Offender Treatment from Youth Progress Association, will cover how to put the results of the ERASOR into practical use. Both John and Gary have years of experience working in the field. They will talk about how to take the findings from the ERASOR and overall assessment and use that information to make an informed treatment plan and community supervision plan.
