


Figure 8.1. Prevalence of current smoking among adults aged 18 years and over: United States, 1997–June 2006





Beginning with the 2003 data, the National Health Interview Survey (NHIS) transitioned to weights derived from the 2000 census. DATA SOURCE: Sample Adult Core component of the 1997–2006 NHIS. The estimate for 2006 was based on data collected from January through June. Data are based on household interviews of a sample of the civilian noninstitutionalized population.

- For the period January through June 2006, 20.8% (95% confidence interval = 19.83–21.83%) of adults aged 18 years and over were current smokers, which was not significantly different from the 2005 estimate of 20.9%.
- The annual prevalence of current smoking among U.S. adults declined from 24.7% in 1997 to 20.8% for the period January through June 2006.



Figure 8.2. Percent distribution of smoking status among adults aged 18 years and over, by sex: United States, January–June 2006





- The percentage of current smokers was higher for men (23.3%) than for women (18.5%).
- The percentage of former smokers was higher for men than for women, and the percentage of those who had never smoked was higher for women than for men.



Figure 8.3. Prevalence of current smoking among adults aged 18 years and over, by age group and sex: United States, January–June 2006





- For both sexes combined, the percentage of adults who were current smokers was lower among adults aged 65 years and over (10.8%) than among adults aged 18–44 years (23.7%) and 45–64 years (21.4%). This pattern in current smoking by age group was seen in both men and women.
- For the age groups 18–44 years and 45–64 years and over, men were more likely than women to be current smokers.

- The age-sex-adjusted prevalence of current smoking was 13.7% for Hispanic persons, 22.6% for non-Hispanic white persons, and 23.1% for non-Hispanic black persons.
- Non-Hispanic white adults and non-Hispanic black adults were more likely than Hispanic adults to be current smokers.
