Detective Wells will review the investigation and prosecution of a "murder by abuse" case, including patrol response, investigative and organization methods used, obstacles faced, and lessons learned. The case involved the murder of 3 year old Karla "Karly" Sheehan by her mother's boyfriend, Shawn Wesley Field. Issues surrounding this case led to the passage of "Karly's Law" HB3328 during the last legislative session. Detective Wells will discuss the impact of the new laws, and how it applies to law enforcement investigations. The second portion of the training will be conducted by Jennifer Schindell who will cover forensic photography of the scene and body which will last roughly three hours. The goal of this section is to explain how written documentation and photo documentation can help or hurt, and what pictures to take of the scene and body. She also will discuss how to improve the quality and value of the photographs through case reviews and photographs.
