Subject: December 2007 CCC lending rates are:

- 1995 and prior crop year commodity loans: **3.750 %** per annum.
- 1996 and subsequent crop year commodity loans: **4.750 %** per annum.
- Local Depository Earnings: **3.750 %** per annum.
- Farm Storage Facility Loans: **4.125 %** per annum.
- Sugar Storage Facility Loans: **4.625 %** per annum.

Note: The lending rate is the rate at which CCC lends money to the public.

Tobacco Transition Payment Program Discount Rate (December 2007): 10.000 %.

Prompt Pay Interest Rate (July 1, 2007 thru December 31, 2007): 5.750 %.
