The Migratory Bird Conservation Commission

Section 2 of the Migratory Bird Conservation Act of February 18, 1929 (Act), as amended, established the Migratory Bird Conservation Commission.

Section 2. A Commission to be known as the Migratory Bird Conservation Commission, consisting of the Secretary of the Interior, as Chairman; the Administrator of the Environmental Protection Agency; the Secretary of Agriculture; two Members of the Senate, to be selected by the President of the Senate; and two Members of the House of Representatives, to be selected by the Speaker, is created and authorized to consider and pass upon any area of land, water, or land and water that may be recommended by the Secretary of the Interior for purchase or rental under this Act and to fix the price or prices at which such area may be purchased or rented; and no purchase or rental shall be made of any such area until it has been duly approved for purchase or rental by said Commission.

Any Member of the House of Representatives who is a member of the Commission, if reelected to the succeeding Congress, may serve on the Commission notwithstanding the expiration of a Congress. Any vacancy on the Commission shall be filled in the same manner as the original appointment. The ranking officer of the branch or department of a State to which is committed the administration of its game laws, or his authorized representative, shall be a member *ex officio* of said Commission for the purpose of considering and voting on all questions relating to the acquisition, under said sections, of areas in his State. For purposes of said sections, the purchase or rental of any area of land, water, or land and water includes the purchase or rental of any interest in any such area of land, water, or land and water.

Approvals During Fiscal Year 2004

In Fiscal Year 2004, the Migratory Bird Conservation Commission approved the acquisition boundary at two national wildlife refuges. The first refuge, totaling 98,029 acres, is the Tensas River NWR in Madison and Tensas Parishes, Louisiana. It was authorized by Public Law 96-285 and was established on February 5, 1985. The second refuge, totaling 24,000 acres, is the Canaan Valley National Wildlife Refuge in Tucker County, West Virginia. It was established in August 1994, as our nation's 500th refuge. The Commission approved boundary additions, totaling 27,988 acres, to eleven refuges that were previously approved by the Commission. The Commission also approved the purchase price of 905 acres at four refuges.

The Migratory Bird Conservation Fund

The Migratory Bird Conservation Fund provides the Department of the Interior with monies to acquire migratory bird habitat. There are four major sources of money for the Fund. The most well-known source is the revenue received from the sale of Migratory Bird Hunting and Conservation Stamps, commonly known as Duck Stamps, as provided for under the Migratory Bird Hunting and Conservation Stamp Act of March 18, 1934, as amended. The other three major sources include appropriations authorized by the Wetlands Loan Act of October 4, 1961, as amended; import duties collected on arms and ammunition; and receipts from the sale of refuge admission permits as provided for in the Emergency Wetlands Resources Act of 1986. The Fund is further supplemented by receipts from the sale of products from refuge lands and rights-of-ways across national wildlife refuges, the disposal of refuge lands, and reverted Federal Aid funds.

Two land acquisition programs are financed from the Migratory Bird Conservation Fund. The first purchases major areas for migratory birds under the authority of the Migratory Bird Conservation Act. Lands acquired through this program are considered

and approved by the Migratory Bird Conservation Commission. The second program acquires small natural wetlands and associated uplands located mainly in the Prairie Pothole Region of the upper Midwest. These lands, known as Waterfowl Production Areas, are acquired under the authority of the Migratory Bird Hunting and Conservation Stamp Act and do not require approval from the Commission.

During Fiscal Year 2004, the Department of the Interior obligated a total of \$17,399,900 for the acquisition of land and interests in land totaling 25,094 acres in major migratory bird conservation areas. An additional \$15,928,161 was obligated for projects in Waterfowl Production Areas totaling 45,532 acres.

A total of \$46,473,958 was available for obligation from the Migratory Bird Conservation Fund during Fiscal Year 2004. Obligations for all Migratory Bird Conservation Fund land acquisition functions during the fiscal year totaled \$44,792,966 (of which \$515,092 was from prior year recoveries). The total obligations equal 96 percent of the available funds.

New National Wildlife Refuge Boundary Approvals

In Fiscal Year 2004, the Migratory Bird Conservation Commission approved the acquisition boundary of two new refuges, Tensas River National Wildlife Refuge in Madison and Tensas Parishes, Louisiana and Canaan Valley National Wildlife Refuge Tucker County, West Virginia. The Commission also approved the acquisition boundary of eleven national wildlife refuges that were previously established: Anahuac National Wildlife Refuge in Galveston County, Texas; Cape May National Wildlife Refuge in Cape May County, New Jersey; Detroit River International Wildlife Refuge in Wayne County, Michigan; Edwin B. Forsythe National Wildlife Refuge in Atlantic,

Burlington, and Ocean Counties, New Jersey; Lake Umbagog National Wildlife Refuge in Oxford County, Maine; McFaddin National Wildlife Refuge in Galveston County, Texas; Rachel Carson National Wildlife Refuge in York and Cumberland Counties, Maine; Red River National Wildlife Refuge in Caddo, Bossier, Desoto, Red River and Natchitoches Parishes, Louisiana; San Bernard National Wildlife Refuge in Brazoria County, Texas; Silvio O. Conte National Fish and Wildlife Refuge, New Hampshire and, Trinity River National Wildlife Refuge in Liberty County, Texas.

Tensas River National Wildlife Refuge *Madison and Tensas Parishes, Louisiana*


Tensas River National Wildlife Refuge was established on June 28, 1980, by Public Law 96-285, to preserve the largest remaining privately owned bottomland hardwood forest tract in the Lower Mississippi River Delta. Tensas River NWR is one of a network of refuges established to preserve and restore habitats for native wildlife and migratory birds.

The purpose of Tensas River NWR is to preserve and restore bottomland hardwood forest and other natural habitats. In addition to the numerous species of mammals and birds, the bottomland hardwood forests on the

refuge provide habitat for the Louisiana Black Bear, a Federally-listed threatened species. The backwater sloughs, lakes, and bayous provide habitat for a great diversity of aquatic life including fish, reptiles, amphibians, mollusks, and crustaceans. This refuge provides wintering habitat for mallards, pintails, gadwall, wigeon, green-winged teal, wood ducks, and contributes to the goals of the North American Waterfowl Management Plan. Reforestation and restoration of native habitats will benefit resident and migratory waterfowl as well a wide array of other species. In addition, the refuge offers recreational, research, and educational opportunities.

The Commission approved the 98,029 acre refuge boundary and also gave price approval for a 10,948 acre tract on September 8, 2004.

Canaan Valley National Wildlife Refuge *Tucker County, West Virginia*


Canaan Valley National Wildlife Refuge is the result of efforts by numerous conservation groups and other partners working with the U.S. Fish and Wildlife Service to protect this unique ecosystem. These efforts commenced in 1961 with a study of the Valley's nationally significant wetlands and wildlife habitats, and culminated with the establishment of the Canaan Valley NWR, our nation's 500th refuge, in August of 1994. The refuge boundary includes 24,000 acres; approximately 15,242 acres have been acquired utilizing funds from the Land and Water Conservation Fund. Land use changes continue to threaten this unique and fragile area.

The habitats in the valley support diverse wildlife populations including important waterfowl and other high priority migratory birds. The wetlands are important for breeding by mallard and wood duck and as stopover habitat for a number of duck and geese species during spring and fall migration, including the American black duck. A number of springs along the Blackwater River and its tributaries stay open during the winter and provide wintering habitat for waterfowl.

Canaan Valley is located in some of the most rugged and mountainous terrain in West Virginia, it is 14 miles long and 2 to 4 miles wide. The average elevation of the valley floor is 3,200 feet, making it the highest valley of its size east of the Rocky Mountains. In 1974, the Secretary of the Interior designated the northern part of the valley, 15,400 acres, as a National Natural Landmark.

The Commission approved the 24,000 acre refuge boundary and also gave price approval for a 156 acre tract on June 9, 2004.


Anahuac National Wildlife Refuge *Galveston County, Texas*

On February 27, 1962, the Migratory Bird Conservation Commission approved the establishment of Anahuac National Wildlife Refuge (Refuge). Following the initial approvals, the Commission approved the acquisition of an additional 20,088 acres with monies from the Migratory Bird Conservation Fund. Another 4,372 acres have been acquired with Land and Water Conservation Funds, through donations, and road easements.

The marsh and prairie provide feeding and resting habitat to Central Flyway waterfowl migrating through and wintering on the upper Texas Coast. Twenty-three species of ducks and four species of geese have been observed on or adjacent to this site. The marsh and neighboring uplands provide nesting and brooding areas for the mottled duck. This area is within the North American Waterfowl Management Plan's (NAWMP) Gulf Coast Joint Venture-Chenier Plain Initiative (GCJV-CPI), and has been identified as a high priority for acquisition.

The Commission approved the 43 acre refuge boundary addition and price approval on June 9, 2004.


Cape May National Wildlife Refuge *Cape May County, New Jersey*

Cape May National Wildlife Refuge was originally approved by the Migratory Bird Conservation Commission on May 9, 1989. To date, 4,416 acres have been acquired with monies from the Migratory Bird Conservation Fund and an additional 6,125 acres have been acquired using the Land and Water Conservation Fund. Two years ago the Coast Guard transferred 625 acres at no cost to the Service. The Refuge is located in Cape May County, New Jersey, and is made up of two divisions. The Delaware Bay Division is along a five-mile stretch of Delaware Bay, and includes the former Coast Guard station and adjacent lands locally known as "Two Mile Beach" just north of the Cape May Canal on the Atlantic Ocean, and the Great Cedar Swamp Division acres that includes the headwaters of two tidal rivers.

The coastal wetlands of New Jersey, especially the Delaware Bay marshes, annually winter 30 to 40 percent of the Atlantic Flyway Black Duck population. The Black Duck relies heavily on small tidal and fresh water creeks within these areas because they remain ice-free during most of the winter season. This area also provides migration habitat for millions of other birds that are funneled through the Cape May peninsula during migrational periods.

The Commission approved the 1,632 acre refuge boundary addition and price approval for a 47 acre tract on March 3, 2004.

Detroit River International Wildlife Refuge *Wayne County, Michigan*

The Detroit River International Wildlife Refuge (Refuge) was established on December 21, 2001 by PL. 107-91 (H.R.1230) Detroit River International Wildlife Refuge Establishment Act and expanded on May 19, 2003, Public Law 108-23, the Ottawa National Wildlife refuge complex Expansion and Detroit River International Wildlife Refuge Expansion Act. The first international refuge in North America, will conserve, protect and restore habitat for 29 species of waterfowl, 65 kinds of fish and 300 species of migratory birds on more than 5,000 acres along the lower Detroit River in Michigan and Canada. The refuge was approved by the Migratory Bird Conservation Commission on June 25, 2003.

The refuge includes islands, coastal wetlands, marshes, shoals and riverfront lands along 18 miles of the Lower Detroit River from Zug Island south along western Lake Erie to the southern boundary of Sterling State Park in Monroe County, Michigan. The refuge also includes Mud Island, Calf Island, and Grassy Island, lands formerly managed by the Service as Wyandotte National Wildlife Refuge. The 326-acre Wyandotte NWR was re-designated as part of the refuge.

The Commission approved the 409-acre refuge boundary addition and price approval on June 9, 2004.

Edwin B. Forsythe National Wildlife Refuge

Atlantic, Burlington and Ocean Counties, New Jersey

Edwin B. Forsythe National Wildlife Refuge is the result of a Congressional action in 1984 which united the Brigantine and Barnegat National Wildlife Refuges in honor of the late Congressman. To date 39,178 acres have been acquired with Migratory Bird Conservation Funds, 2,967 acres have been acquired with Land and Water Conservation Funds, and an additional 3,943 acres have been acquired by easement and donation. Acquired Refuge lands encompass 46,088 acres of predominantly estuarine marsh habitat that grades into brackish and fresh water wetlands, including some stands of Atlantic white cedar. The barrier islands ecosystem and the upland forest and fields increases the biodiversity area of the Refuge.

The Refuge provides the necessary breeding habitat, food, cover, travel corridors and wintering habitat for the survival of those species of waterfowl that utilize the Atlantic Flyway. It is also the first major estuarine area encountered by waterfowl in the United States as they migrate southward from the small glaciated wetlands of the Northeast. These coastal wetlands annually winter approximately 35% of the entire Atlantic Flyway population of American black ducks and 70% of the Flyway's Atlantic brant population. The northern end of the Refuge is approximately 65 miles south of New York City and the southern end is only six miles north of Atlantic City. Residential and commercial development pressure, though somewhat abated from its rampant pace at the end of the last decade, shows no sign of reversal. Marsh destruction has been reduced by the passage of the New Jersey Wetlands Act of 1970 and the State's assertion of its riparian claim. There is, however, a renewed assault by development on marginal areas as wetlands protection legislation is being challenged, and manpower constraints make enforcement ineffective.

The Commission approved the 850 acre refuge boundary addition and price approval for a 28 acre tract on September 8, 2004.


Lake Umbagog National Wildlife Refuge *Oxford County, Maine*

The Lake Umbagog National Wildlife Refuge project area includes diverse and extensive palustrine, lacustrine, and riverine wetland complexes recognized as some of the finest wildlife habitat in the states of New Hampshire and Maine. Located on the northern part of the New Hampshire/Maine border, the 23,184 acre project includes wetland habitat in both New Hampshire and Maine. Both states are setting aside additional lands to complement the protection of the Lake Umbagog watershed. Lake Umbagog has been listed by both states as a priority site for acquisition under the Atlantic Coast Joint Venture of the North American Waterfowl Management Plan, as well as identified for protection under the Emergency Wetlands Resources Act of 1986. A portion of the project area has already been designated as the Floating Bog National Natural Landmark by the National Park Service.

Wildlife values include waterfowl production and migration habitat, with a large amount of forested wetland of particular importance to black ducks whose populations are declining, ring-necked ducks, and cavity nesters such as wood ducks, goldeneye, and hooded mergansers. The first bald eagle nest in New Hampshire since 1949 is located in the project area, and several federal Species of Management Concern and state-listed threatened/endangered species are dependent on the area. Lake Umbagog is the most productive breeding site for the common loon in New Hampshire and is recognized as one of the most important breeding areas in the northeastern United States for its high nesting success. Additionally, the area is noted for its high nesting density of osprey. Large populations of moose and black bear also add to the wilderness quality of the area.

The Commission also approved the 466 acre refuge boundary addition and price approval for a 1,073 acre tract on September 8, 2004.


McFadden National Wildlife Refuge *Galveston County, Texas*

On May 1, 1980, the Migratory Bird Conservation Commission approved the establishment of the McFaddin National Wildlife Refuge, and the fee purchase of 41,682 acres at the Refuge using the Migratory Bird Conservation Fund (MBCC). Following these initial approvals, the Commission approved the acquisition of an additional 6,962 acres in Fee and 7,748 by means of conservation easement with MBCC. The last 212 acres approved by the Commission February 25, 1997, never closed due to deaths in the family etc. The total acreage of the Refuge now stands at 56,180.

Acquisition of the proposed addition of 2,681 acres to McFaddin NWR, would protect important wetland habitats for migrating and wintering waterfowl. Coastal marsh habitats on the property provide feeding and resting areas for waterfowl migrating through or wintering on the upper Texas Coast. Twenty-three species of ducks and four species of geese have been observed on adjacent Refuge lands. The marsh and neighboring uplands provide excellent nesting and brooding areas for the mottled duck, a resident species of special concern due to the recent population declines. This area is within the North American Waterfowl Management Plan's (NAWMP), Gulf Coast Joint Venture-Chenier Plain Initiative (GCJV-CPI) and is considered a high priority for acquisition. It would assist in meeting the habitat protection goals of NAWMP and the GCJV-CPI, as well as assist in sustaining waterfowl populations at recommended levels and maintaining their current distribution across North America.

The Commission approved the refuge boundary addition and price approval for a 2,681 acre tract on June 9, 2004.


Rachel Carson National Wildlife Refuge *York and Cumberland Counties, Maine*

Rachel Carson NWR was established to preserve ten estuaries along the Atlantic coast of Maine that provide important resting and wintering habitat to waterfowl and other migratory birds along with the Atlantic Flyway. Acquired lands total 5,187 acres in ten refuge divisions beginning at Kittery, Maine, northward along the coast communities to Cape Elizabeth, Maine.

A major emphasis at the refuge is salt marsh management. These salt marshes provide breeding habitat for black ducks and are especially important to wintering black ducks for foraging and shelter. During fall migration black ducks occur in modest numbers in salt marshes and bays throughout the refuge. During harsh winters, these marshes provide vital food and cover resources at a time when inland waters are frozen. The refuge also supports a breeding and summer resident population of waterfowl. Acquisition of this area will greatly increase the refuge's ability to provide important breeding and migration habitat for waterfowl, particularly black ducks, mallards and wood ducks as well as other migratory birds of concern to the USFWS. The goal of the refuge's restoration prescription for this area is to restore small ponds on the marsh surface so that aquatic life can survive and plug ditches to more closely mimic natural hydrology. The ponds provide habitat for submerged aquatic plants and aquatic insects. The Spartina salt marsh and dune grass along with several other natural communities form a coastal dune-salt marsh ecosystem in southern Maine.

The Commission approved the 275 acre refuge boundary addition and price approval for a 35 acre tract on September 8, 2004.

Red River National Wildlife Refuge


Caddo, Bossier, Desoto, Red River; and Natchitoches Parishes, Louisiana

Red River National Wildlife Refuge was established on October 13, 2000, under authority of the Red River National Wildlife Refuge Act (Public Law 106-300) to preserve, protect and restore 50,000 acres in five refuge units along a 280-mile stretch of the Red River in northwest Louisiana. To date, 4,532 acres have been acquired at this refuge with an additional 1,103 acres being leased.

The purposes of Red River NWR are to: restore and conserve native plants and animal communities in the Red River basin; provide habitat for migratory birds; and provide assistance to private landowners for the restoration of their lands for the benefit of fish and wildlife. This refuge provides wintering habitat for mallards, pintails and wood ducks, and contributes to the goals of the North American Waterfowl Management Plan. Reforestation and restoration of native habitats will benefit resident and migratory waterfowl as well a wide array of other species. In addition, the refuge offers recreational, research, and educational opportunities.

The Commission approved the 14,397 acre refuge boundary addition and price approval for a 1,082 acre tract on September 8, 2004.


San Bernard National Wildlife Refuge *Brazoria and Fort Bend Counties, Texas*

The San Bernard National Wildlife Refuge was approved by the Migratory Bird Conservation Commission on February 27, 1968. To date, 36,698 acres have been acquired. In 1997, the Austin=s Woods Conservation Plan authorizing the acquisition of up to 28,000 acres of satellite units to San Bernard was approved. To date, 8,156 acres have been acquired through transfer from the Federal Deposit Insurance Corporation or through donations from various entities, or with funds approved by North American Wetlands Conservation Act, with funds obtained from mitigation, and by Migratory Bird Conservation Commission approval for the Austin's Woods Unit.

The proposed area is part of a productive and valuable wetland complex providing wintering, migration, and resident habitat for waterfowl, wading birds, neotropical migratory birds, and other wetland-dependent wildlife species. Thousands of waterfowl winter in the area. Mottled ducks, a species of concern, use the area, as well as green-winged teal, gadwalls, and black-bellied whistling ducks. This proposed acquisition is within the Mid-Coast Initiative of the Gulf Coast Joint Venture of the North American Waterfowl Management Plan.

The Commission approved the refuge boundary addition and price approval for a 1,681 acre tract on September 8, 2004.


Silvio O. Conte National Wildlife Refuge *Coos County, New Hampshire*

The Silvio O. Conte National Fish and Wildlife Refuge (Refuge) was launched with the introduction of legislation by the late Congressman Silvio O. Conte which authorized a national fish and wildlife refuge within the Connecticut River watershed. Congressman Conte was a member of Congress for over 30 years and served on the Migratory Bird Conservation Commission for about 27 years. After his death, Congress renamed the refuge the Silvio O. Conte National Fish and Wildlife Refuge.

The Final Environmental Impact Statement (FEIS) for the Silvio O. Conte Refuge was completed and a Record of Decision authorizing the Refuge was signed by the Regional Director on December 13, 1995. Within the 7.2 million acre Connecticut River watershed, 65 Special Focus Areas important for resource protection were identified in Connecticut, Massachusetts, New Hampshire, and Vermont. The Refuge was officially established on October 3, 1997 with the acquisition of the 3.8 acre Third Island, located in the Connecticut River in Deerfield, Massachusetts. Approximately 30,430 acres of the proposed 91,500 acres have been acquired to date. The Pondicherry Division was established with the purchase of three tracts (670 acres) from one land owner on December 22, 2000.

The Commission approved the 5,103 acre refuge boundary addition and price approval for a 622 acre tract on September 8, 2004.


Trinity River National Wildlife Refuge *Liberty County, Texas*

The Trinity River National Wildlife Refuge (Refuge) was established on January 3, 1994, with the purchase of 4,400 acres of bottomland hardwood and associated habitats in Liberty County, Texas. These lands were purchased with Land and Water Conservation Fund dollars totaling \$3,270,000. Since 1994, an additional 4,195 acres have been purchased with LWCF dollars totaling \$1,941,500. On June 14, 1994, the Migratory Bird Conservation Commission approved the initial MBCC boundary for the Refuge, encompassing 19,220 acres. Since 1994, the MBCC boundary has been expanded by the Service to include another 10,498 acres. To date, 9,617 acres have been purchased with Migratory Bird Conservation Funds totaling \$5,974,172.

The Trinity River NWR protects remnant bottomland hardwood and associated wetland habitats for migrating, wintering and breeding waterfowl. Additionally, it represents one of the few remaining high quality areas for waterfowl in East Texas. It provides essential foraging and/or roosting habitat for the wood duck, mallard, gadwall, widgeon, green and blue-winged teal, lesser scaup and mottled duck. Mature cavity trees dispersed throughout the area provide important nesting habitat for wood ducks and black-bellied whistling ducks. Numerous colonial waterbird rookeries are found in swamps throughout the project area.

The Commission approved the refuge boundary addition and price approval for a 255 acre tract on September 8, 2004.





Notes on Tables One and Two

The information contained in this report includes those acquisitions and dispositions of land and interests therein that are purchased with Migratory Bird Conservation Fund monies or acquired under the authority of the Migratory Bird Conservation Act. It also includes other migratory bird areas such as those that are transferred to the Fish and Wildlife Service under the authority of Public Law 80-537 to carry out a migratory bird management program (these will appear on Table 1).

In an ongoing effort to improve data quality, the figures in Tables One and Two may show minor changes from previous annual reports. Lands in which the Service previously acquired a less-than-fee interest (leases and easements) may be purchased in fee during the year, and

the number of easement or lease acres will show a decrease and the number of purchased acres an increase. The acreage appearing in the Approvals and Summary of Land Acquisitions sections of this report will not appear in Tables One or Two until after the tracts are acquired and the funds are actually expended. Also, a newly approved refuge will not appear on Table One until the tracts are acquired.

North American Wetlands Conservation Fund (Summary) Fiscal Year 2004

The Migratory Bird Conservation Commission approved 82 standard wetland conservation project proposals for funding in Fiscal Year 2004 under the North American Wetlands Conservation Act. A total of \$58,398,533 from the North American Wetlands Conservation Fund (Fund), together with

\$205,515,162 in partner funds, are supporting 39 projects in the United States, 31 in Canada, and 12 in Mexico. The following tables provide summary and detailed allocation information.
