# **National Provider Identifier**

### **Avoid payment delays**

To avoid delays in processing your electronic claims, DMAP is requesting that you send us your NPI and taxonomy codes by **March 16, 2007.** DMAP will create a crosswalk between your DMAP provider number(s) and your NPI/taxonomy code(s) so we can continue to process claims in a timely manner.

## CMS compliance date

Federal mandates say that providers of medical or health services and any other persons or organizations who furnish, bill, or are paid for health care in the normal course of business must obtain an NPI and report any associated taxonomy codes by the compliance date of May 23, 2007, and must use the NPI in any covered HIPAA standard transaction (*i.e.*, 837 professional, institutional or dental formats).

DMAP will meet the federal requirements for compliance effective May 23, 2007. Because of this change, DMAP will require providers to use their NPIs and taxonomy codes, as appropriate, on all electronic claims.

#### Consequences of non-compliance

If you have not reported your NPI and taxonomy codes to DMAP prior to the compliance date, **your electronic claim may either suspend or deny**.
