SECTION 1--UNIFORM OFFENSE CLASSIFICATIONS IN THE OFFENSE (OFF), ORIGINAL OFFENSE CODE (OOC), AND CONVICTION RESULTING IN REGISTRATION

The codes on the following pages are the NCIC Uniform Offense Classifications for use in the OFF, OOC, and CRR Fields.

When the offense codes (except as noted) are used, free text or easily understood abbreviations further explaining or describing the offenses may be entered in the Miscellaneous (MIS) Field or in positions 5 through 24 of the OFF Field.

When the offense is followed by the parenthetical wording "identify type of institution" or "specify conduct," free text describing the institution or specifying the actions which constitute disorderly conduct should be entered in the MIS Field or in positions 5 through 24 of the OFF Field.

When the offense is followed by parenthetical wording such as "identify weapon" or "identify object," entry of free text to describe same is optional in the MIS Field or in positions 5 through 24 of the OFF Field.
