TO: Processed Commodities Storage Agreement Warehouse Operators

SUBJECT: Processed Commodities Storage Agreement (PCSA), Amendment 1

Enclosed are two copies of the PCSA, CCC-29, Amendment 1. Please have an authorized individual complete, sign, and return both copies of the amendment to this office no later than November 1, 2004.

This amendment covers Part V. – E. Security Plan, which requires that all warehouses storing/handling agricultural products address security issues stated in Part V, E. This section of the Amendment is in response to the events of September 11, 2001, and the need to enhance the security of the infrastructure of the United States. This need includes those facilities engaged in storing and handling the nation's agricultural products. It supports the initiatives by the U.S. Department of Homeland Security (Homeland Security Presidential Directive/Hspd-9), by implementing security plan requirements into the PCSA.

This amendment to the PCSA requires warehouse operators to conduct a facility-vulnerability assessment and implement a security plan that includes measures to protect commodities handled and stored under the PCSA. It is important that each company evaluate the existing level of security at each of their facilities and develop a plan for managing potential risks. In order to allow warehouse operators time to meet the requirements of Amendment 1, CCC will provide a 5-month phase-in starting November 1, 2004, before any actions are taken for non-compliance.

The security plan required under Amendment 1 is general in nature because of the diversity of the warehouse industry and the need for warehouse operators to determine the extent of risk that exists at individual locations and to devise appropriate risk-mitigation measures. It is not CCC's intent to prescribe the specifics to be included in the warehouse's facility security plan. However, CCC will expect warehouse operators to make a good faith effort to address each of the four elements contained in Part V, E, as outlined in Amendment 1, to mitigate the facility's vulnerability to a potential terrorism incident and to effectively respond if an event occurs.

CCC recognizes that PCSA warehouse operators already may have conducted vulnerability assessments and prepared facility security plans that address the provisions of Amendment 1. These assessments and resultant plans may have been prepared in response to requirements imposed by other Federal or State government agencies, insurance carriers, or other entities. In addressing these assessments the warehouse operator may have implemented emergency action plans, hazardous material response plans, spill prevention, control and countermeasure plans, or other response plans. CCC will recognize these plans as meeting the requirements of Part

V, E, of the PCSA, as conveyed in Amendment 1, so long as such plans address the areas specified in Amendment 1.

Clarification of the intent of Amendment 1:

- Paragraph 2.b.: The warehouse operator agrees to have shipping and receiving procedures in place to protect against tampering of commodities. The warehouse operator must implement procedures that provide adequate security at the receiving and load-out areas at the PCSA facility that are within the physical control of the warehouse operator.
- Paragraph 2.c.: The warehouse operator is to specify actions to be taken in the event of a national emergency. The warehouse operator should have a contingency plan outlining emergency steps that would be activated if there is a credible threat to the safety or security of commodities stored or handled at the PCSA facility.
- Paragraph 2.d.: The warehouse operator must have contact information for local security authorities. The warehouse operator should include in the security plan the names and telephone numbers of local emergency responders, such as police, fire department, and the local FBI office, if available, that the warehouse operator can call in the event of a terrorism incident.

Please sign and return both copies of Amendment 1 by November 1; it will become effective immediately. In order to allow warehouse operators time to meet the requirements of Amendment 1, CCC will provide a 5-month phase-in starting November 1.

AMENDMENT 1 TO THE PROCESSED COMMODITIES STORAGE AGREEMENT (PCSA)

Part V, E., Security Plan, is added to read as follows:

Part V. RESPONSIBILITY FOR CONDITION OF WAREHOUSE AND PROTECTION OF COMMODITIES -

* * * * *

E. Security Plan - The warehouse operator must:

1. Have a security plan that includes measures to protect processed commodities handled and stored under this Agreement.
2. Conduct a facility vulnerability assessment and establish procedures that address:
 - a. General security of the physical structures and grounds of the warehouse,
 - b. Shipping and receiving procedures to ensure processed commodities are not subject to tampering,
 - c. Action to be taken in the event of a national emergency, and
 - d. Contact information for local security authorities.
